Nearly 9 out of 10 wildfires nationwide are caused by people and could have been prevented.

Run new radio PSAs to remind listeners of the responsibility we all share to protect the lands we love by preventing wildfires. It is through this shared responsibility that Smokey Bear is within us all. Remember, "Only you can prevent wildfires!"
