During the months of March, April, and May of 2020 the US experienced a Pandemic caused by Covid-19. In response to this pandemic the radio station broadcast numerous informational messages giving safety tips promoting hand washing, social distancing, use of facial masks, and other safe practices. These messages were a mixture of the radio station's own productions, the red cross' productions, the NAB productions, among other health organizations' productions. Also, a series of these announcements were also broadcast in Spanish to serve the growing Hispanic community in this region. Most of the announcements were either 30 seconds or 15 seconds in length.
