Three stations licensed to VPM Media Corporation were identified in the April 24, 2023 Enforcement Bureau letter as randomly selected for an EEO audit. As is detailed below, each of the three stations had its license renewal granted after February 2021:

WHTJ(TV), Charlottesville, VA (FID 9990); renewal granted 7/27/2021 (*see* FCC File No. 0000115447)
WNVC(TV), Culpeper, VA (FID 9999); renewal granted 7/27/21 (*see* FCC File No. 0000115413)

WVPY(TV), Front Royal, VA (FID 66378); renewal granted 6/9/2021 (*see* FCC File No. 0000115419)

The three stations listed above are all in the same SEU. If relevant, the remaining station in the SEU—WVPT—also had its renewal granted in June 2021 (*see* FCC File No. 0000115416).

Please advise on whether these stations need to submit a response to the audit letter.
