
Addendum to attached memo from DECADES Network.

During the above period, WABI-DT3 aired network disseminated programs, originally produced and broadcast primarily for an audience of children 13 -16 years of age, as listed in the attached memo.

The programming was not required to conform to the commercial time limits prescribed in the Communications Act, as amended, 47 U.S.C. §303a, and 47 C.F.R. §73.670(a)-(d) because the programming was all originally produced and broadcast primarily for an audience of children older than 12.

I hereby certify that WABI-DT3 aired the programming according to the sequence and schedule recommended by the network, with no revisions in format.

As indicated in the network's statement, although the programs are not subject to the Website rules, the network made efforts to comply with the FCC's URL display rules. This station did not add any website addresses to the children's programs nor did it air programming adjacent to children's programming that displayed website addresses that would violate these rules.
