In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

The concerns of Globe-Miamians in the second quarter of 2022 mirrored the worries of Americans everywhere when it came to dealing with rapidly rising prices of virtually every necessity from gas to groceries. No doubt the problem will affect the upcoming elections this year. The quarter started with little evidence of the upcoming August primary, and ended with streets littered with candidate posters. Like all primaries, the focus is on infighting within the two major parties, which while lively, is not nearly as divisive as the choices voters will face in the general election in the fourth quarter. Unlike other states, due to the lateness of the primary, Arizonans are not yet concentrating on what they'll do in November, thus this quarter produced little interest in the candidates or contests.

The one constant in Globe-Miami is the significant role that **Mining** plays in virtually every aspect of local life here. Often seen as a blessing and a curse, since copper mining byproducts over the years have caused great harm to the local environment while the copper mining process historically has provided the bulk of local employment, mining is, and forever has been, the area's prime economic backbone. For that reason, residents pay rapt attention to mining news, which KJAA covers in depth.

This quarter was somewhat a departure from recent quarters in that mining news was mixed. Reports of first quarter 2022 financial results from the major copper producers were somewhat uplifting, but this quarter the price of copper unexpectedly fell. Though prices have been unrealistically high, with copper reaching \$4.94 a pound in the first quarter; continually falling prices this quarter were a disappointment, and June's steep decline to \$3.74—a loss of \$1.20 a pound from its high less than four months earlier, was a surprise.

Magnifying concerns were various news items including one that positioned falling copper prices as a leading indicator of a broad downturn in the economy due to copper's wide variety of uses in electrical, industrial and transportation

applications; and another that blamed copper's fall to a 9-month low on global recession fears due to rising interest rates, weaker demands for industrial metals, and China's slowing economy from its zero covid policy.

How the price drop will affect second quarter financial results remains to be seen. First quarter results of the mining giants ranged from celebratory to disheartening. Freeport McMoRan (FMM) issued an admirable report with its fifth quarter of more than a billion dollars in net profit. The average price paid for a pound of copper was \$4.66, at a cost of \$1.33 to produce. For the year 2022, FMM projected sales of 4.2 billion pounds of copper. The company declared a cash dividend of .15 per share, payable August 1<sup>st</sup>.

The news was not as good for Grupo Mexico or Capstone Mining. Grupo Mexico, which owns the nearby Asarco Mine and Hayden Smelter—the latter still shuttered from a long-term strike—reported consolidated net profits fell to \$920 million in the first quarter 2022. That's down from \$1.03 billion a year ago. Though Grupo Mexico, the fifth largest producer of copper worldwide, brags about its low production costs at a mere 81 cents a pound, production costs at Asarco were \$2.49 a pound.

Vancouver-based Capstone Mining showed a significant loss in the first quarter of 2022. Net profit was \$35.1 million. A year earlier, the first quarter of 2021 registered a net profit of \$127 million. 22,500 tons of copper were produced in the first quarter of 2022 (14,400 tons from Pinto Valley locally) at a cost of \$2.31 a pound. The cost of production was up 66 cents a pound due to lower output and higher operating costs. On the upside, work is progressing on a pre-feasibility study for Pinto Valley mine here to maximize the conversion of one billion tons of resources, which will significantly increase the mine's life.

A split decision from the 9<sup>th</sup> Circuit Court of Appeals in San Francisco reverberated through the mining community, when a federal judge's 2019 decision was upheld, which stopped the proposed Rosemont Copper Mine south of Tucson. At issue was not whether Rosemont would have the right to mine on forest service land, but whether they could dump mining rock waste on the surface of that land.

No decisions have been made on the Resolution Copper Project near Superior. The extended objection period ended May 24<sup>th</sup>. Emotions are high surrounding the giant underground mine's fate. For the local economy it is undeniably the boost this area greatly needs. But environmentally, questions of differing validity remain.

Rio Tinto, the principal entity in the Resolution Copper project is clearly a boost to the **Economy** of any region in which it operates. In 2021, it paid \$13.3 billion for global taxes and royalties. That's up \$8.4 billion from 2020. Its total direct economic contributions worldwide was \$66.6 billion, up from \$47 billion the previous year.

To some onlookers, Lucid Motors in neighboring Pinal County (Casa Grande), is a needed departure from the overwhelming economic dependence on copper mining here. But from another perspective, copper and Lucid are inextricably

linked. Lucid is manufacturing electric cars— and so many have been ordered, that workers toil around the clock in three shifts. Copper is integral to the manufacturing process, to the point that the demand might affect copper prices.

Further demonstrating the economic impetus of Lucid Motors, two related factories are now being built: South Korea's LG Energy Solutions purchased 650 acres of state land in Pinal County (Queen Creek) for the construction of a huge electric car battery plant. Construction begins this summer on the 1.5 million square foot facility, which will have 2800 employees when it opens in 2024. And a new plant specializing in recycling Lithium Ion batteries owned by a Canadian company opened on 20 acres of land in suburban Phoenix this quarter.

But to Globe-Miamians who find themselves regularly traveling great distances, either for shopping or work, the state of the current economy relates directly to the price of gasoline. At the start of this quarter, fuel in Arizona averaged an unsettling \$4.60 a gallon for regular gas (\$6.09 was the highest, \$3.99 was the cheapest—neither were close to Globe). As the quarter came to a close, regular gas averaged an eye-popping \$5.40 a gallon, with a whopping \$7.99 being the highest, and \$4.45 being the lowest price found in the state (again, neither close to Globe).

Statewide **Unemployment** figures continued to fall this quarter, with May registering just 3.2%.

Concerns about the area's **Infrastructure** and its widespread **Blight** continued to be mitigated with ongoing progress on the Tri-City Sanitary District's (TRSD) wastewater project. This quarter, home-owners in Phase 1 of the district received letters requesting information that will enable the district to design connections. While some homeowners are against the project due to the monthly cost, most understand the urgent necessity as properties here largely rely on failing cesspools. More has happened to bring the project to fruition in the last year than over a decade before that, when a different board of directors helmed the effort. This quarter, the new board tackled property acquisition and the sale of reused water, in addition to nailing down the 2022-23 budget and tax levies.

Old Dominion Park remained closed this quarter. Earlier hopes for a reopening at the start of the year were dashed when park owner BHP determined additional work was needed. BHP assured the City of Globe of its intention to reopen the park, but the tentative date has now been pushed back to 2027. The site's history is an interesting one. It had been a huge underground mine, with shafts reaching a depth of 2600 feet. It closed during the depression in 1937, leaving behind billions of dollars of copper and an unseen maze of empty tunnels and shafts, some of which reached a depth of 2600 feet. At the time, copper was 30 cents a pound, and mining it was arduous at best. Today, with vastly improved technology and prices of copper at well over \$4.00, would BHP be wise to reopen it? While that's an intriguing question, it appears that BHP's focus is on fixing the problems so the park can again be safely used by the public. The reason for the

closure in September 2021 was the partial collapse of a 140-year old underground shaft, half a mile below the park's surface.

As for the local **Environment**, interest was greater than expected in the Air Force's plans to lower the ceiling to 500 feet for flights with flairs and sonic booms—so great that the comment period for the change from 2,000 feet was extended through May this quarter. Residents have been vocal in objecting to a lowered ceiling, fearing that what is already a problem for them will become significantly worse.

For better, or usually worse, mining will always affect the local environment. This quarter the Copper Corridor Community Working Group met held a public meeting in Superior to present a good-neighbor agreement designed to meet the needs of the public and the mining companies. Water-quality was the focus of that meeting, which included reports from Resolution Copper and an independent water-quality consultant.

Demonstrating an understanding of the need to protect the environment surrounding its projects, annual sustainability reports are now the norm for the mining industry. Freeport McMoRan released its 21<sup>st</sup> annual report on their efforts as did Capstone Mining.

It's not a stretch to say the economic viability of the town of Superior rests with the fate of the Resolution Copper project. The mine will be a huge asset if it opens. But now, the unthinkable: what if it doesn't? is on the table. Should that be the case, Superior's efforts to improve the quality of life for local residents will become even more crucial. To help in Superior's efforts, the federal government has awarded the town \$4.25 million dollars for the creation of a multi-generational enterprise center and for the restoration of the natural habitat in the Queen Creek Canyon area.

Fire restrictions are expected annually in the second quarter as wildfire danger increases as spring turns into summer, so the USFS' Tonto National Forest announcement that Stage 1 Fire Restrictions would be in place as of May 5<sup>th</sup> was anticipated. The restrictions remain in place until the danger has passed. History shows that long before that, restrictions are more likely to increase in response to critical conditions.

**Transportation** issues remain largely unchanged— with construction on Highway 60 to Phoenix, when it occurs, presenting the biggest problems. This quarter, the obstacle on 60 continued to be the long-term Pinto Bridge Project. The new bridge has been open for some time, but periodic lane closures each month again required long delays and pilot cars for paving and striping work. This quarter, like every year in the second quarter, ADOT reopened a number of White Mountain roads that were closed for winter, giving a green light to recreational travelers.

With a statewide primary coming up in the third quarter, **Election** news should have been on the forefront this quarter, but it wasn't. The biggest change was the

finalization of new districts, mandated every decade by the results of the US census. Globe-Miami was formerly part of Arizona's First Congressional District. It is now part of the Second Congressional District, the 11<sup>th</sup> largest in the United States in terms of land area. 25% of the district is made up of Native American land. US Representative Tom O'Halleran who had been in District 1, now is part of District 2. He'll run unopposed in the democratic primary in August. The August republican primary will be decidedly more active, with seven candidates battling it out.

Statewide the districts have undergone change as well. Globe-Miami is now part of Legislative and Senate District 7. For the Arizona House of Representatives, no democrats are running. Voters will choose two from among republican incumbents David Cook and John Filmore, and David Marshall. For the Arizona Senate, voters will choose one from republican incumbents Wendy Rogers and Kelly Townsend, and democrat Kyle Nitschke.

This quarter's voter registration rolls showed that Arizona had 4,290,348 registered voters (1,478,783 republican; 1,442,813 independent; 1,334,001 democrat). By percentage, Arizona's voters are 34.4% republican, 33.6% independent and 31.69% democrat. In Gila County, as of June, 35,321 people are registered to vote with 17,305 republicans, 10,563 independents, 9,337 democrats and 220 libertarians. The deadline to register to vote in the primary is July 5<sup>th</sup>.

Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, the Chairman of the Gila County Board of Supervisors, Tim Humphrey uses KQSS as the origination point of his monthly meeting. Listeners and residents are invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA, and is available as a download on KQSS.net. Here's a review of this quarter's meetings:

#### Tim Humphrey Community Meeting

April 17, 2022 8-8:30 AM

Potholes! Who to call? Supervisor Humphrey discussed that issue, which is particularly vexing when the County says it's a city road and the city claims it's County. He also reviewed upcoming chip sealing projects, and a potential construction start date for the new Tonto Creek Bridge. With the upcoming fire and flood season, mitigation was discussed, as was redistricting. The final decision on the new districts comes next month and the public is urged to review the proposed maps and get their comments in now.

#### Tim Humphrey Community Meeting

May 15, 2022 8-8:30 AM

The redistricting is final and new maps can be seen on the Gila County website. Supervisor Humphrey fully explained the changes and the reasons behind them. He also continued the discussion on the upcoming fire and flood season, including the various approaches the county is taking and how they are working with other agencies to address the emergencies that local residents are virtually certain to face every year.

June 19, 2022 8-8:30 AM

Why do the unincorporated portions of the Globe-Miami area need the Tri-City Sanitary District's coming sewer system? That was discussed at length with Supervisor Tim Humphrey and Michael O'Driscoll head of Gila County's Health and Emergency management department. While some residents focus on the monthly cost to them and object to paying it, many understand that most of the properties in the district rely on cesspools—which, since the 1970s, are illegal in Arizona. That means, if a cesspool fails the option is to get a septic tank and few lots are large enough to accommodate the legal requirements. When that happens, and no sewer system is under construction, the home is condemned. (When a sewer system is in the works, homeowners with failed cesspools are able to get permits for a temporary solution.) But even without the worst-case scenario, homes dependent on cesspools do not qualify for permitting if changes are desired, and in the event of a sale, lenders will not make loans on them. Evening meetings are planned for later this month to fully explain the reality, and the reasons that it has taken so long to get this project underway.

In addition to extensive reporting on the foregoing, KJAA enhances its public service presence with three long form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour and a half long block of this information in morning drive on Sundays.

Health Care is an issue of critical importance to all Americans.
