3rd QUARTER 2022

The third quarter of 2022 was calmer than expected given the anticipation of the August Primary Election. While candidate posters were seen everywhere in July, little excitement was generated and August results were largely in line with expectations. The most notable race was the republican primary for governor, where Kari Lake, a former Phoenix news anchor endorsed by Donald Trump, narrowly defeated a much better funded mainstream opponent. She will face Secretary of State Katie Hobbs in the general election on November 2nd.

In addition to its unique blend of music, comprised primarily obscure soul and R&B from the 1950s and 1960s mixed with sambas, pop standards, instrumentals and early rock and roll chosen for its local appeal without regard to national popularity; KJAA airs public service announcements around the clock along with hourly weather, news items and immediate updates when dangerous conditions exist, as well as at least one full length morning drive local newscast each weekday morning including local job openings. KJAA does not attempt to compete with national news sources. Using a need-to-know approach, KJAA focuses exclusively on local events and concerns. KJAA is heard on 1240 AM, and on 106.1 FM via translator K291CU.

Beyond primary victories and losses, the most surprising **Election** news this quarter, given all the previous attention on the possibility of ballot irregularities in the 2020 race, was the near-devastating misstep made by neighboring Pinal County, which sent out over 63,000 incorrect ballots to early voters. Federal, State, Legislative District and County races were properly stated on each ballot, however municipal issues were mixed up. Voters in Superior, Casa Grande, Mammoth, Eloy, Maricopa, and Apache Junction received ballots with issues for a municipality in which they didn't reside, and no issues for their own municipality. Human error was responsible. What followed was chaos. At first the county was going to reissue all the ballots, but fears of lawsuits prevented that. Ultimately, voters were instructed to vote for all but municipal issues. A separate corrected ballot was sent out for those. Votes cast on the incorrect ballots were not counted.

Gila County has 33,205 registered voters. 19,689 early ballots were mailed out.

Mining continues to be the lifeblood of the Globe-Miami community. For that reason, mining stories are of greater interest to local residents than is the case elsewhere. Overall, metal prices were in serious decline this quarter, due in large part to lower demand largely blamed on China's zero Covid policies. The average 3rd Quarter 2022 price for a pound of copper was \$3.51. 2nd Quarter Reports were released by several companies:

Freeport McMoRan had a net profit this quarter of \$840 million, down from 1st quarter profits of \$1.5 billion. Consolidated sales were 1.1 billion pounds of Copper (at \$4.03 a pound), 476 ounces of Gold (at \$1827 an ounce) and 21 million pounds of molybdenum. Average cost of mining the metals was \$1.41.

Capstone Mining's 2nd Quarter 2022 report for their four operating mines, including the Pinto Valley Mine was of Miami was 45,200 tons of copper mined at \$2.78 a pound. Net income for the quarter was \$92 million. Sale price of copper dropped from \$4.78 in the first quarter to \$3.66. 13,300 tons of copper came from Pinto Valley, west of Miami; 6400 tons came from Cozamine Mine in Mexico; the rest (over 25,000 tons) came from Capstone's two mines in Chile. Work is

progressing on the feasibility study to optimize the conversion of mineral resources and extend the life of Pinto Valley.

Grupo Mexico's 2nd quarter report including its nearby Asarco mine, showed total consolidated revenue of \$6.96 billion, down 5.25% from last year's 2nd quarter. Higher costs triggered by global inflation and a decrease in copper production were blamed. Workers at Grupo Mexico's Marana, Arizona mine voted to drop union representation. They had been part of United Steelworkers Local 137. With the long-term strike continuing at the Asarco mine, the decision is not a total surprise. Asarco workers have been striking going on three years with no resolution, and other than shuttering Grupo Mexico's nearby Hayden Smelter, operations continue.

BHP released its annual results for the Fiscal Year ending June 30th 2022 with an underlying profit of \$40.06 billion, and good news for Globe-Miamians. BHP is the third largest property owner in the area, with over 7,000 acres involving several former copper producing mines including, Old Dominion Underground Mine, Sleeping Beauty, and Copper Cities. This year an agreement was reached with Capstone to allow Capstone to conduct copper exploration on the former Copper Cities site. Capstone will pay BHP \$6.7 million for 18 months of drilling. Past estimates show 68.7 million tons of copper remain at that site.

In August, the EPA issued a draft underground injection control permit for Florence Copper. The 45 day comment period is now underway, and the outcome will bear heavily on whether the project gets final approval. If it does, Florence Copper predicts that the mine will create close to 800 jobs, \$2.1 billion dollars in economic activity, \$1.98 billion in personal income, and \$468 million in taxes as royalties for the state. Earlier this quarter, Florence Copper announced that it had successfully completed its 18-month production test demonstrating that copper ore can be safely extracted from the mine.

The ADEQ held a public comment period from August 2nd to September 25th on the air quality control permit it expects to issue to allow Freeport McMoRan to continue its local operations, mining copper and processing ore.

Rio Tinto received the Rocky Mountain Institute's 2022 Mine Safety Award this quarter for its work on the Resolution Copper Mine in Superior, displaying dedication to safety and responsible mining. But the fate of the project still hangs in political limbo. Previously celebrated for many things, perhaps most importantly as the driver of future economic stability in the area, concern about whether it will happen at all continues to rise as the congressionally approved land swap is being revisited due to concerns from tribal entities, the Biden Administration, and some Arizona politicians, most notably, US Representative Raul Grijalva. The last deadline to file an objection to the project closed September 6th. It was open only to those entities that had previously commented on the revised land management plan involving the mine.

Copper Mining now, and as far back as anyone can remember, is the biggest factor in the **Economy** of Globe-Miami and surrounding areas. While many residents, worried about the future of the Resolution Copper Project, voice dissatisfaction with what they feel is misguided concern over the **Ecology**, it is interesting to note that ecological concerns are at the heart of what could become the biggest increase in copper demand in our lifetime. Electric cars, heralded for their eco-friendly operation, require 2.5 times more copper to build than conventional gas-powered vehicles.

Therefore, the fate of Lucid Motors, in nearby Pinal County, impacts the local economy in multiple ways. It not only creates a source of jobs regionally, but it directly increases the demand for copper. This quarter came news that again the site of Lucid Motors is expanding. The plant in Casa Grande is now operating around the clock with workers in three shifts producing cars, and Casa Grande has approved the sale of an additional 1300 acres of land for the project.

More electric cars mean the need for more electric charging stations. This quarter it was announced that the state of Arizona will be getting \$6 million in federal funding for the building of charging stations throughout the state. In July, ADOT held a virtual public meeting soliciting input on plans for electric vehicle infrastructure deployment.

It was reported in July that statewide unemployment figures rose a fraction of a percent in June, still at a relatively low 3.3%, and non-farm labor increased year to year by 104,000 jobs.

But once again this quarter, overriding everything else when it came to economic impact on Arizonans, was the high price of fuel. From its impact on the price of goods due to increased delivery costs, to what is being spent at the pump, Globe-Miamians continued to be greatly affected. On the surface it would seem like shorter daily commutes experienced here would reduce the impact, however the reality is most Globe-Miamians need to regularly make 100-mile trips to the Phoenix or Tucson areas for goods and services not readily available here. Even though throughout most of the quarter gas prices were stable or slightly lower, for many drivers, filling up the tank exceeded \$100. Adding to that challenge, gas prices suddenly began to rise sharply at the end of the quarter. Prices throughout the quarter averaged from a low of \$3.34 to almost \$5 a gallon.

Apart from cost, **Transportation** here continued to be impaired by the seemingly never-ending road construction projects, particularly on Highway 60 connecting Globe-Miami to the Phoenix area, where lane restrictions necessitating pilot cars and alternating one lane-traffic were announced on multiple occasions.

Gila County is constructing a much-needed bridge across Tonto Creek. This quarter, funding from the county and a grant was announced along with agreements with the US Fish and Wildlife department and Arizona Game and Fish department. While some residents across the creek voice objection to a bridge, preferring to be separated from the rest of the county, the creek is inherently unsafe to cross. Passing through the creek is usually without peril, but safe passage is far from guaranteed as evidenced by the drivers who have died trying.

Infrastructure issues perennially plague the local area, though some of this quarter's biggest concerns were weather-related. A series of heavy rains produced flooding due in large part to the lack of vegetation lost to massive wild-fires in the past. One upside to the recent flooding is that the Tonto National Forest was able to cancel all shooting restrictions in July as the monsoons greatly lowered fire danger.

It was also announced this quarter that the EPA will be working with the San Carlos Apache tribe on a pilot program to improve water treatment facilities on the reservation, which relies primarily on septic systems and cesspools. It will be funded by the \$8 billion set aside by the federal government to improve water infrastructure in the southwest.

On a positive note, the Tri City Sanitary District continues to move forward with the much needed sewer system for the unincorporated areas between Globe and Miami.

Education continues to be of concern to southern Gila County, which has a reputation for poor public schools, which many residents feel is well deserved. But for locals wanting higher education, there are several low and no-cost opportunities, including Eastern Arizona College's 100% tuition waiver for anyone over 55 years old who has lived here for more than a year.

Freeport McMoRan announced a new \$3 million scholarship program this quarter for Navajo tribal members. Two groups of 50 students each will receive up to \$6000 for yearly tuition, in addition to various services including tutoring and counseling, designed to keep students in school.

The biggest **Health** news this quarter was no news. While Covid-19 continues to be a factor and announcements of vaccine availability are ongoing, attention is returning to the more mundane day to day necessities, such as sports physicals and back to school checkups. Helping with that, Canyonlands Healthcare in Globe offered a free well-child clinic in July.

Creating interest and participation in **community meetings** is the often-elusive goal of local community leaders everywhere. To facilitate wider-reach and easier-access, the Chairman of the Gila County Board of Supervisors, Tim Humphrey uses KQSS as the origination point of his monthly meeting. Listeners and residents are

invited to participate, but for those who miss the live meeting, it is replayed the following weekend on KJAA, and is available as a download on KQSS.net. Here's a review of this quarter's meetings:

Tim Humphrey Community Meeting
July 17, 2022 8-8:30 AM

What happened to the fairgrounds? At one point, events were held regularly, ranging from horse racing to gun shows. Now virtually the only thing left is the annual Gila County Fair. Supervisor Humphrey detailed plans to demolish the outdated and dangerous race track, and the planned formation of committees, and possibly an employee, dedicated to developing events that will keep the venue busy, drawing tourists as well as locals. An update on flooding preparedness was also discussed.

Change in street addressing was the primary focus of this meeting. Now properties in Gila County that do not contain a residence or business with plumbing facilities qualify for a street address. This is particularly helpful in deliveries to sites that have industrial, storage or other buildings, which previously had no specific address. But to comply with 911 requirements and other county ordinances, many residential addresses have changed, with the result being longer and unappealing (for instance 500 Cedar Street may have morphed into 5722 South Cedar Avenue). Supervisor Humphrey was joined by the head of the Gila County Rural Addressing department to discuss the requirements and reasons behind them.

September 18, 2022 8-8:30 AM

Water—not enough and too much. Recent rains brought flash flooding, but not in large amounts. The monsoon season is not over, and efforts continue to mitigate the results of flooding which is likely to occur during significant rains. A bigger problem in Arizona is the lack of water—particularly in Northern Gila County, but elsewhere as well. Citizens in nearby Tonto Basin are concerned with a new development that will be further taxing the water supply. The issue is that private wells have no protection from other wells being drilled nearby. When a new development comes in, even if it is served by municipal water supplies, that water comes from somewhere, and when it's a new and bigger well drilled nearby existing wells, the existing wells can, and sometimes do, dry up necessitating great homeowner expense to drill deeper into the earth. Also discussed was the timetable for the TRSD wastewater project, crucial to many homeowners utilizing cesspools. Present predictions have Phase 1 online by the end of 2023, Phase 2 by the end of 2024, and Phase 3 by the end of 2026, though unforeseen events may change that time table.

KJAA enhances its public service presence with three long-form nationally produced shows chosen for their coverage of issues impacting the local area. Unlike stations that choose to bury required public interest programs, KJAA is proud to offer an hour and a half long block of this information in morning drive on Sundays.

Health Care is an issue of critical importance to all Americans.
