Official Contest Rules**

1. NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL AND MINICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
2. TO ENTER: Enter by calling the NET Radio toll free telephone number, 1-888-638-7346 and giving your name, address and phone number or via e-mail to radio@netNebraska.org. Only one entry per person. All entries must be received by April 5 10 p.m. (date and time)
3. ELIGIBILITY: You must be 18 years of age or older. It must have been at least 30 days since the last time you won a contest sponsored by NET Radio. Contest is not open to employees of Nebraska Educational Telecommunications (NET), National Public Radio, Public Radio International and each of their respective parent companies, subsidiaries, affiliates, and promotional agencies, and the immediate family members of, and persons domiciled with such employees. The term "immediate family members" includes spouses, parents, grandparents, siblings, children and grandchildren.
4. PRIZE: A winner(s) will be determined in a random drawing from among all eligible entries to be held on or about April 7, noon (date and time). In the event the winner does not accept the prize for any reason, is deemed ineligible by Sponsor, is disqualified, or fails to comply with these rules, the prize will be awarded to a substitute winner selected in a random drawing from among all remaining eligible entries.
