- Issue: Building Strong Families

Summary: Nearly every state has a statute defining what constitutes counseling. The law stipulates that licensed counselors, with the title "Licensed Practical Counselor", can advertise and charge a fee for their services. Each state also includes a provision allowing members of the clergy to provide counseling as long as they don't promote themselves as a licensed counselor and don't charge a fee directly for their counseling services

Summary: Every church should have a written facility use policy. The policy should clearly state what can and cannot be used, and should require proof of liability insurance that is going to be provided by the people using the building. It is not unreasonable to require a deposit that will be refunded after the facility has been inspected, and the keys returned.

A preschool must also have a license, which exists only to be certain that certain fire and safety standards are maintained. Schools at any level in any state are required to do a criminal background check on all employees
