January 5, 2007

John Campbell—Kingsport City Manager

A project getting attention during the year of 2007 is the Higher Education Initiative. Kingsport is large enough to support such a facility and studies are being made to implement a plan for such.

Sullivan is actively becoming involved with economic development in both Kingsport and Bristol as new shopping centers are being built.

January 12, 2007

Doug Kirkland—President and CEO, Goodwill Industries Tenneva

Al Bart—Holston Habitat for Humanity
