## ITEMS OF PUBLIC INTEREST AIRED ON KDPM-FM (Q1 2022)

As part of KDPM's regular programming schedule from 6a-7p the station airs announcements, updates and interviews regarding a myriad of items in the public interest. It should be noted that these announcements are not relegated to only 30 minutes of "public interest programming" per week but are integrated as part of the station's day-to-day programming with each of the announcements airing a minimum of three to four times a day and sometimes more.
