## **SIGNIFICANT ISSUES:**

### **ECONOMY**

#### **10/6/21 Affordable Housing (4:00 p.m. 1:18)**

Margaret Johnson is one of 81 other people who live at the new Magnolia Senior Apartments.

"This is my bedroom and I love, I love my home,"

A one bedroom for anyone 55 or older costs anywhere between \$349 to \$650.

Two bedrooms are \$412 to \$745.

"I can afford it and to live my life comfortably now that I'm reaching 60."

This was made possible by nonprofit and private groups. There's still a long way to go to make sure other people find affordable housing opportunities too. It is estimated that the city is lacking more than 21,000 reasonably priced housing units. City leaders say it will take years to catch up.

"So, there's certainly a need that's evident."

#### **10/11/21 Career Changes due to Covid (6:00 p.m. 1:34)**

Brian Lorusso left his job of 15 years during the pandemic...a choice that was hard to make.

Brian Lorusso "It really opened up how fragile the restaurant industry was."

He's a hospitality expert and master bartender...but said COVID was earth shattering for him.

He was looking for better hours and more stability.

And he's not the only one.

Holly Hughes, intuitive healer, and author

"I think covid and shutting down and all those other things that happened. Like black lives matter, a lot of fear in the world, a lot of danger in the world. Am I being who I want to be? Am I living the life I want to live? And some brave people are changing their careers because of that."

Lorusso took a 6-month intensive course at UNCC for cyber security -- but now he's having trouble finding a job.

Brian Lorusso "Everyone wants experience. It's the chicken and egg debate, like how do you get the experience. People like me who went back and get the training they needed to make the career change are finding some closed doors right now. Hopefully that's going to change soon."

All of this put together causes a strain on the economy.

People Companies are desperate to hire and many without jobs can't find ones they want.

The U.S. Labor Secretary says they're hard at work to figure out what's next.

#### **11/17/21 NC Budget for Racetracks (6:00 p.m. 1:45)**

For years it was the engine that drive the local economy, but it stopped in 1996 except for occasional events, and the track became dilapidated. Now, there's new hope.

"We hope we have racing back here again."

Keith Huffman manages the grocery store just up the road and is a big proponent of seeing the return of racing.

"Businesses in Wilkes County looking forward to watching our businesses grow again with the speedway and the revenue it brings to a county."

In downtown North Wilkesboro, signs of fall comingle with signs of the holidays, and these signs point to a new season at a local landmark.

"And it has been for the last few months the talk around town, we've heard a little bit, the whispers that things are started to head in the right direction, quite frankly, it's what our town needs."

### **12/9/21 Troutman Development (6:00 p.m. 1:50)**

At T-Town Jewelry and Pawn you can find everything from guns to guitars, and opinions about that proposed distribution center.

Dean Swaim, T-Town Jewelry

"I think it would maybe be a good thing as far as bringing in jobs to the community, stuff like that, having places for people to work."

On the other hand...

"We're getting kind of crowded around here. The roads aren't set up to handle it."

The new project, if approved, would go here on Perry Road and Oswalt Amity Road. Troutman has seen a lot of growth, including a Walmart distribution center and several apartment projects.

Downtown Randy's BBQ is a very popular spot.

"There's been so many changes here it doesn't even look like home anymore...for a little country town, it's becoming like a big city town."

Folks here were also shared their thoughts.

It's nice and cute and quaint the way it is, if they pull something like that in here it's just going to change the whole area."

Residents we found like the idea of the benefits a major economic development can bring, but just wonder at what cost.

"I'm not opposed to growth. I think it's good for the community, good for the economy, but I think other things ought to be thought of ahead of time before these apartments and houses and other stuff come in here."

### **12/21/21 Holiday Travel Plans (11:00 p.m. 2:18)**

Roni Fishkin from Mann Travels tells me she has seen an increase in travel requests compared to this time last year.

But the rollercoaster ride continues...

with the Omicron variant -- there are concerns days before the Christmas holiday.



Are you changing your holiday plans?

That's the million-dollar question as COVID-19 cases continue to rise with the Omicron variant to blame.

"As soon as the world started opening up, we got a lot of interest." (Roni Fishkin, Director of Marketing & Events, Mann Travels)

Roni Fishkin is with Mann Travels....a local travel agency...

"People have COVID fatigue and there is so much pent-up desire to see their family and celebrate a holiday, so we have not seen a lot of cancelations." (Roni Fishkin, Director of Marketing & Events, Mann Travels)

### **12/29/21 Duke's Mayo Bowl Game Economic Impact (4:00 p.m. :48)**

No industry's been for more than the hospitality industry. So, for the restaurants and the hotels to have a vibrant energized uptown at this time of year is obviously important too. Danny Morrison, Executive Director of Charlotte Sports Foundation says the past bowl games here in Charlotte have brought in on average 20 million dollars to the local economy.

With two popular Carolina teams in this one, businesses are relying on this bowl game to help them through tough times with inflation and the pandemic.

### **12/31/21 Growth in CLT (7:30 p.m. 1:29)**

WBTV Anchor Jamie Boll sat down with Veteran Reporter Steve Crump to discuss the economy in Charlotte, where it's been, where's it is going, and how it's grown over the past decade.

One of the things that has driven this community has been growth. Something that is appealing to the eye is the way the skyline has changed in the last 10 years, between 2011 and 2021.

## **PUBLIC SAFETY**

### **9/3/21 School Bus Stop Safety (6:00 p.m. 1:36)**

ANNETTE ALBRIGHT

"I was horrified. To know that not only was one person hit but everyone at that bus stop was hit."

A terrifying story for anyone parent to hear.

A family hit by a truck, waiting for their school bus.

ANNETTE ALBRIGHT

"Student safety should be the first concern."

Annette Albright talked to us in 2019 about school bus safety after she was concerned about her son's walk from the bus stop.

After what happened to councilman Tariq Bokhari's family, she says all school districts should reevaluate their stops.

ANNETTE ALBRIGHT

"Some stops are really unsafe. I think it's important they go out immediately, do some sort of assessment and make sure that's the best stop and the safest spot for that child. And if not, move that spot immediately."

In Bokhari's tweet sharing the news -- he said he was "angry that we don't have sidewalks."

That's something that could be changing soon.

ASHLEY LANDIS, planning and design deputy division manager CDOT

"We're going to be able to accelerate our projects, deliver more projects and really spread out the projects across the city."

That's Ashley Landis, the planning and design deputy division manager at CDOT.

After a WBTV investigation, the city passed funding for city sidewalk projects more than tripling the budget.

ANNETTE ALBRIGHT

"Were their sidewalks, were there trees in the way, did weather have an impact was their driver visibility? I started to think what could have happened that someone could have hit four people."

Security expert Karl de La Guerra says bus stop locations matters to keep kids safe.

KARL DE LA GUERRA, WBTV security & safety expert

"Don't wait close to corners if that is all possible. You want to wait further away from a corner on the street. You want to wait as far back from the street as you possibly can."

## **12/7/21 Weapons in Schools (6:00 p.m. 1:22)**

(William Lassiter, Office of Juvenile Justice)

"That bigger problem is what we need to get down to. How do we get to the conflicts that are going on in our communities and our schools to prevent those weapons from coming to school in the first place?"

William Lassiter with the North Carolina Office of Juvenile Justice says the number of weapons on school campuses has doubled since before the pandemic. He says most students bringing weapons to schools are 16 and 17 years old.

(William Lassiter, Office of Juvenile Justice)

"Almost all of the kids that have brought weapons onto school campuses in Mecklenburg County this year did not have a previous charge that they were facing in juvenile justice."

When it comes to eliminating gun violence and weapons at the source - his office is using money from the state budget to launch the firearm safety storage awareness initiative.

(William Lassiter, Office of Juvenile Justice)

"We're starting a public service announcement campaign where we're talking to adults about how you better secure your weapons so that children won't end up with those guns."

With this funding they're also partnering with local law enforcement, social services, and local organizations to distribute gun locks to adults.

(William Lassiter, Office of Juvenile Justice)

"We know that you just can't do it at a state level, you need to get down into the local level and get with trusted people that folks who are buying the weapons that they're going to listen to so they understand why it's important to secure those weapons, so kids don't get them."

**12/23/21 Crimestoppers: Postal workers robbed at gunpoint in Charlotte (5:00 p.m.)**

As if the holiday season wasn't stressful enough for postal workers, two were recently robbed at gunpoint while delivering mail in Charlotte. The two United States Postal Workers were robbed around 2:40 p.m. Dec. 21 on the 400 block of Music Hall Way. The suspect is described as a tall, thin Black male in his 20s.

**SOCIAL: HUMAN SERVICES**

**9/13/21 Union County Contact Tracing (5:30 p.m. 1:53)**

Another big change in Union County Schools.

Katherine Rowland, UCPS parent

"Her desk is side by side with classmates. There's no social distancing."

The UCPS board voted Monday to end COVID-19 contact tracing.

And quarantining is only required if a student or staff member tests positive or has symptoms.

Otherwise, students should go to school no matter who they've been in contact with.

RICHARD DAUNT, UCPS parent

"I'm excited kids will get to have their education back again and not be sent home on any worse case scenario people can imagine."

Union County Public Schools is required to alert the health department of positive cases and Union County will continue to contact trace...but some parents say that might be too late.

Katherine Rowland, UCPS parent

"If children are in her class are symptomatic and go home and my 11-year-old doesn't tell me, I have no way of knowing if I can take her to go see my 90-year-old grandmother...

Some parents say they don't trust UCPS to do the right thing -- and they're asking Governor Cooper to step in.

Katherine Rowland, UCPS parent

"I hate for him to have to come to that point that he has to mandate that. But at this point I hope the governor steps in and protects us and our kids and I really hope he decides to do a mask mandate sometime soon statewide.

We didn't hear from Governor Cooper -- but did hear from the North Carolina Department of Health and Human Services who said the decision to this morning was "troubling."

In a statement - they are considering additional actions for Union County.

But that decision might not go over well with many --

RICHARD DAUNT, UCPS parent

If he wants to preside over the destruction of public schools he can go ahead. If he does that there will be a massive number of parents pulling their kids out of school because we the parents have had enough."

### **10/5/21 College Admissions (7:30 p.m. 2:07)**

Talk to those parents who this might be the first time their first-generation college student. You know, in their family you know lots of parents are working hard to get their kids this opportunity. What would you tell them about? This process so maybe calms their nerves.

Yeah, I think it doesn't have to be scary. I know it's a huge, huge commitment as a family, but I think having a discussion. About what you value and what's important to you so that you're making sure you're spending money that aligns with those values. I oftentimes hear families say, well, we have this budget. This is what we can spend, but we'd be willing to pay it if they got into this school, or we'd be willing to, you know, make extreme sacrifices if our student. Got into ex school, which makes me a little nervous because it feels like, gosh, I don't want families or students to be in such significant debt and especially when we're talking about value that oftentimes we don't really understand what we're basing it off. You hear about adults all the time, saying, oh, I've heard that's a good. Cool, how do you know and oftentimes it's just hearsay. It's just, oh they were on the, you know, they have a big football team and I've heard of them, or I have a friend to work with who I love who went to that school. So, I think it's also on us. The adults in the room to make sure that when we talk about what's a good school or a bad school, we've done our research for the kid who's in front

of us and know this is a good school for my Kid and make sure we're aligning value with that.

And you're going to make the most of it once you're there, right? It's really on. You, no matter what the. Name of the of the Pennant is behind you that you're at. You can make the most out of no matter where you land.

Absolutely, and that's I mean, studies upon studies have shown this that the name on the diploma doesn't matter as much as what you do when you get there. And I will say big caveat to that though is it does matter what your financial aid package is. So, if you're going into debt and you do a great job when you're there, but you're riddled with debt that doesn't make for a good experience. But if it's a good package. It's a school that's a good match. And you can really shine when you get there. That's what college is.

I don't mind take a breath you're going to get through all this, aren't you?

Exactly, it's going to be OK.

Casey near college wise, Casey. Thanks for the time on the inside. I appreciate it.

### **10/22/21 Community Conversation (7:30 p.m. 4:33)**

Three people chair the DA's Diversity and Inclusion committee. No budget for this but there is a curriculum.

Tell me about that curriculum and the classes tell me all about that.

The goal of our curriculum moving is not necessarily offer to always have mandatory trainings Spencer may want some mandatory trainings we may find some we think may be beneficial for everyone to do - but our goal is to help people continue to learn to continue to grow but in different ways - some people may want to read a book and talk about it. some people might prefer to do a 21-day equity challenge on their own - some people might want to go out and get involved with the community and we are not looking for a one size fit all.

After the attorneys chose their activity - they come back in a group setting and discuss what was experienced and learned.

This can be a hard thing for people to talk about this could be difficult, so I know we have had difficult conversations I know there have been people who have been brave to share things people who have been questioning things and that's what we want we want the conversation to happen.

Already I have seen where members of my office are asking questions in a slightly different way which are giving people more of an opportunity meaning members of our community more of an opportunity to talk about their frustrations with our justice system

That makes a difference.

When they are willing to tell me that when they are willing to tell members of my staff that that's a breakthrough that means we are getting somewhere

What have people said about the DA's office to show that you needed this work People have looked me in the face and told me listen I don't necessarily trust you I don't trust because I don't believe you understand the plight of a

woman I don't trust you the plight of someone who is not from this country I don't trust you because you don't speak my language I don't trust you because maybe you didn't grow up in the same part of town I grew up in and so what am I going to do with that except ask questions except seek to learn.

as a white attorney have your eyes been opened as it relates to dealing with African American community - Hispanic community talk to me about your own experience.

Personally, my eyes have been opened there is just so much I didn't know everyone says you don't know what you don't know

I didn't know the history of our country or this community I didn't know how different people's experiences really could be from my own.

I have seen how difficult it has been for me at times to connect with victims with witnesses with them not understanding me and it has helped me in this work to try to be someone they can trust to be someone they are willing to open to and the only way I can do that is by coming to them wanting to understand them and trying to learn what they have gone through.

It makes witnesses more comfortable if we are there actually hearing them listening to them, I don't want to come in with assumptions that I know what they happened or what they experienced.

Have you had lawyers who did not embrace this, and have you had to get rid of some lawyers who weren't on the same page as you?

I think we haven't had to get rid of anybody this is what people have come to do they've come to serve this isn't about politics.

All of us are trying to get better at our jobs all of us I expect that every attorney from the person who started yesterday to the person who started 25 years ago I would expect that every single one of them are doing something just to get a little bit better at their craft every single day.

We must figure out how we meet whole people where they are.

#### **10/26/21 Too Much Trash (5:00 p.m. 1:02)**

Take a step outside. It may look trashy.

NCDOT says at the beginning of the year, they had a surplus of litter to pick up.

I learned during the pandemic when people started quarantining and weren't traveling as much, their budget took a hit.

NCDOT is funded by the gas tax so with not as many people driving, -- they needed to cut back on programs like litter pickup.

However, right now—they're at normal pickup levels.

#### **11/16/21 Teacher Raises (11:00 p.m. 2:09)**

Courtney Cole reports for WBTV on the recent teacher pay raises:

One teacher says extra money in salary would help her pay for classroom supplies. She was thrilled.

Yet others tonight told me though any raise is good... she thinks more should be added and what's pending tonight, doesn't satisfy everyone.

"I'll probably be putting it in my savings just trying to build up some interest there."

Gaston County's Brookside Elementary School Music Teacher Erynn Chambers is anxiously waiting final approval for the proposed the state budget.

The proposed numbers include an average five percent pay raise for teachers over the next two years, a nearly three-thousand-dollar bonus, and 1 million dollars to support low wealth counties with recruiting teachers.

"Some people are feeling grateful for it, some people are like 'well where's our step raise that we were supposed to get?'"

That proposed budget is statewide... and it would be in addition to what Gaston County voted on Monday night:

To give an extra thousand-dollar bonus to all school employees hired before September 1st, 2021.

Similar story – but even better – in Rowan-Salisbury Schools.

Employees there will get a \$2,000 bonus starting next month.

Long time bus driver Debra Campbell calls that a blessing.

### **11/22/21 Mental Health and Holidays (6:00 p.m. 1:31)**

I don't have a job, I have 10 grandkids, I got bills.

A lot of gift-giving, a lot of spending money

Yes, it's very stressful. The holidays can be a lot to unload.

And right now, experts say, inflation – fueled by supply and demand issues –is causing prices to creep up. It can all take a toll on your mental health.

Everything is going up for sure but the overall family budget has not increased so that difference in price or that inflation causes additional stress. 55

Mental Health Counselor Damion Harmon says he's seen a spike in new clients and sessions over the holidays.

In addition to outside influences...

The time can drum up grief and unresolved issues within family and friends.

### **12/2/21 VP Kamala Harris live interview with WBTV's Jamie Boll (7:00 p.m. 6:16)**

Madam Vice President, welcome back to Charlotte.

{VP Harris} Good to be back in Charlotte.

{Jamie} I know, you know, the expression all politics is local. Right. And I couldn't help but think as I was driving in to work this morning. Infrastructure is kind of the same way apps, especially as I'm stuck on i 77, and bumper to bumper traffic, but lots of other people. Does this bill, does this law, is it going to make my trip to work smoother and quicker?

{VP Harris} Yes, it will. And then you are absolutely right. And that's why I'm here in Charlotte. That's why we've been working with mayors, with governors

with local elected officials, because this absolutely is about getting it right into the communities that need it. So in North Carolina, we are looking at almost a billion dollars that are going to go into public transit. So we're on this beautiful bus. Why is that going to matter for real people at a local level to your point, people take the bus to school, they take it to work, they take it to church, if a bus breaks down, that means that you might be as much as an hour late for work that might dock your pay real consequences.

{Jamie} What about the highways themselves? You're in North Carolina, home of NASCAR? We love our cars. Yeah, people still like to drive?

{VP Harris} Okay, so let's talk about driving. So we're looking at putting billions of dollars into roads and bridges. Why is that going to matter for a driver? Well, first of all, if you have to drive over potholes every day, if you have to drive over bridges that are falling apart, what does that mean, you're going to get a flat tire. Well, insurance, insurance doesn't cover the cost of replacing the tire, and the cheapest tire, you can get us about \$100. That's a lot of money, that you're asking folks to pay, because we need to repair our roads and bridges. We are now because of our infrastructure deal, and put billions of dollars into upgrading the roads and bridges of America.

{Jamie} And you mentioned mass transit, obviously, as well. And you know, the long list here of needs in Charlotte is really fast-growing commuter, and I'm sure you've heard it today from the local leaders, are we going to be able to build some of these light rails faster? Are we going to be able to get commuter trains going quicker?

{VP Harris} That's why we're here actually, right here at CATS because if you look, we're looking at electric buses, we're looking at electric rail cars. And that requires some federal investment so that at a local level, we can create the jobs that are about the manufacturing the repair the folks who are going to be driving these buses driving the rail systems. And we're very excited about it.

{Jamie} No House Republicans from North Carolina voted for this bill, the infrastructure law that passed. They use reasons like there's not enough on roads and bridges. it's not paid for, etc. How do you react to them?

{VP Harris} This is the bipartisan infrastructure law. And Republicans supported it. Because we know that the way that Americans live, when they're driving that car on that road or bridge, it's falling apart, they could care less about who their elected official, what party they're registered to vote with what they know, they want this stuff fixed. And that's how we're going to approach this as we move forward.



{Jamie} The second bill, though, you're still trying to get through, it doesn't appear like you'll get any Republican support for that. Is bipartisanship, then just dead you moved on from that?

{VP Harris} No, I mean, in fact, if you look at the build back better act that we are now in the process, we believe, of being able at some point soon to get past. It's about a Republican mayor's all over the country. There are Republican mayor's all over the country in different regions who have supported it because they know we've got to bring down the cost of childcare. Working Families should not have to pay more than 7% of their income and childcare. We need to bring down the cost of elder care. So many working people are taking care of their young kids and their senior relatives. And it is just Absolutely impossible to juggle it all because they can't afford to do it, we're going to bring down the cost of prescription drugs. How many people here in Charlotte in North Carolina have diabetes? Who can barely afford to pay for the insulin that keeps them alive? We're going to say, and we're with Bill back, better you don't pay more than 35% \$35 Excuse me a month for insulin. This is real stuff. And that, that that diabetic, could care less about somebody saying this is a Republican or a Democratic policy, they need to be able to afford their insulin, or they die.

{Jamie} You're talking about prices? Let's talk about that real quickly. If we can, I think tell most people see it that at the gas pump, they they see that the grocery store, they're paying more for their groceries, they're worried are the Christmas presents going to arrive on time, will they? And will prices come down?

{VP Harris} So you're talking about supply chain issues, and they are real. And why we'll look at we've been through almost two years of a pandemic, where our economy shut down, where people were not able to work manufacturing slow down, if not in some sectors shut down. And so, the supply chain was directly impacted. And as the economy is now building back up, which it is, we've got to deal with the short-term impact of the two years of a pandemic. That's why the President and we as an administration said, Hey, let's look at the ports issue. We got to open those ports, where all these goods are coming into the United States. They can't just operate a five-day, week, day, eight hours a day, let's open them up 24 hours a day, seven days a week. That's what we did, in places like California, places like Savannah, Georgia, so that we can start bringing more goods in so that Santa Claus can do what Santa Claus needs to get done. To make sure that all our kids get something on their wish list.

{Jamie} Just a real quick follow up if I could because some economists have said, because demand surge that was because there was too much stimulus put into the economy. Did you put too much in?

{VP Harris} Listen, you want to talk about what we did with the American rescue plan. Let's talk about the fact that folks had the ability because of the American rescue plan, to not lose their home, to be able to pay their bills to get through one of the most difficult times economically that our country has endured, and those families who benefited from it had a right to believe that we will be there to support them when the catastrophe was no fault of their own. The catastrophe being this pandemic.

{Jamie} Madam Vice President, thanks for the time.

### **12/31/21 Salisbury-based Three Rivers Land Trust permanently conserves 147 acres in Davie County (6:00 p.m. 1:30)**

Salisbury-based Three Rivers Land Trust (TRLT) has announced the conservation of a 147-acre property located in Davie County. The landowner, Grover McNair, placed a permanent conservation easement on his family farm on December 29th, 2021. This conservation easement will restrict future development and subdivision of this important parcel.

"The conservation of important natural areas and family farms are a focus of Three Rivers Land Trust and we are thankful to have helped Mr. McNair protect his property in perpetuity" states Executive Director Travis Morehead.

"This newly protected property in Davie County is comprised of mature hardwoods, pine stands, and is bisected by a beautiful unnamed creek that is a tributary of Dutchman's Creek," states Sam Parrott, Associate Director of Conservation. "By conserving this property, we are not only protecting the extensive mixed hardwoods and wildlife habitat, but are also protecting water quality in Dutchman's Creek and ultimately the Yadkin River". Three Rivers Land Trust is committed to working with property owners like Mr. McNair to conserve tracts like these, while they remain undeveloped.

Linda disappeared on July 6th, 1973, as she walked home from summer school; she was last seen talking to a man in a turquoise blue van in Corona del Mar, CA. Her body was found the next morning along a nature trail. There were few clues to what happened and after years of working on the case, the detectives eventually ran out of leads. On July 6th, 2018, the Newport Beach Police Department launched a series of tweets which told Linda’s story, and ended with the killer’s DNA composite released to the public. The unusual campaign went viral, accumulating more than 7 million impressions worldwide, and garnered national and international attention to the case. Inspired by the methods used to arrest the Golden State Killer, investigators applied genetic genealogy to Linda’s case and uploaded the killer’s DNA profile into GEDmatch, a public database. In January 2019, the DNA sample left by Linda’s attacker led to a perfect match in Monument, CO: James Alan Neal. Further investigation revealed that at the time of Linda’s murder, he lived in Orange County and that his real name was James Albert Layton. Soon after Linda was killed, he turned up in Florida under his new identity. James Neal’s criminal history contained petty crimes to serious offenses and included other sexual assaults. He was arrested and pleaded not guilty on all counts in Orange County Superior Court. The fire began when the band, Jack Russell’s Great White, took the stage and their tour manager set off four large fireworks called gerbs. Flames appeared on the walls on either side of the stage and spread quickly due to the highly flammable foam that lined the walls and ceiling, installed to dampen the sound. In December 2003, brothers and owners Jeff and Michael Derderian were each charged with 200 counts of involuntary manslaughter; Daniel Biechele, Great White’s tour manager, faced the same charges – he had failed to get a license for the pyrotechnics from the state of Rhode Island and permits from the local fire department. In February 2006, a plea deal was reached with the tour manager: sentenced to 4 years, Daniel Biechele was paroled after 22 months. Michael and Jeff Derderian pleaded no contest. Their plea deal stated only one of them would go to prison and because Jeff had young children, Michael served 33 months in prison; Jeff completed 500 hours of community service. Eighteen years after the fire, the brothers use this broadcast to tell their story and reveal new information about the foam used to line the walls and ceiling of the club, claiming the foam company sent them the wrong foam. The Derderians have since learned that the fire marshal should have tested the foam and have always maintained they never gave the band permission to use pyrotechnics. Former Rhode Island attorney general Patrick Lynch led the investigation into the fire; he stands by his initial findings and disagrees with the brothers’ decision to come forward. In 2017, a memorial was opened to honor the lives lost in the fire. **On-screen text graphic:** At the time of The Station fire, older clubs in Rhode Island weren’t required to install sprinklers. It is now mandatory for nightclubs with occupancy over 150 to have them. Since The Station fire, many states have adopted stricter fire prevention codes. **48 HOURS: “The Murdaugh Mysteries”** – a report on the investigation into Alex Murdaugh, a wealthy, once prominent attorney in the South Carolina Lowcountry, and the incidents connected to his family. On June 7th, 2021, Alex Murdaugh called 911 to report he found his wife Maggie and son Paul shot to death at the family’s hunting lodge in Colleton County. About two-and-a-half years earlier, Paul was charged in the February 2019 boat crash that killed 19-year-old Mallory Beach. Mallory was one of six friends onboard the Murdaugh family boat when it crashed into a bridge on Archer’s Creek. All were underage, and all drinking alcohol. A month after the crash, the Beach family filed a wrongful death suit against members of the Murdaugh family. In September 2021, Alex Murdaugh resigned from his law firm and a day later reported he was shot. He later named Curtis Smith as the gunman, who maintains he did not shoot Alex and claims Alex requested Curtis’ help to make the incident look like a suicide. Alex faces charges of insurance fraud, conspiracy to commit insurance fraud and filing a false police report, in addition to two felonies related to a different alleged insurance fraud case involving the 2018 death of Gloria Satterfield, his former housekeeper. Evidence gathered by investigators looking into the shooting of Maggie and Paul Murdaugh led to the reopening of the investigation into the unsolved death of Stephen Smith, who was 19-years-old when he was found dead on a Hampton County roadway in July 2015. Alex Murdaugh was admitted to the Richland County jail October 16th; Curtis Smith is out on bail. In 2016, Robert Kennedy, Jr., Michael Skakel's cousin, released "Framed: Why Michael Skakel Spent Over a Decade in Prison for a Murder He Didn't Commit", which repeated Skakel classmate Tony Bryant's 2003 allegations that his friends Burton Tinsley and Al Hasbrouck murdered Martha Moxley. In 2018, the Connecticut Supreme Court vacated his murder conviction and ordered a new trial. But in 2020, prosecutors said they would not retry him. Dorothy Moxley remains convinced that Martha was murdered by Michael Skakel; no one has been convicted of the murder. **On-screen text graphic:** Michael and his brother Tommy, according to one of his attorneys, have been estranged for years. - 11/13/21      **48 HOURS: “The Ring: The Murder of Patrick De La Cerda”** – a report on the February 27<sup>th</sup>, 2018 murder of Patrick De La Cerda, who was expecting a delivery of an engagement ring for his fiancée, Jessica Devnani. De La Cerda was shot four times in the doorway of the home he shared with his father on the outskirts of Deltona, FL. The investigation exposed a meticulous murder plan crafted by a man jealous of the couple’s relationship: Devnani’s ex-boyfriend, Gregory Bender, who had been harassing the couple. Since Bender violated the restraining order the couple had against him by telephoning Devnani the morning of De La Cerda’s murder, he was arrested. A February 28<sup>th</sup>, 2018 search of Bender’s home led to the discovery in a trash can of several handwritten pages with a map of the murder scene and details of how to conceal the crime. Less than 48 hours after De La Cerda’s death, Gregory Bender was arrested for murder in his front yard, after being released from the Orange County Jail. The trial included testimony from Bender’s ex-wife, Daymara Sanchez, about the murder plan; Bender’s defense insisted that the murder plan did not equate to guilt. The jury found Bender guilty of the charge of first-degree murder. In Florida, a conviction of first-degree murder carries an automatic life sentence without parole. **On-screen text graphic:** Gregory Bender’s attorneys say they plan to appeal his conviction. They contend the search of his house that produced the murder plan was illegal. - 11/20/21      **48 HOURS: “A Killer In The Family Tree”** – a report on the murders of Tanya Van Cuylenborg, 18, and her boyfriend, Jay Cook, 20, in November 1987 and the connection to Chelsea Rustad, an amateur genealogist from Tumwater, WA. On November 18<sup>th</sup>, 1987, Tanya and Jay left British Columbia in Jay’s parent’s van for Seattle, WA, to pick up furnace parts. After they didn’t return home, Jay and Tanya were reported missing. On November 24<sup>th</sup>, Tanya’s body was found in Skagit County, some 80 miles north of Seattle; she had been raped and shot in the head. The next day, her wallet, the keys to the van, bullets and other items were found under the porch of a tavern in Bellingham, WA. The following day, Jay’s body was found under High Bridge, 70 miles south from where Tanya was found; he had been strangled. Recovered evidence and semen samples allowed investigators to create a profile for “Individual A”. In 2017, Parabon NanoLabs was hired to predict the genetic traits of “Individual A” through Snapshot Phenotyping. After the Golden State Killer was arrested in 2018, Parabon NanoLabs agreed to upload the DNA of “Individual A” to the genetic database GEDmatch on April 27<sup>th</sup>, 2018. Genetic genealogist CeCe Moore assisted with what became her first criminal case and soon identified William Earl Talbott II. Investigators sought information from Chelsea Rustad, Talbott’s second cousin, who had also uploaded her DNA to GEDmatch. After a fresh DNA sample from Talbott was matched to “Individual A”, William Talbott was arrested on May 17<sup>th</sup>, 2018; he pleaded not guilty. Talbott’s trial began in June 2019 in the Snohomish County Superior Court; he was found guilty of the aggravated murders of Tanya and Jay and sentenced to two life terms in prison without parole. 11/27/21      **48 HOURS: “A Promise to Ahmaud”** – a follow-up report on the shooting death of Ahmaud Arbery, focusing on the trial against the three White men - Travis McMichael, Gregory “Greg” McMichael and William “Roddie” Bryan - accused of killing the Black jogger and the final guilty verdicts. On February 23<sup>rd</sup>, 2020, Ahmaud Arbery went running in the Satilla Shores neighborhood of Brunswick, GA. He went inside a home under construction; a neighbor called 911 to report a trespasser. Greg McMichael and his son, Travis, decided to follow Ahmaud in their truck, who fled when they confronted him. Soon William “Roddie” Bryan joined the pursuit, and the McMichaels were able to box Ahmaud in. As Ahmaud attempted to run past Travis, a confrontation ensued, which resulted in Ahmaud being fatally shot. First responders arrived within minutes and allowed all three men to go free. Police contacted Ahmaud’s mother, Wanda Cooper-Jones, and stated that he was killed during a break-in. She learned the truth after it was published in the paper. On May 5<sup>th</sup>, 2020, 72 days after the shooting, video of Ahmaud being chased down and killed was released and led to widespread condemnation and protests. Greg and Travis McMichael were arrested on May 7<sup>th</sup>; Roddie two weeks later. A year and 8 ½ months later, the trial began for the three men accused of murder. Central to the prosecutor’s case was that Travis, Greg and Roddie acted as vigilantes. Defense attorneys claimed that under Georgia’s citizen’s arrest law, they were justified. That law was overhauled after Ahmaud’s shooting. Roddie’s lawyer painted his client as an innocent bystander. Travis McMichael testified. After ten days of testimony and almost a day-and-a-half of closing arguments, the trial went to the jury - comprised of 11 White jurors and one Black juror. Eleven hours later, they reached their verdict: Travis McMichael, who fired the fatal shots, was convicted on all counts; His father Greg and neighbor Roddie were convicted of felony murder and other charges. **On-screen text graphic:** In February 2022, Travis McMichael, Gregory McMichael and William “Roddie” Bryan are scheduled to face federal hate crime charges in a separate trial. In November 2018, Amy Mullis was found dead by her son, Trysten, in a shed on the family farm. She had apparently been killed by a corn rake used on the farm. After an investigation, her husband Todd Mullis was arrested for Amy's murder. The autopsy showed a pattern of puncture wounds that indicated Amy had been struck with the corn rake multiple times. Other injuries she had also indicated she had been in a struggle. Police investigations turned up an affair that Amy had in the past. The couple reconciled, but Amy agreed to leave her job and work on the farm, allegedly so Todd could keep an eye on her. Friends testified that Amy was unhappy. Eventually she would begin another affair, with the farm's manager Jerry Frasher, which Todd found out about. Todd's alibi was that he had been working in a barn with Trysten before his son found Amy's body. However, Trysten would amend his story, adding that he went to the office at the front of the barn a few times. At trial, the prosecution maintained this allowed opportunity for Todd to commit the murder. They also cited that surveillance cameras around the property were not working the day of Amy's death in addition to suspicious internet searches related to infidelity and murder. Todd countered that there had been no surveillance footage for weeks before the murder, possibly due to animals damaging it and that the device the searches were made on was accessible to the entire family. After jury deliberations, Todd was found guilty. He filed a motion for a new trial based on the fact that his original attorneys did not focus on presenting Amy's death as an accident as he pushed for. In September 2020, his motion was denied and he was sentenced to life in prison. **On-screen text graphic:** Todd and Amy Mullis' three children—Trysten, Taylor, and Wyatt—are now with Amy's family. This report focuses on what ultimately happened to a 9-year-old girl adopted in 1997 by Crystal and Jesse, a couple from Atlanta, GA. While in Russia, adopting the girl they named Caralee, Crystal and Jesse also adopted a 3-year-old boy they named Joshua. Two years later, the couple came to believe Caralee was dangerous, even capable of murder and claimed she tried to throw her younger brother off a 30-foot-high deck. Troy Roberts, who reported on their story, was present as the American couple returned Caralee to Russia and left her behind in a children's psychiatric hospital. Over the years, Roberts tried to keep track of Caralee, but was unable to find out what happened to her. Last summer she reached out to Roberts and they reunited in North Carolina, where Caralee, now known as Sabrina Caldwell, lives with her husband and four children. During their meeting, Caldwell explained what happened on the family deck with Joshua, her feelings about Crystal and Jesse, how she left the hospital in Russia and was adopted by new parents in North Carolina, and her family with her husband. This broadcast also includes Roberts' own experience with adoption: In 2003, he became certified to adopt and learned about a woman in Djibouti (in East Africa) who was hoping to find an American to adopt her 4-year-old son, because she feared for his safety due to his being mixed-race. Roberts and his son, Jonah Gray Roberts, now 23-years-old, discuss their life together. **On-screen text graphic:** Jonah's mother passed away a few years after his adoption. - 12/11/21      **48 HOURS: “Who Killed Rachael DelTondo?”** – an update on the investigation into the May 2018 murder of Rachael DelTondo, a popular teacher who was gunned down outside her home in Aliquippa, PA. The case was first featured in 48 HOURS: “What Happened to Rachael”, OAD: 05/18/19. The investigation led to several potential leads for the police to follow, including the actions of DelTondo’s ex-fiancé Frank Catroppa and her friendship with Sheldon Jeter, a young Aliquippa High School athlete. Before the murder, Catroppa was allowed access to a police report about DelTondo with a lot of sensitive personal information, but he denies showing it to anyone. Jeter, through his attorney, also denies anything to do with the murder. There is also the belief that Sheldon Jeter was obsessed with DelTondo and there may have been some sort of inappropriate relationship. Her mother, Lisa DelTondo, also says her daughter told her she was cooperating in an ongoing investigation by state police into alleged corruption in the Aliquippa Police Department and had received death threats. **UPDATE:** On May 17<sup>th</sup>, 2020, Sheldon Jeter was arrested and charged with the murder of Tyrice Pugh, a friend of Jeter’s who lived on and off with the family. In early June 2021, Jeter went on trial and was ultimately found guilty; in Pennsylvania, first-degree murder carries a mandatory sentence of life without parole. A secret Pennsylvania statewide grand jury has heard evidence about Jeter’s possible involvement in DelTondo’s death; the district attorney’s office hasn’t officially named a suspect or person of interest. - 12/18/21      **48 HOURS: “Scott Peterson: Case in Question” (9:00 – 10:00p)** - an update on the case of Scott Peterson, who was convicted and sentenced to death for the murder of his pregnant wife in 2004. On December 24<sup>th</sup>, 2002, Laci Peterson was reported missing by her family in Modesto, CA. Investigators’ suspicions turned to her husband, Scott, whom they believed was acting strangely in response to her disappearance. They also considered it odd that he spent the 24<sup>th</sup> on a fishing trip, leaving Laci alone, despite her being eight months pregnant. The case quickly gained national and international attention. A month after Laci’s disappearance, Amber Frey came forward and revealed that she had been in a romantic relationship with Scott and had no idea he had been married or expecting a child. More than three months after her disappearance, the bodies of Laci and Conner washed up in San Francisco Bay, only a few miles away from where Scott said he was fishing on Christmas Eve. Police quickly moved to arrest Scott. In 2003, Scott’s trial began in Redwood City, CA, where it had been moved to avoid publicity. The prosecution focused on the numerous lies he told during the investigation and used Amber Frey’s secretly made recordings of phone calls between her and Scott. He was found guilty on November 11<sup>th</sup>, 2004. Four months later, Scott was sentenced to death. Scott’s defense team filed appeals for years and in the summer of 2020, the California Supreme Court threw out his death sentence due to a mistake on how jurors were selected. His attorneys continue to push for an entirely new trial based on juror Richelle Nice, who incorrectly filled out a prospective juror questionnaire. Scott’s defense team, as well as his sister-in-law Janey Peterson, theorize that Laci was still alive when Scott left for his fishing trip, that he is being framed and that there is a connection between two men caught burglarizing a home across the street from the Petersons. *Original on-screen text graphic: Scott Peterson’s next court appearance is expected in June 2021. **48 HOURS: “The Life and Death of Nikki Kuhnhausen” (10:00 – 11:00p)** – a report on the murder of Nikki Kuhnhausen, who disappeared June 6<sup>th</sup>, 2019 after connecting with a man in a Snapchat rendezvous. Her murder continues to impact LGBTQI (lesbian, gay, bisexual, transgender, queer and intersex people) communities. The murder of Kuhnhausen illustrates the real-life dangers and struggles many in the transgender community face every day. Kuhnhausen, age 17, vanished from Vancouver, WA in June 2019, just hours after meeting and exchanging messages on Snapchat with David Bogdanov, then 25. Bogdanov also seemingly disappeared. Four months later, Bogdanov claimed phone problems when he met with police and told them the last time he had seen Kuhnhausen was when he asked her to get out of his car, after she told him she was transgender. Bogdanov told police he had no idea where Kuhnhausen went after she left him. On December 7<sup>th</sup>, 2019, six months after she disappeared, Kuhnhausen’s body was discovered by a hiker on Larch Mountain. Bogdanov was arrested on December 17<sup>th</sup>, 2019 after cell tower data placed his phone where Kuhnhausen’s body was found. Prosecutors and investigators say Bogdanov killed Kuhnhausen in a hate-filled rage after learning she was transgender. At his August 2021 trial, Bogdanov said he killed Kuhnhausen in self-defense when she reached for his gun. He testified that he panicked after realizing she was dead and dumped Kuhnhausen’s body at Larch Mountain. Bogdanov was found guilty of murder in the second degree and malicious harassment, a hate crime. He was sentenced to the maximum 19 and a half years for murder, with 12 concurrent months for the malicious harassment charge. Kuhnhausen’s mother and supporters from the Justice for Nikki Task Force were determined something positive should come from her death and worked with legislators in Washington to pass Nikki’s Law, which is designed to prevent defendants charged with violent crimes from using sexual orientation or gender identity as an excuse for violence, the so-called “gay” or “trans panic defense”. **On-screen text graphic:** According to the Human Rights Campaign, there have been more violent deaths of transgender and non-binary people in the U.S. in 2021 than any other year on record. - 12/25/21 **48 HOURS: "Natalie Wood: Death in Dark Water"** (9:00 – 10:00p) - a follow-up report about the unexplained death of Hollywood star Natalie Wood nearly four decades ago. County sheriff's investigators speak for the first time and tell 48 HOURS her then-husband, actor Robert Wagner, is now a person of interest; the investigators want to speak with Wagner about circumstances surrounding her death in 1981. Wood drowned off the coast of Catalina Island in California in November 1981 after she went missing from the Splendour, her family's yacht. Also aboard that night were Captain Dennis Davern, and actor Christopher Walken. The next day, Wood was found floating in the water wearing a red down jacket and flannel nightgown. After a two-week investigation, the death was ruled an accident. In 2011, as detailed in "Natalie Wood's Fatal Voyage" (OAD: 11/19/11), the L.A. County Sheriff's Department reopened the death investigation. In 2012, the L.A. Coroner's Office amended the death certificate from "accidental drowning" to "drowning and other undetermined factors." Now, six years after that investigation 48 HOURS talks with the investigators about new witnesses, evidence, and theories as to what happened that night. Rumors of foul play have long surrounded Wood's mysterious death. At first, the three men aboard the boat told detectives Wood took off in a dinghy and went ashore. Over time, Wagner and Davern's accounts have shifted, raising a red flag to the investigators. Investigators also say Wagner has refused to speak with them since the case was re-opened. Investigators today note the autopsy report indicates there were a number of bruises that appeared to be fresh on Wood's body. The latest information is detailed through interviews with the detectives, and Natalie Wood's sister, Lana Wood. Also included are archival interviews with Robert Wagner and Captain Dennis Davern. - 12/25/21 **48 HOURS: "The Fenn Treasure"** (10:00 – 11:00p) – a report on the treasure hunt started by a rich art dealer and the lives lost in pursuit of it. After he retired as a fighter pilot, Forrest Fenn became a successful art dealer in Santa Fe, NM. In 2010, he published a memoir that included a twenty-four line poem that he said contained clues to the location of a ten-by-ten inch box filled with gold he had hidden in the Rocky Mountains. After attention from the media, the hunt grew in popularity, including annual "Fennboree" meetups, which Forrest himself attended. On January 5<sup>th</sup>, 2016, Randy Bilyeu set off searching along the Rio Grande near Santa Fe, NM with his dog. He was reported missing ten days later. A helicopter rescue crew located his dog and raft, but could not find Randy. Six months later, his body was found on a riverbank. In June 2017, three more searchers lost their lives. Jeff Murphy fell off a cliff. Pastor Paris Wallace attempted to cross the high waters of the Rio Grande near the Taos Junction Bridge, but was overcome. His body was recovered four days later and spurred New Mexico State Police to ask Fenn to call off the hunt. Fenn refused. Eric Ashby attempted to swim across the Arkansas River outside Canon City, CO, but could not get past the rapids. On March 17<sup>th</sup> 2020, Mike Sexson and Steven Inlow set off from Salt Lake City, UT so they could search before the coronavirus lockdowns went into place. Originally on snowmobiles, they left their vehicles and most of their supplies when the terrain changed. They attempted to reach a mountain ridge, but the trek was more arduous than anticipated. Without water, Steve resorted to drinking his urine to survive the cold. At 2AM on March 20<sup>th</sup>, he awoke to find Mike dead from hypothermia. The next day, Steven was able to draw the attention of a helicopter. On June 6<sup>th</sup>, 2020, Fenn posted a brief message on a forum used by searchers stating the treasure had been found. In July 2020, he elaborated that it was found in Wyoming. In September 2020, Fenn passed away. Later that year, Jack Stuef went public as the person who had located the treasure. **On-screen text graphic:** To this day, searchers continue to look for the spot where Jack Stuef found the treasure, still hoping to solve the clues in Fenn's poem.
