That bridge should be repaired early next month.

The "Johnson Bridge" was closed after cracks were found in three of the four supporting girders.

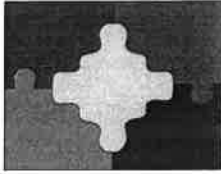
Commission Chairman Todd Woods says the repair bid came in well under estimates.....(NEWS14)(budgets)(:27)

Woods and incumbents Deb Bodenstedt and Ray Epp were defeated for reelection earlier this month, largely over the issue of confined animal feeding operations.

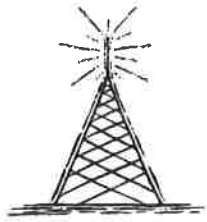
Woods says the court decision earlier this month upheld county zoning rules.....(NEWS22)(that)(:12)

Woods says Gustad has done a good job.....(NEWS1)(job)(:19)

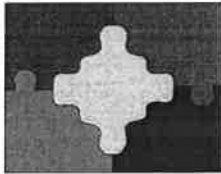
Woods says taking care of the counties hundreds of miles of gravel and paved roads with a limited budget has been a challenge.....(NEWS2)(of it)(:19)

Commissioner Ray Epp says there needs to be production agriculture...somewhere.....(NEWS3)(world)(:09)

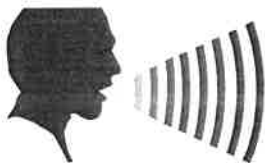
The commission approved the permits on a series of four to zero votes. Commissioner Gary Swensen had left the meeting earlier and was not present to vote.

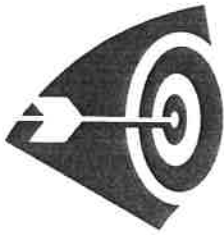

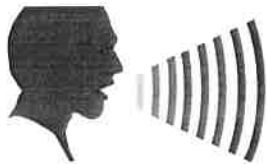
Creech was asking for a road use agreement, and said they plan to start construction early next year.....(NEWS17)(stuff)(:28)
