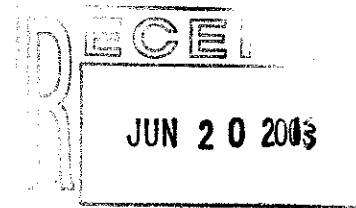

Dear Mr. Herman:

This letter follows up on your April 22, 2013 response to our March 12, 2013 letters to seven stations licensed to WatchTV, Inc. regarding their compliance with the online public file requirements.

We have reviewed the Station's filings as well as applications on file with the Commission and find that discrepancies exist with respect to two of the stations, KABH-CD and KORY-CA. Both stations filed requests for special temporary authority to remain silent on October 19, 2010, indicating that the stations had gone silent on October 16, 2010 in the case of KABH-CD and October 17, 2010 in the case of KORY-CA. Both stations also filed forms indicating that they returned to the air on October 15, 2011. However, the Class A certifications for both stations report that the stations were on the air throughout 2010 but were off the air from March 2, 2011 through February 8, 2012.

The current certifications and applications on file are therefore contradictory. In order to determine whether these stations are meeting the ongoing requirements of Class A license status, Watch TV, Inc. shall provide the following information for the Stations:


- 1) A declaration<sup>1</sup> from Station representative(s) with personal knowledge clarifying the operating history of both KABH-CD and KORY-CD from January 1, 2010 through the present;
- 2) Amended certifications and/or resumption of operations forms stating an accurate summary of the two stations' operating histories since January 1, 2010 until the present day; and
- 3) Copies of both Stations' full programming lists for October 2010, October 2011, March 2011, and February 2012.

Your submission must be filed with the Office of the Secretary, Federal Communications Commission, 445 12<sup>th</sup> Street, S.W., Washington, D.C. 20554, ATTN: Barbara A. Kreisman, Chief, Video Division, Media Bureau, within 30 days of the date of this letter. An electronic copy should also be sent to [peter.saharko@fcc.gov](mailto:peter.saharko@fcc.gov). **In the event that the Stations wish to revert to low power television status, you need only notify us of this election and request a change in status for the Stations. Should the Stations make such an election, any potential violations addressed in our letters would be moot and no further response would be required. Failure to provide the requested information or to request a change in status within 30 days from the date of the letter will result in further action, including potential loss of Class A television status.**
