This is to respond to the Video Division's letter of June 18, 2013, inquiring about discrepancies between my letter of April 22, 2013, and CDBS records regarding the dates that KABH-CD and KORY-CA were silent during the 2010-2012 time period.

The CDBS records are correct. The information in my April 22 letter was inadvertently in error. That information was derived from Class A compliance certificates in the Stations' online public inspection files. WatchTV is the licensee of seven Class A stations and created compliance certificates for all of them on a template form. When the template was copied from one station to another station, the silent dates for KABH-CD and KORY-CA were inadvertently copied from the dates for another station. The error was noted by our Chief Operator; but unfortunately, as best we can reconstruct the circumstances, the wrong versions of the certificates were uploaded to the public files by mistake.

Thus KABH-CD was silent from October 16, 2010, to October 15, 2011; and KORY-CA was silent from October 17, 2010, to October 15, 2011. Attached are copies of the logs for the stations, created contemporaneously in 2010 and 2011 by Jesus M. Ortega, Chief Operator, showing entries documenting the shut down and re-activation of the transmitters. These dates are confirmed by the statements regarding silence in Box 17 of contemporaneously-filed Form 398 Children's Television Programming Reports for the 4<sup>th</sup> quarter of 2010 and the 4<sup>th</sup> quarter of 2011.

Corrected Class A compliance certificates have been posted to our online public inspection files. Copies are attached.

Except for very short outages for maintenance and/or storm damage, both stations were on the air full time on all dates during the current license term prior to October 16/17, 2011, and from October 15, 2011, to the present. It should be noted that the stations were originally analog but are now digital, so some CDBS records are under what is now KORY-LP, which was the analog Class A station, with Class A status migrated to companion station KORY-LD, now KORY-CD.

Your request for "full programming lists" for four months in 2010, 2011, and 2012 is difficult for us to fulfill, because our programming records are computer-generated comma delimited ASCII files, and it would take a long time to translate all of those records into clear English. We hope that it will be sufficient to tell you that both stations carried programming from the Home Shopping Network and the America One network, 24 hours a day except for local programming time, before their periods of silence and America One network after their periods of silence. Our Form 398 Children's Television Reports show that the stations carried 6 to 10 children's programs each quarter, totaling 180 or more minutes (3 hours) per week, during the first half of October 2010, the second half of October 2011, and all of February 2012, all supplied by America One. The stations were dark in March 2011 and so did not broadcast any children's programming during that quarter.

The local programming on both stations during all the first half of October 2010, the second half of October 2011, and February 2012, was Northwest Weather Report, with content from each community of license, broadcast in hourly segments in all day parts, for a total of 31 minutes per day, 217 minutes (3 hours 37 minutes) per week. Since the stations were dark in March 2011, no local programming was broadcast during that month.

We apologize for the error in the Class A compliance certificates initially uploaded to our public inspection files. All other information we have filed has been consistent, as reflected in this letter.
