

As demonstrated in the screen capture below, the Licensee uploaded to its political file the below document on February 10, 2020. In the process of preparing its license renewal application, Licensee discovered that nonrelevant documents were inadvertently included with the original upload. To remedy this, Licensee removed the original upload from the political file, amended it to remove the erroneous information, and re-uploaded the document. The currently displayed date of upload reflects the date of the corrected upload.
