NEBRASKA EMERGENCY MANAGEMENT WANTS TO REMIND YOU OF A NATIONWIDE TEST OF THE WIRELESS EMERGENCY MESSAGE SYSTEM TODAY A LITTLE AFTER 1 O'CLOCK CENTRAL TIME. THE MESSAGE WILL COME ACROSS YOUR PHONE READING "THIS IS A TEST OF THE NATIONAL WIRELESS EMERGENCY ALERT SYSTEM. NO ACTION IS NEEDED" AN EAS TEST WILL THEN BE ISSUED A SHORT TIME LATER ON NORMAL OUTLETS LIKE RADIO AND TV. IF YOU WOULD LIKE TO LEARN MORE ABOUT THE ALERT YOU CAN GO TO READY DOT GOV SLASH ALERTS.

LINCOLN COUNTY SHERIFF'S DEPUTIES ARE INVESTIGATING AN ACCIDENT SOUTH OF HERSHEY ON LINK 56 C THAT OCCURED MONDAY EVENING JUST BEFORE 6. THEY RECEIVED A CALLED OF A FEMALE LYING IN THE ROADWAY WITH A VEHICLE PARKED NEXT TO HER. A DEPUTY ARRIVED AND STARTED LIFE SAVING TECHNIQUES BUT THE FEMALE WAS PRONOUNCED DEAD AT THE SCENE AND WAS IDENTIFIED AS 45 YEAR OLD BRANDY LEWIS OF OGALLALA. DEPUTIES THEN MET WITH THE MRS LEWIS'S HUSBAND 59 YEAR OLD TED LEWIS WHO WAS ALSO THE DRIVER OF THE VEHICLE. MR LEWIS TOLD DEPUTIES SHE DECIDED TO JUMP OUT OF THE VEHICLE WHILE IT WAS IN MOTION AND HE COULD NOT STOP HER. MR. LEWIS WAS DETAINED FOR A BLOOD TEST THAT INDICATED HE WAS ABOVE THE LEGAL LIMIT TO OPERATE A MOTOR VEHICLE. MR. LEWIS WAS ARRESTED FOR DRIVING UNDER THE INFLUENCE OF ALCOHOL 1ST OFFENSE AND INCARCERATED IN THE LINCOLN COUNTY DETENTION CENTER. AN AUTOPSY IS EXPECTED TO BE PERFORMED THIS AFTERNOON AND A ACCIDENT RECONSTRUCTIONIST ALONG WITH INVESTIGATORS CONTINUE TO LOOK INTO THE ACCIDENT.

A JUDGE HAS SET A MARCH TRIAL FOR ONE OF THE TEENAGES ACCUSED OF FATALLY SHOOTING 22 YEAR OLD ETHAN POHLMEIER IN NORTH PLATTE IN OCTOBER. 16 YEAR OLD BRAYDEN TURNER OF GRAND ISLAND WILL BE GOING TO TRIAL ON MARCH 6TH WITH A PRETRIAL HEARING ON FEB 4TH. 16 YEAR OLD JESUS MARTINEZ WHO IS ALSO BEING CHARGED WITH FIRST DEGREE MURDER AND USE OF A WEAPON TO COMMIT A FELONY WILL BE BACK IN COURT AGAIN ON DEC 17TH.

WINTER STORMS WARNINGS AND ADVISORIES REMAIN IN EFFECT UNTIL TOMORROW AFTERNOON FOR MUCH OF NEBRASKA AS A SNOW STORM MOVES INTO THE STATE.
