

Hope you had a good weekend and got a little rest. I just wanted to confirm with you the schedules and make sure we are both on the same page. You placed an original order for 26 spots on WXEF for \$328.90 gross and 24 spots on WKJT for \$248.40 gross. Total \$577.30 to run from 3/8 - 3/13.

Then you placed the same order to run from 3/14 - 3/19. 26 spots on WXEF for \$328.90 gross and 24 spots on WKJT for \$248.40 gross. Total \$577.30.

Also Friday afternoon you added another order for \$750.00 gross each station. \$1500.00 total. That will come to \$1450.15. 59 spots on WXEF for \$746.35 and 68 spots on WKJT for \$703.80. I have these spots starting tomorrow thru Monday if schedule is approved.
