Hello Linda:

Larry Walke in NAB's Legal Dept has reviewed your email chain with Quigley. Under the FCC's rules, you can request documentation that Quigley is a legally qualified candidate for President under the FCC's rules, in which case he is entitled to reasonable access. However, even so, a legally qualified candidate is not entitled to special payment terms (like Net-15) that differ from a station's normal business practice. So if your regular policy is to collect payment from political advertisers up front (or under some other arrangement subject to a showing of credit worthiness or some other conditions, etc.), it is within your rights to require the same for Quigley.
