On behalf of Tribune Broadcasting Denver License, LLC, licensee of Station KDVR(TV), Denver, Colorado, enclosed herewith please find its response to the EEO audit letter from Lewis C. Pulley, Assistant Chief, Policy Division of the Media Bureau of the Federal Communications Commission dated February 12, 2014 (the "Audit Letter"). This response is accompanied by a declaration signed by Peter Maroney, General Manager of Tribune Broadcasting Denver, LLC.

KDVR(TV) is commonly-owned and operated with its satellite station KFCT(TV), Fort Collins (Facility ID No. 125), and KWGN-TV, Denver, Colorado (Facility ID No. 35883, which is licensed to KWGN, LLC). The three stations comprise a single station employment unit that share employees. Tribune Broadcasting Denver, LLC and KWGN, LLC are indirect wholly-owned subsidiaries of Tribune Broadcasting Company II, LLC and Tribune Broadcasting Company, LLC (respectively), both of which are direct wholly-owned subsidiaries of Tribune Company.

Tribune Company acquired KDVR (TV) and KFCT(TV) on December 27, 2013 pursuant to FCC staff approval granted on December 20, 2013 (See FCC Files BTCCDT-20130715AER and BTCCDT-20130715AES). Accordingly, the enclosed materials cover the period since Tribune's December 27, 2013 acquisition of KDVR(TV).

STATEMENT

This responds to the EEO Audit Letter from Lewis C. Pulley, Assistant Chief, Policy Division of the Media Bureau of the Federal Communications Commission dated February 12, 2014 (the "Audit Letter"), addressed to Community Television of Colorado License, LLC, the previous licensee of Station KDVR(TV), Denver, Colorado. Tribune Company acquired KDVR (TV) and its satellite Station KFCT(TV), Fort Collins, Colorado, on December 27, 2013 pursuant to FCC staff approval granted on December 20, 2013 (See FCC Files BTCCDT-20130715AER and BTCCDT-20130715AES).

Tribune Broadcasting Denver License, LLC is the licensee of KDVR(TV) and KFCT(TV). These stations are operated as a single employment unit and share employees with KWGN-TV, Denver, Colorado, which is licensed to KWGN, LLC (collectively referred to herein as, the "Unit"). Tribune Company is the 100% owner and indirect corporate parent of both licensee entities. This response covers the period since Tribune's December 27, 2013 acquisition of KDVR(TV)/KFCT(TV) through February 12, 2014 (the "Reporting Period").

- 1. <u>EEO Public File Reports.</u> Section 3(a) of the Audit Letter requests copies of the Unit's two most recent EEO public file reports, station website addresses, and date of each full-time hire listed in each report provided. The Unit's EEO Public File Reports are due by December 1 of each year. There have been no EEO Public File Reports due since Tribune's December 27, 2013 acquisition of KDVR(TV)/KFCT(TV), and no such reports have been prepared. KDVR(TV)/KFCT(TV) maintains a website at www.kdvr.com, and KWGN-TV maintains a website at www.kwgn.com; each website contains a link to the Unit's most recent EEO Public File Report (prepared by the prior licensee).
- 2. <u>Job-Specific Recruitment.</u> The Unit has filled six (6) full-time vacancies during the Reporting Period, all pursuant to recruitment undertaken by the prior licensee. Attachment 1 lists the six hires made during the Reporting Period, the date of each hire, the referral sources use, the number and referral source for each interviewee, and the referral source for the successful candidate (as requested in Section 3(c) of the Audit Letter). Attachment 2 contains documentation requested in Section 3(b) of the Audit Letter demonstrating the job-specific recruitment for those six positions, including: for each position, the job description and a list of referral sources used to recruit for such vacancy, along with a confirmation list for sources notified through the Unit's EEO compliance vendor, Broadcast1Source. The Unit maintains electronic copies of notices and receipt confirmation data in the Broadcast1Source system, and either copies or confirms for those either self-posted by the Unit or faxed to referral sources. According to Unit records, the prior licensee utilized sixty (60) sources to recruit for the six vacancies, as listed in the "Master Recruitment Source List" included in Attachment 3.

When there are vacancies, the Unit's standard practice is as follows: the hiring manager consults with the station General Manager to assess staffing needs, define the duties of the position to be filled, develop a job description and recruitment strategy. The Executive Assistant to the General Manager sends vacancy notices to the recruitment sources identified by the hiring manager, primarily via email and faxes, or by direct postings on referral source websites. The Unit conducts broad outreach for both full-time and part-time vacancies.

² Prior to the December 27, 2013 acquisition, KWGN-TV was operated under a Local Marketing Agreement with KDVR(TV) and had fewer than five employees.

3. Supplemental Recruitment Initiatives.

Section 3(d) of the Audit Letter requests information about the Unit's supplemental recruitment initiatives. As of March 21, 2014, the Unit employed 204 full-time employees. More than 250,000 people live in the Denver, Colorado. Accordingly, the Unit is required under FCC Rules to perform four supplemental recruitment initiatives in each two-year reporting period. Since December 27, 2013, the Unit has continued the internship program established by the prior licensee. This program provides unpaid part-time internships for academic credit to students interested in pursuing broadcast and communications careers. For the spring 2014 semester, the Unit has two participants from the University of Colorado who are completing news internships. The Unit promotes the internship program on the station websites and through its relationships with area colleges and universities. Attachment 4 contains additional documentation about the internship program. The Unit intends to undertake further supplemental outreach in accordance with FCC Rules.

- 4. <u>Pending or Resolved Complaints.</u> Section 3(e) of the Audit Letter requests information about pending or resolved complaints alleging unlawful discrimination in the employment practices on the basis of race, color, religion, national origin, or sex. There have been no such complaints filed against the Unit since December 27, 2013, nor has the Unit inherited any such matters from the previous licensee.
- 5. <u>Management EEO Responsibilities & Policy Dissemination.</u> Section 3(f) asks the Unit to describe management level responsibilities pertaining to informing Unit employees about and enforcing Unit EEO policies during the Reporting Period. Tribune and its business units believe in equal employment opportunities for all, regardless of race, color, religion, sex, national origin, age, disability or any other legally protected classification, and is committed to providing its employees a professional work environment free from physical, psychological or verbal harassment. In general, the company's policy is to hire and promote the most qualified applicants and to comply with all federal, state and local equal employment opportunity laws. At the station level, enforcing these policies and priorities are the responsibility of hiring managers, department heads and the General Manager, in consultation with the company's Regional Human Resources Manager and the Vice President of Human Resources for Tribune Broadcasting.

The Unit informs employees and job applicants of its EEO policies through its job postings, all of which include the statement "Station is an equal opportunity employer" or "EOE;" by stating on its employment application form that the employer is an equal opportunity employer; and through statements posted on the jobs section of the KDVR(TV)/KFCT(TV) and KWGN-TV websites. The Unit also disseminates its EEO policies by making postings on station bulletin boards and through its new-employee orientation program, which all new employees must attend. Once a candidate is hired, it is the hiring manager's responsibility to ensure that the employment environment complies with company policies, and to manage any problems arising thereunder.

- 6. <u>Analysis of EEO Recruitment Program.</u> Section 3(g) asks the Unit to describe its efforts to analyze its EEO recruitment program during the Reporting Period. Since December 27, 2013, the Unit has not analyzed its recruitment program, but it plans to do so annually in conjunction with the preparation of the annual EEO Public File Report in consultation with in-house legal counsel.
- 7. <u>Periodic Analysis of Internal Practices.</u> Section 3(h) of the Audit Letter asks Unit to describe its efforts to analyze its measures to examine pay, benefits, seniority practices, promotions and selection techniques and tests to ensure that they provide equal opportunity and do not have a discriminatory effect during the Reporting Period. Since December 27, 2013, the Unit has not undertaken any such analysis but plans to do so in accordance with Company-wide review initiatives undertaken in the ordinary course. The Unit does not have a union agreement.


