STANDARD BROADCAST STATION LICENSE

Subject to the provisions of the Communications Act of 1934, subsequent Acts, and Treaties, and Commission Rules made thereunder, and further subject to conditions set forth in this license, ¹the LICENSEE

MINN-IOWA RADIO, INC.

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for the term ending 3 a.m. Local Time APRIL 1, 1983

The licensee shall use and operate said apparatus only in accordance with the following terms:

- On a frequency of 1560 kHz.

ANTENNA: 281' (282' overall height) uniform cross section guyed, series excited vertical radiator with a 3-section FM broadcast antenna and a communications type antenna side-mounted near the top. Theoretical efficiency of 223 mV/m/kW is restricted to 180 mV/m/kW. Ground system consists of 120 equally spaced, buried, copper radials 150 to 200' in length.

This license shall not vest in the licensee any right to operate the station nor any right in the use of the frequency designated in the license beyond the term hereof, nor in any other manner than authorized herein. Neither the license nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This license is subject to the right of use or control by the Government of the United States conferred by Section 606 of the Communications Act of 1934.
