RESPONSE OF FOX TELEVISION STATIONS, INC. TO FCC LETTER OF INQUIRY

Station KMSP-TV File No. EB-06-IH-1749

Inquiries: Documents and Information to be Provided

State whether the Licensee broadcast the material described in the Complaint over the Station on March 18, 2006, at approximately 5:45 p.m. Provide a recording of the broadcast by DVD or a VHS videocassette tape (two copies), including the complained-of material plus the 15 minutes aired before and after it, and a written transcript of the recording.

Response

The Letter of Inquiry in this file, dated May 3, 2007 (the "LOI"), and addressed to WFTC(TV), Minneapolis, Minnesota, states: "Specifically, it is alleged that indecent material was aired during the Station's broadcast of the movie, 'Tomcats' on March 18, 2006 at approximately 5:45 p.m." There was one complaint attached to the LOI:

"Indecent scene of the movie shown on tv of a batchers party in which there were woman indecently dressed. Show near nude backsides of women who appear as strippers. Many women were very under dressed."

In response to the LOI, Fox Television Stations, Inc., the Licensee of WFTC(TV), states that the Station did not broadcast the movie, "Tomcats" on March 18, 2006.

However, KMSP-TV, Minneapolis is also licensed to Fox Television Stations, Inc. (the "Licensee"), and on March 18, 2006, from 4:00 to 6:00 p.m., KMSP did broadcast the movie, "Tomcats," which included a bachelor party scene. Accordingly, in a spirit of cooperation, the Licensee will respond to the LOI as if the complainant and the Commission had correctly identified the station. The Licensee has not retained an air-check tape from March 18, 2006. In order to respond to the Commission's request, the Licensee has obtained a copy of the requested movie segment from its distributor, Debmar-Mercury LLC. A declaration of the Co-President of Debmar-Mercury attached hereto serves as evidence that the tape being provided to the Commission with this Response is an accurate representation of the relevant section of "Tomcats" as it was furnished to KMSP for broadcast. KMSP broadcast the movie with a Parental Guideline Rating of "TV 14" (Parents Strongly Cautioned).

Analysis

The complainant was incorrect when she alleged that the "batchers party" (sic) scene in "Tomcats" is indecent. It may be sophomoric humor, but it is not indecent.

The Commisson's evaluation of indecency involves two determinations:

First, . . . the material must describe or depict sexual or excretory organs or activities. . . . Second, the broadcast must be *patently offensive* as measured by contemporary community standards for the broadcast medium.

The Commission has set forth three principal factors for evaluation: (1) the explicitness or graphic nature of the description or depiction of sexual or excretory organs or activities; (2) whether the material dwells on or repeats at length the descriptions or depictions; and (3) whether the material appears to pander or is used to titillate, or whether the material appears to have been presented for its shock value.

The bachelor party scene from "Tomcats" does not meet the Commission's indecency standard. The scene is critical to the development of the movie's plot. In it, Kyle is celebrating his "last hurrah" as a single man prior to his marriage to Natalie. Kyle's best friend, Jerry, is secretly in love with Natalie. Jerry is appalled when he hears Kyle brag that after his marriage he will still sleep with whomever he wants while Natalie is at home with the kids. Jerry decides to stop the wedding.

The scene contains no description or depiction of sexual or excretory organs or activities. At most, it contains only innuendo: e.g., "one last dip in the bachelor pool." The Commission has previously determined that innuendo is not indecent except where its sexual references are unmistakable or its sexual meaning is inescapable, which is clearly not the case here. There is no nudity in the scene: the men are fully clothed; the women are wearing nothing more revealing than swimsuits commonly worn at beaches and family pools across America. Possible sexual activities are only conveyed by allusion. It is left to the mind of the viewer to imagine the possible off-screen activities referred to in such ambiguous lines as: "You wouldn't believe what she can do with ping-pong balls," or "go in the bedroom and start warming up without me."

Even if the Commission were to find that the bachelor party scene describes or depicts sexual activities, it would still not meet the second part of the indecency standard: there is no explicit or graphic depiction of sexual activities; the scene is relatively brief and does not dwell on its suggestions of off-camera activities; and the scene is presented to further the plot of the movie and not for its shock value or to pander or titillate. There is adequate precedent to demonstrate that the Commission should not find this material to be indecent. Even within the single Omnibus Order, there are no fewer than four examples of similar material that the Commission found to be not indecent:

In re Industry Guidance on the Commission's Case Law Interpreting 18 U.S.C. § 1464 and Enforcement Policies Regarding Broadcast Indecency, 16 FCC Rcd 7999, ¶¶ 7-10 (2001) (emphasis in original) (citation omitted) ("Indecency Policy Statement").

Indecency Policy Statement, ¶ 14 (finding material indecent where "unmistakable sexual references remain that render the sexual meaning of the innuendo inescapable."); but see NBC Telemundo License Co., 19 FCC Rcd. 23025 (2004) ¶ 7 (finding "repeated use of sexual innuendo and double entendre" not patently offensive and therefore not indecent); and Complaints Regarding Various Television Broadcasts Between February 2, 2002 and March 8, 2005, 21 FCC Rcd. 2664 (2006) (the "Omnibus Order"), ¶ 202.

- 1. "Alias" (January 5, 2005), Omnibus Order, ¶¶ 147-52 (male and female characters in bed, kissing, caressing, and rubbing against each other with no display of sexual organs and no sexually graphic language).
- 2. "Two and a Half Men" (February 21, 2005), Omnibus Order, ¶¶ 160-62 (no nudity or depiction of a sexual organ or description of sexual organs or activities; viewers left to surmise what is happening).
- 3. "Golden Phoenix Hotel & Casino Commercial" (February 19, 2005), Omnibus Order, ¶¶ 166-72 (women in sexually suggestive casino show-style costumes jumping onto the bed of a fully clothed man without any actual display of sexual organs).
- 4. "The Simpsons" (September 9, 2004), Omnibus Order, ¶¶ 219-23 (female dancer at strip club shown from behind in a "thong," with no cartoon nudity or depictions of physical contact involving cartoon sexual organs).

Following a viewing of the tape provided herewith, an examination of the script, and a review of relevant precedent, the Commission should find that the scene that was the subject of the complaint is not indecent and that no further action is warranted.
