Today's show looks at what Hawaii needs to do to insure that another false alarm does not send the residents and guests of Hawaii into a panic.

A Hawaii employee who mistakenly sent an alert warning of an incoming ballistic missile earlier this month, creating panic across the state, thought an actual attack was imminent, federal regulators said Tuesday.

The revelation from the Federal Communications Commission is the first indication that the alert was purposely sent, adding another level of confusion to the Jan. 13 false alarm. State officials have only said it was sent in error.

The FCC said the state Emergency Management Agency has already taken steps to try to avoid a repeat of the false alert, requiring more supervision of drills and alert and test-alert transmissions. It has created a correction template for false alerts and has stopped ballistic missile defense drills until its own investigation is done.

We will take a look at the damage done on the island of Kaui from the massive rain storm. There is destruction to homes, businesses, roads, farms and just about everything on Kaui. The island of Kauai was hit with a devastating storm in mid-April, with rain reaching record highs on the north shore. The towns of Hanalei received 27 inches of rain and Wainiha received 20 inches of rain within 24 hours, causing landslides, flooding and destroying homes, and putting much of Hanalei under water.

Topic: Kilauea Volcano Disaster Aired: 5/13, 5/20, 6/10, 6/17/2018

On May 3, 2018, Kilauea volcano erupted and began flowing lava from the volcano down to the ocean, causing mass destruction to anything and everything in the way.

Lava from the Kilauea volcano on Hawaii's Big Island has expanded its flow in residential areas known as Four Corners and Kapoho Beach Lots.

The volcano has been erupting since May and over 600 homes, including Hawaii County Mayor Harry Kim's second home, have been destroyed.

Over the past week, the lava erupting from Hawaii's Kilauea volcano fissures advanced through two small residential subdivisions along Kapoho Bay, reaching the Pacific Ocean, and wiping out nearly a hundred homes. Geologists at the Hawaiian Volcano Observatory say that lava is consistently fountaining from Fissure 8, reaching heights up to 180 feet, feeding the flow. Civil defense officials saying that the lava has now filled in Kapoho Bay, "what used to be the bay is now all lava bed, new land, almost a mile out into the ocean."

Residents were urged to stay away from the areas and to remain cognizant of the fact that other breakouts are possible on the active flow field. Along with an update about the Fissure 8 activity, the Civil Defense message provided information about disaster relief programs and encouraged people to reach out if they are in need of help.
