RADIO STATION KVNN-AM, VICTORIA, TEXAS QUARTERLY ISSUES/PROGRAMS LIST 4th QUARTER - 2021

Listed below are some of the significant issues responded to by Radio Station KVNN-AM, along with the most significant programming treatment of those issues for the period October 1, 2021 to December 31, 2021. The listing is by no means exhaustive or all-inclusive. These issues were in part ascertained through discussions with service-providers and general interaction of station staff with the community, and staff knowledge of the community and area occurrences. The order in which the issues appear does not reflect any particular priority.

The following issues were principal topics or themes within the station's weekly public affairs program, "Issues Today" (IT), which is broadcast on Sunday Mornings at 7:00am. Each program has a normal running time (or length) in the range of 29 to 30 minutes. Each program is usually in two or three parts, each dealing with separate topics and issues.

Health/Big Government - 10/03/21 - IT - Interview with Lewis Grossman, Professor of History at American University, with a history of alternative medicines in the country, and about the policies of the FDA.

Youth/Health – 10/03/21 – IT – Interview with Dr. Carolyn Brooks, Senior Director of Clinical Capabilities, United Healthcare, with some tips for pregnant women on coping with COVID, and about the safety of vaccines.

Climate Change/Consumerism – 10/03/21 – IT – Interview with Bernie Staub, Improvement Expert, about roof safety and why yearly inspections are important, and about how solar installations affect roofs.

Education/Unemployment - 10/10/21 - IT - Interview with Arthur Levine, Former President of Teacher's College, about the future of higher education, and about current issues that many liberal arts colleges are facing.

Economy/Government Debt – 10/10/21 – IT – Interview with Greg Mennis, Director of Public Sector Retirement Systems at Pew, with a positive report on the state of public pension debt, and about the growing federal government deficit.

Crime/Gun Control – 10/10/21 – IT – Interview with Ashley Elliot, Victims' Rights Advocate, about the need for better victims rights, and about gun rights.

Crime/Big Government – 10/17/21 – IT – Interview with Erwin Chemerinsky, Dean of UC Berkeley School of Law, about Supreme Court decisions over the last few decades, and about the present makeup of the court.

Youth/Education – 10/17/21 – IT – Interview with Laura Linn Knight, Parenting Expert and Former School Teacher, about the anxiety that many kids are facing because of COVID, as well as some advice to parents on how to alleviate stress.

Youth/Public Safety – 10/17/21 – IT – Interview with Nadji Kirby, Senior Program Manager, Domestic Road Safety, Safe Kids Worldwide, about the dangers involved with railroad crossings, and about reasons why nobody should walk on tracks.

Economy/Inflation – 10/24/21 – IT – Interview with John Fenton, Supply Chain Expert, CEO of Patriot Rail, about why distribution routes have been compromised, and about shortages that will occur for the Christmas Holidays.

Communication/Crime – 10/24/21 – IT – Interview with Meaghan Murphy, Editor and Chief of Woman's Day, about the importance of strong neighborhoods, and about how a new app works to bring neighbors together.

Health/Communication – 10/24/21 – IT – Interview with Karyne Jones, President and CEO of NCBA, about the importance of pneumonia shots, especially in minority communities, and about the effects of COVID and other vaccinations.

Racism/Politics – 10/31/21 – IT – Interview with Claude Clegg, Professor of History at University of North Carolina, about the Obama Presidency, and about racism in that era.

Prescription Costs/Big Government – 10/31/21 – IT – Interview with Dan Leonard, President and CEO of Assn. For Access, BLE Medicines, about the growing price of prescription drugs, and about rules that could raise prices if certain government programs are passed.

Consumerism/Inflation – 10/31/21 – IT – Interview with Matt DiLorenzo, Senior Managing Editor of Kelley Blue Book, about why the auto market has been erratic, and about how consumers can save money. Vaccine Mandates/Big Government – 11/28/21 – IT – Interview with John Mahoney, Federal Employment Law Attorney, about the legality of vaccine mandates, and about at will employment.

Seniors/Stress – 11/28/21 – IT – Interview with Jill McNamara, Senior Director of CARE at Workforce.com, about senior loneliness as a result of COVID, and about ways seniors are dealing with stress. COVID/Health – 11/28/21 – IT – Interview with Colleen McDaniel,

Editor-In-Chief of Cruise Critic, about the current status of COVID cruising rules, and about rules for staff members.
