Second Quarter

Issue: Eating Disorders

April 1, 2019 We broadcast a discussion at 8:00 am for 25 minutes by author, Asheritah Ciuciu. She addressed eating disorders and offered women insight on how they can achieve and maintain a healthy relationship with food.

Issue: Children and Divorce

April 5, 2019 We ran a 30 minute interview at 9:30 am with Gregory Jantz, Ph.D., a licensed mental health expert and author addressing the raised concerns according to the American Psychological Association, that 48% of all marriages in the United States end in divorce. Dr. Greg Jantz discussed the idea of 'Parental Alienation', manipulation to hate, but also the healing these families can find.

Issue: Child Abuse

April 9 Family At 8:30 am, we carried a discussion with Joel Fitspatrick about the abuse he endured as a child. He discussed the feelings and confusion that accompanied his life and how he grew through it, redeeming those lost years. He discussed ways to prevent abuse and how to get help.

Issue: Sexually Transmitted Disease

April 22, 2019 We carried a discussion at 9:30 am with Dr. Joe McIlhaney, a board-certified OB/GYN and former General Medical Officer on the HIV/AIDS council. He covered topics of how parents need to be aware and involved of the sexual immorality that threatens their children. He addressed these growing issues that surround cohabitation, the threats of sexually transmitted infections, and why culture has normalized promiscuity.

Issue: Financial Setback

April 15, 2019 We carried a 25 minute interview at 8:00 am with Blogger Erin Odom. She described how she and her family's needs were met, and they made decisions to make changes, after a significant financial setback. She offered suggestions, encouragement, and ideas to listeners experiencing similar struggles in a discussion based on her book *More Than Just Making It: Hope for the Heart of the Financially Frustrated*.

Issue: Forgiveness

May 15, 2019 We broadcast a conversation at 9:30 am with author, Dr. R.T. Kendall about overcoming painful experiences and learning how to forgive and move forward.

Issue: Unexpected Tragedy

May 20, 2019 We played a conversation with Jonathan Pitts at 8:30 for 30 minutes. Predicated on a book he co-wrote with his wife, She suddenly and unexpectantly died. We discussed his family and how they navigated through unexpected tragedy.

Issue: Marital Conflict

May 21, 2019 We aired a discussion at 9:30 am between Dr. Scott Stanley, a research professor for Marital and Family Studies at the University of Denver and Dr. Gary Smalley of the Smalley Institute. Their topic was looking for warning signs in a marriage and techniques of how to cope with conflict and resolve issues without further damage to the relationship.

Issue: Teen Pregnancy

May 29, 2019 We carried an interview at 8:00am with Author and speaker Patricia Layton describes how she picked up her life and started over after a teen-aged pregnancy and abortion. She offered encouragement and hope to women who are struggling with similar pain.

Issue: Equality Legislation

June 3, 2019 We carried a conversation with Attorney Kelly Shackleford, President and CEO of the First Liberty Institute. Kelly discussed the Equality Act legislation, its intention, its status, and how it will interact with Religious liberty.

Issue: Anger Management

June 5, 2019 At 8:30 am, we ran a 30 minute presentation on how to get help with anger management. We discussed the problems that arise in a family as well as personal difficulties with someone who has a short temper. We discussed techniques as well as resources and places to go for both people who need help cooling their temperament as well as those who may be a victim of someone.

Issue: Wills and Probate

June 12, 2019 We carried a 30 minute presentation at 8:30am with a Financial planner about Wills and how to handle assets. They discussed courts, probate, family, stepfamilies and other issues that might arise when trying to decide how to disseminate assets after death.

Issue: Fathers' family roles

June 17, 2019 We ran a 30 minute presentation at 9:30 am by Dennis Swanberg who talked about how fathers guide and influence the lives of children, and how to improve it to be for the best.
