Political Advertiser Verification Guide

Political ads are defined as those representing elections, candidates or ballot measures. For political ad campaigns, there are additional verification steps that need to be taken to ensure transparency and compliance with online advertising guidelines. The application process can take several business days, so please be advised that you will need to build that into your campaign timeline for when to get started. These are all requirements that we need; we are unable to make any exceptions to the process, nor can we expedite it.

- **Not accepted:** A domain that verifies they are a legitimate candidate but is not directly associated with the candidate and their campaign

Political Verification

Provide one of the following forms of verification:

- Federal Election Commission ID (FEC ID) Recommended

Additional Guidelines (Please provide in a word document)

- General advocacy campaigns that do not mention any candidates do not require approval.
- If the candidate is representing **Maryland**, advertisers will be asked for brief descriptions of the audience and geographies that are being targeted.
- If the candidate is representing **New York**, advertisers will be asked to upload a copy of the independent expenditure committee's state registration certificate.
- If the candidate or ballot measure is representing the state of Washington, they will be prohibited from running ads. Federal races are still permitted to target Washington state with ads.

Political Verification FAQ

What is the difference between a federal and state election?

Federal elections include candidates running for federal office, including the president, the Senate and the House of Representatives. State elections include candidates running for state or local office, including but not limited to governor, state senator, mayor, freeholder, sheriff, etc.

What is a "paying entity?"

This is the entity that is ultimately paying for the political ad's display.

What is the "address of paying entity?"

This is how users can contact the paying entity. Please enter the mailing address of the advertiser's CEO, executive committee, board of directors or treasurer for the entity that is ultimately paying for the ad.

What is an "executive of paying entity?"

Please enter the name of the advertiser's CEO, executive committee, board of directors or treasurer for the entity that is ultimately paying for the ad.

What is the "title of executive?"

Please enter the role or official title of the advertiser's CEO, executive committee, board of directors or treasurer for the entity that is ultimately paying for the ad (for example, "Secretary-Treasurer").
