On April 24, 2023, pursuant to Public Notice DA: 23-232, "Enforcement Bureau Commences 2023 EEO Audits," several stations owned by Scripps Broadcasting Holdings, LLC ("Scripps") were randomly selected to participate in the FCC's April 2023 EEO audit process.
