On behalf of Citicasters Licenses, Inc., as debtor in possession, licensee of KBQI(FM), Albuquerque, NM (Fac ID# 4706) (the "Station"), I am writing to request an exemption from the requirements outlined in your February 14, 2019 letter based on the recent audit of the Station's EEO program. The Station is part of larger station employment unit based in Albuquerque, NM (the "SEU"), which also includes KABQ(AM), Albuquerque, New Mexico (Fac ID# 65394), KZRR(FM), Albuquerque, New Mexico (Fac ID# 68609), KPEK(FM), Albuquerque, New Mexico (Fac ID# 4704), KOLZ(FM), Corrales, New Mexico (Fac ID# 39265), and KTEG(FM), Santa Fe, New Mexico (Fac ID# 53652) (the "SEU"). The SEU submitted an audit response on May 30, 2018, which included its 2016 and 2017 EEO Public File Reports, both ending May 31.
