Dear NBA Member,

We are about to enter the second phase of the **EEO Scholarship Program for** 2023 & **2024**. Your participation in this program allows your SEU the opportunity to achieve a full EEO Credit.

As listed by the FCC in their EEO initiative, stations can achieve a full EEO credit "by participating in scholarship programs designed to assist students interested in pursuing a career in broadcasting."

Thanks to your two-year participation (which you have already paid for), the NBA Foundation will grant two, \$2,000 scholarships in 2024.

Attached are the **sample script** to be produced for airing on your stations from 1/1 - 2/29/24 and our new **NBA logos**. Applications are accepted only via the NBA website; please post this link on your website(s) on 1/1/24: https://ne-ba.org/eeo-college-scholarship-program/

Here is the timeline for this phase of the EEO Scholarship program:

Jan. 1 – Feb. 29, 2024: Air promos. SEU decides scheduling; you must run a schedule you feel will be acceptable to FCC in case of an audit.

Mar. 1, 2024: All applications must be received on the NBA website.

Mar. 13 – 25, 2024: Each SEU must review all applications (provided to you by NBA) and submit judging forms to the NBA office.

Apr. 3 – Apr. 10, 2024: Applicant pool narrowed to no more than five finalists based on SEU judging, pending final approval of the top two scoring applicants as winning recipients by the NBA Executive Committee.

Aug. 6-7, 2024: Scholarship winners recognized at NBA Convention.

The backup material for your participation (promo copy, affidavit, etc.) is required to be kept for the term of the station license and made available for FCC inspection if necessary. The only item that needs to go in your Online Public Inspection File is a brief description of participation in the program as one of the recruitment outreach initiatives. So, under the initiative "Participation in scholarship programs designed to assist students interested in pursuing a career in broadcasting," a station could simply say, "Participated in 2024 scholarship program of Nebraska Broadcasters Association."
