Susanna Janssen, language expert, newspaper columnist and the author of "Wordstruck!: The Fun and Fascination of Language"

Roughly 20% of American citizens are fluent in a second language. Ms. Janssen talked about the less obvious benefits of learning a second language, including enhanced abilities in focus and concentration, memory, interpersonal skills and problem-solving. She also noted that several recent studies have suggested that bilingualism may be a buffer against the development of Alzheimer's disease. She said bilinguals earn on average about 20% more than those who speak a single language.

The use of "study drugs"-- prescription medications used illegally by college students improve their academic performance--is on the rise. Dr. Rabiner said the drugs of choice are those typically used to treat ADHD. He discussed the question of whether the practice is a form of academic cheating. He added that students who use these medications without a prescription typically have higher rates of drug and alcohol abuse, perform worse academically and are more stressed out about their grades.

Michael Thompson, Director of the Council of State Governments Justice Center

Mr. Thompson's organization conducted a study that examined whether juveniles who commit crimes fare better if they are sentenced to community-based supervision or state-run incarceration. The study found that youth who are locked up in state-run facilities are 21 percent more likely to be rearrested than those who remain under supervision closer to home. He said that community supervision programs are also far less expensive for taxpayers than state-secure facilities.

Mark Underwood, PhD, neuroscience researcher, expert on brain aging and cognitive function, President and co-founder of Wisconsin-based biotech company Quincy Bioscience

She said many employers welcome it, because it allows the senior employee to mentor younger colleagues and the organization to retain institutional knowledge.

The Trust is a prepaid tuition plan that allows pre-purchase of tuition based on today's rates then paid out in the current rates when the beneficiary goes to college. A total of 208 announcements aired from April 4 to April 24, 2017.



SET WITH MET / WHAT IS MET? .

What is MET

MET is a 529 Prepaid Tuition Plan which allows for the pre-purchase of tuition based on today's rates and then paid out at the future cost when the beneficiary is in college. Performance is often based upon tuition inflation.

Peace of Mind for Parents

MET allows parents, grandparents, businesses and others to pre-purchase undergraduate tuition for a child residing in Michigan at any Michigan public university or college, including 28 public community colleges.

Portability - Out of State and Private Universities

Students may direct refund payments to any eligible university in the nation, both private and public.

Flexibility

Students have 15 years to use tuition benefits.

MET contracts may be purchased by semester, by year, or by credit hour.

MET offers payment plans over four, seven, 10, and 15 years.

Payroll deduction is offered through participating employers.

Transferable

Benefits may be transferred to a sibling or first cousin in the event the student receives a full scholarship or does not attend college.

Refundable

In the event the student does not wish to attend college, monies are refunded.

Tax Deductible

Total contract price can be deducted from state income tax. Prepaid tuition earnings are tax-exempt when benefits are used for higher education.

MET's Obligation

Under the contract, MET will pay future tuition and mandatory fees without additional charge. MET pays in-state tuition at public four-year colleges and universities in Michigan or in-district tuition at public community colleges in Michigan.

About Us — MVU focuses on the K-12 community

Michigan Virtual University[©] (MVU[©]) was established in 1998 by the State of Michigan. MVU is a private, nonprofit 501(c)(3) corporation and is governed by an independent Board of Directors comprised of individuals representing business, industry, higher education, K-12 education and state government.

MVU began to serve Michigan's K-12 community with online instructional services as a result of Public Act 230 of 2000. In 2005, the Michigan Virtual School[®] (MVS[®]) was awarded accreditation by the North Central Commission on Accreditation and School Improvement (NCA) and the Commission on International and Trans-Regional Accreditation (CITA). MVS was re-accredited in 2016.

In 2003, in partnership with the Michigan Department of Education, MVU created Michigan LearnPort®, a web-based portal that provides low-cost online professional development opportunities to Michigan's K-12 community, higher education and for organizations not directly affiliated with K-12 or higher education. In 2016, MVU updated the professional development portal and renamed it the Professional Learning Portal.



In 2012, MVU opened the Michigan Virtual Learning Research Institute™ (MVLR/™) which draws upon

recognized state and national leaders from K-12 schools, higher education and the private industry to provide research, evaluation, and development expertise that support Michigan's students, parents, schools, K-12 and postsecondary educators and state and local policymakers. In 2013, MVLRI received the 2013 iNACOL Innovator Award for Outstanding Research.

Strategic Decisions: A Framework for the Future

Last fall, MVU published Strategic Decisions: A Framework for the Future. This document serves as a strategic compass for Michigan Virtual University. Working with a group of internal and external stakeholders, we prepared this planning tool to help guide important decisions as we strive to better serve Michigan's K-12 community and policymakers as a trusted leader, partner, innovator and capacity builder. MVU Values

The state's health agency has partnered with several public and private organizations in the hopes of bringing up vaccination rates among children and adolescents in Michigan.

The Michigan Department of Health and Human Services announced a campaign Monday dubbed "I Vaccinate," which includes a website, social media and television public service ads encouraging parents with questions about vaccines to seek out more information.

The goal of the program is to raise awareness and eventually bring up vaccination rates among vulnerable populations, said Eden Wells, the chief medical executive of the Department of Health and Human Services.

"Michigan's low immunization rates threaten the health of all residents," she said. "Both here and nationally, we're seeing the unfortunate return of vaccine-preventable diseases because some parents are choosing not to vaccinate based on misinformation."

According to the 2015 National Immunization Survey, Michigan ranks 43rd in the U.S. for children ages 19 to 35 months, and data from the Michigan Care Improvement Registry shows 54 percent of children ages 19 to 35 months and 29 percent of teens aged 13 to 18 are fully up to date on vaccinations.

Officials also cited a series of 2016 chickenpox outbreaks in schools and child care centers in Michigan and a rise in whooping cough cases in Michigan in recent years as another big reason to address vaccinations.

WLAV aired announcements provided by the Michigan Association of Broadcasters and the Michigan Department of Health & Human Services Promoting the Michigan Tobacco Quitline and other services available to help Michigan residents quit smoking.

A total of 175 announcements aired from April 27 to May 31, 2017. The announcements were worth a total of \$30,625 in station inventory.


