Re: Retransmission Consent Election

Dear Mr. Abbott:

We are in receipt of your letters dated September 9 and September 16, 2016 providing notice that Citizens Telecom Services Company, LLC d/b/a Frontier Communications ("Frontier") intends to initiate a video service during 2016 in the following Designated Market Areas ("DMAs"): Wilkes-Barre-Scranton, Champaign-Urbana-Springfield-Decatur, Evansville, Davenport-Rock Island-Moline, Rockford and Terre Haute. Nexstar Broadcasting, Inc. ("Nexstar") is the licensee of television broadcast stations (the "Stations")

WBRE-TV, Wilkes-Barre, Pennsylvania, assigned to the Wilkes-Barre-Scranton DMA;
WCIA, Champaign, Illinois, assigned to the Champaign-Urbana-Springfield-Decatur DMA;
WCIX, Springfield, Illinois, assigned to the Champaign-Urbana-Springfield-Decatur DMA;
WEHT, Evansville, Indiana, assigned to the Evansville DMA;
WHBF-TV, Rock Island, Illinois, assigned to the Davenport-Rock Island-Moline DMA;
KGCW, Davenport, Iowa, assigned to the Davenport-Rock Island-Moline DMA;
WQRF-TV, Rockford, Illinois, assigned to the Rockford DMA; and
WTWO, Terre Haute, Indiana, assigned to the Terre Haute DMA.

Please be advised that Nexstar hereby invokes its rights pursuant to Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(a) of the FCC's rules, to bar retransmission of the Stations' signals by Frontier on its above-referenced systems except pursuant to our express written authority granted pursuant to a retransmission consent agreement between you and us. Pursuant to the terms of the retransmission consent agreement dated December 23, 2013 between Nexstar and Frontier, Nexstar hereby agrees to Frontier's retransmission, and the addition, of the Stations to Attachment B of the agreement through the expiration of the Term. Nexstar requests that, upon Frontier's launch of service in the referenced DMAs, Frontier provide a revised Attachment B to the undersigned.

This election is a continuing election from the date hereof through the initiation and provision of service by your systems. In addition, this election is made for each and every community or video service that Frontier intends to serve in the DMAs.
