DA Nancy O'Malley has declined to charge the Alameda County Sheriff's employees involved in Madrigal's death, copying and pasting text from a letter she issued also declining to charge officers involved in Dajuan Armstrong's death.

Wildfire Emergency			
	UpFront	08/20/20/7:08AM/2 hours	California wildfire stories: Farmworkers toil in smoke and heat; Cal Fire crews stretched thin battling 23 major fires; Smoke threatens recovery for Covid patients; Thousands evacuate - We spend the hour talking about the 300+ fires raging across California, including the major LNU Lightning Complex Fire and the CZU Lightning Complex Fire, and take calls from listeners. Thousands of people are under evacuation orders with guests: Tim Edwards is president of Cal Fire Local 2881, the state Cal Fire firefighters' union. He says crews are stretched thin and understaffed, and working ultra long shifts, putting more strain on their bodies and minds, and on their families. Dr. John Balmes, professor of Medicine at the University of California, San Francisco (UCSF) and professor of Environmental Health Sciences at the UC Berkeley School of Public Health, talks about respiratory health and wildfire smoke. Senator Bill Dodd represents California's Senate District 3, which includes parts of Napa, Contra Costa, Solano, Yolo and Sacramento counties. Gabriela Orantes is the Just Recovery Fellow with the North Bay Organizing Project. Christy Lubin is with the Graton Day Labor Center.
	UpFront	08.24.20/8:08AM/60 MIN	David King, a meteorologist with the National Weather Service, discusses potential wildfire risks from a new storm coming onshore in the Bay Area. "One lightning strike can start a new wildfire," he says — but adds that the Bay Area has largely avoided lightning from this storm, unlike last week when lightning strikes ignited devastated fires. Lenya Quinn-Davidson (@lenyaqd), the area fire advisor for the University of California Cooperative Extension and director of the Northern California Prescribed Fire Council, joins us to analyze the wildfires through the lens of forest ecology and explain how prescribed fires work. "We need to take action to create the conditions that would make us more resilient to fire, and make our forests and landscapes more in the state that they could accept fire and not have such catastrophic results," Lenya says. Otherwise, she says, major wildfires will become the new normal. The CZU Lightning Complex fires in Santa Cruz and San Mateo counties have forced thousands to evacuate. KPFA's Ariel Boone (@arielboone) and Lucy Kang (@ThisIsLucyKang) spoke to some of the evacuees — many of them from rural communities — at the Half Moon Bay High School evacuation center. We take calls from listeners impacted by the wildfires, and ask for input on the issues we should cover.

What is the effect of a 25-day smoke event on your lungs? The longer the exposure to poor air quality, the greater the risk of negative lung effects, says Dr. John Balmes, a professor of Medicine at the University of California, San Francisco (UCSF) and a Professor of Environmental Health Sciences at the UC Berkeley School of Public Health. He relays that older people and people with chronic lung disease do experience death as a result of prolonged PM 2.5 pollution exposure. Alleen Brown is a reporter for The Intercept.
