Re: Election of Retransmission Consent Status


Dear Frank:

Idaho Broadcasting, LLC, licensee of television station KPVI (NBC), KPVI (MyCW) licensed to Pocatello, ID DMA, pursuant to Section 76.64(f) of the rules and regulations of the Federal Communications Commission ("FCC"), hereby elects to invoke its right under Section 325(b) of the Communications Act of 1934, as amended, and Section 76.64(a) of the FCC's rules, to have the Stations' signals carried on Rodeo Networks, or its affiliated cable system(s) only with its express consent.
