I. Introduction and Summary

This application is one of several concurrently filed applications that seek the Commission's consent to the long form transfer of control of the radio and television broadcast licensees controlled by AP IX (PMC) VoteCo LLC ("VoteCo") arising from a proposed corporate reorganization (the "AGM Reorganization") of Apollo Global Management, Inc., a publicly traded for-profit Delaware corporation ("AGM"). The proposed AGM Reorganization concerns only AGM and does not involve any other change in the ownership, structure, management or business operations of VoteCo or any of its subsidiaries that hold or control Commission licensees (VoteCo and its subsidiaries are referred to herein as "CMG"). The Commission previously determined that AGM exercises *de facto* control over CMG; therefore, the applicants respectfully request Commission consent to the AGM Reorganization.¹

II. Description of the Transaction

Messrs. Marc Rowan, Joshua Harris, and Leon Black (the "Founders") presently jointly control AGM through Founder-controlled BRH Holdings GP, Ltd. ("BRH-GP"). The AGM Reorganization would result in the relinquishment of that control to the general public shareholders of an AGM successor corporation through the exchange of two special stock classes, with no new party gaining control. The proposed AGM Reorganization concerns only AGM and does not involve any other change in the ownership or structure of VoteCo or any of its subsidiaries that hold or control any Commission license.

As part of the AGM Reorganization and a separate merger transaction,² AGM would merge with a newly-created Delaware merger subsidiary of a newly created Delaware corporation, Tango Holdings, Inc. ("New AGM, Inc.").³ AGM would be the surviving entity of this merger. The Founders and public stockholders of AGM would receive common stock in New AGM, Inc. in exchange for their present common stock interests in AGM.⁴ As a result,

AGM would continue as a wholly owned subsidiary of New AGM, Inc., and New AGM, Inc. would become the successor corporation to AGM as the publicly traded ultimate parent entity in the ownership chain.

As of August 4, 2021, BRH-GP controls AGM on behalf of the Founders as a group via a special Class C share with voting rights constituting 83.1 percent of the voting rights of AGM on general stockholder matters, including the election of directors, and a special Class B share which gives BRH-GP 7.7 percent of the voting rights of AGM on general stockholder matters, including the election of directors. Under the AGM Reorganization, both the Class C share and the Class B share would be exchanged for Class A shares, with control relinquished to the public shareholders of AGM generally.⁵ Following consummation of the AGM Reorganization, the Founders are expected to separately hold in their own names directly and/or indirectly through entities each may separately control, in the aggregate, up to a maximum of 37.6 percent of the voting rights in New AGM, Inc.⁶

Foreign Ownership Compliance

AGM and New AGM, Inc., as the proposed successor entity to AGM, are permitted to have up to 100% foreign ownership and 100% foreign control,⁷ subject to conditions to seek prior approval for any additional foreign investor that would acquire more than five percent of equity or voting rights.⁸ As an “affiliate” of Terrier Media Buyer, Inc., under Section 1.5000(d)(2) of the Commission’s rules, New AGM, Inc., which will wholly own AGM, is relying upon the previously issued Declaratory Ruling for its compliance with Section 310(b)(4) currently and will continue to do so going forward. Accordingly, Question Five under Transferee Alien Ownership is answered “Yes.” As of the filing of this application and as a result of BRH-GP being a foreign entity, AGM is above the 25% benchmark in Section 310(b)(4) as permitted by the Declaratory Ruling. Upon the closing of the AGM Reorganization, AGM expects that the foreign ownership in New AGM, Inc. will be below the 25% benchmark in Section 310(b)(4) and that BRH-GP will not own or control any shares in New AGM, Inc.

Control of the FCC licensees, as listed in Attachment 1, and other subsidiaries of VoteCo, remains unchanged since the closing of the previous internal reorganization on June 5, 2020.

IV. Transaction Documents

The parties are submitting with this application a copy of the Governance Term Sheet, which will govern the AGM Reorganization:

Governance Term Sheet, dated March 8, 2021, setting forth the principal governance terms for New AGM, Inc., subject to approval by the Conflicts Committee of the Board of Directors of New AGM, Inc. and receipt of required regulatory approvals and stockholder votes.¹⁴

There are other documents and agreements, some of which are not yet finalized, that have been or will be created in connection with the implementation of the AGM Reorganization. Except for the Governance Term Sheet provided with this application, however, these documents would not provide information relevant to the processing of this application that is not already included in the exhibits and attachments hereto and they would

not be germane to the Commission's consideration of this application.¹⁵

V. National and Local Television Ownership Compliance

As demonstrated in Attachment 3, the AGM Reorganization complies with the Commission's National Television Multiple Ownership Rule. The national television audience reach cap limits entities from owning or controlling television stations that, in the aggregate, reach more than 39 percent of the television households in the country after taking into account a 50 percent discount for UHF stations.¹⁶ New AGM, Inc. would not currently hold an attributable interest in any broadcast television station other than the stations that are the subject of the instant applications, and New AGM, Inc. is not now proposing to acquire any additional broadcast television stations. Following consummation of the AGM Reorganization, New AGM, Inc. will continue to have a national audience reach of just 12.9830% without giving effect to the UHF Discount.¹⁷

The AGM Reorganization also complies with the Commission's Local Television Multiple Ownership Rule.¹⁸ Under this rule, an entity may own, operate, or control two television stations licensed in the same Designated Market Area ("DMA") if at the time the application to acquire or construct the station(s) is filed, at least one of the stations is not ranked among the top four stations in the DMA.¹⁹ New AGM, Inc. is not proposing to create any new duopoly markets.

There are only three DMAs where CMG will continue to own or control two television stations licensed in the same DMA, and in each of those DMAs at least one of the stations is not ranked among the top four stations in the DMA. In the Charlotte DMA, WSOC-TV is ranked second and WAXN-TV is ranked fifth; in the Orlando-Daytona Beach-Melbourne DMA, WFTV is ranked first and WRDQ is ranked seventh; and in the Tulsa DMA, KOKI-TV is ranked second and KMYT-TV is ranked seventh. Accordingly, the AGM Reorganization complies with the Commission's Local Television Multiple Ownership Rule, because in each of these DMAs, there will be at most one top-four television station transferred as a result of the AGM Reorganization.²⁰

Separately, in the Jacksonville, Florida, market, CMG owns station WFOX-TV and

provides certain joint sales and shared services to independently-owned station WJAX-TV, licensed to Hoffman Communications, Inc. In the Yuma-El Centro DMA, CMG is a party to shared services agreements with independently-owned station KECY-TV, licensed to NPG of Yuma-El Centro, LLC (“NPG”) through which NPG provides certain services to CMG’s KYMA-TV. In the Greenwood-Greenville DMA, CMG owns station WABG-TV and provides certain shared services to independently-owned station WFXW(TV), licensed to Radiant Life Ministries, Inc. These relationships will remain in place after the closing and the parties are not seeking any modification to any of them.²¹

VI. Local Radio Ownership Compliance²²

Under Section 73.3555(a)(1) of the Commission’s rules, the Commission uses a tiered approach, as described below, to determine whether a combination of commonly-owned radio stations comply with the local radio ownership limits for any particular market.²³

Nielsen Audio Metro Methodology: When more than one commonly-owned radio station is licensed to a community within a Nielsen Audio Metro, the Commission counts the number of commercial and noncommercial radio stations that are either “home” to that Metro area or are licensed to a community within geographic boundaries of that Metro (the “Nielsen Audio Metro Methodology”).²⁴

2. Contour Methodology: For combinations that are licensed to communities that are not home to any Nielsen Audio Metro, the Commission defines the market as the area where the principal community contours of the commonly-owned stations overlap. To determine the number of stations in that market, the Commission counts all stations whose principal community contours overlap that of at least one of the commonly-owned stations. The Commission, however, excludes each station whose transmitter is greater than 92 kilometers from the mutual overlap area and each commonly-owned station that is not included already in the market (the “Contour Methodology”).²⁵

3. Nielsen Contour Hybrid Methodology: The Commission requires an analysis under both the Nielsen Audio Metro Methodology and the Contour Methodology in two situations: (a) if at least one of the commonly-owned stations is “home” to a Nielsen Audio Metro but it is licensed to a community outside that Metro or (b) if a station is licensed to a community within a Nielsen Audio Metro but its principal community contour overlaps that of another commonly-owned station that is not licensed to a community within any Nielsen Audio Metro.²⁶

The AGM Reorganization will not create any new radio combination and CMG’s radio station holdings will continue to comply with the Commission’s Local Radio Ownership Rule. Below is a market-by-market analysis of CMG’s radio station interests. In each of those markets, the AGM Reorganization complies with the Commission’s Local Radio Ownership Rule without the need for any waiver or divestiture.²⁷

Athens, Georgia

The Commission requires the submission of a contour overlap analysis to demonstrate compliance with the Commission’s Local Radio Ownership Rule for stations that are licensed to communities outside of a Nielsen Audio Metro. As described in the attached contour-based analysis prepared by W. Jeffrey Reynolds of du Treil, Lundin & Rackley, Inc., the AGM Reorganization complies with the Commission’s rules. In each of the defined radio markets created using the contour overlap analysis, there are no less than 86 radio stations. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in six commercial radio stations in the Athens, GA market (2 AM stations and 4 FM stations), which is permitted under the Commission’s Local Radio Ownership Rule.

Atlanta, Georgia

As shown in the attached BIA FCC Geographic Market Definition report for Atlanta,

GA, there are 85 commercial and noncommercial radio stations that are home to the Atlanta, GA Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in five commercial radio stations (1 AM station and 4 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

Dayton, Ohio

As shown in the attached BIA FCC Geographic Market Definition report for Dayton, OH, there are 38 commercial and noncommercial radio stations that are home to the Dayton, OH Nielsen Audio Metro. Therefore, common ownership of seven radio stations, no more than four in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in four commercial radio stations (1 AM station and 3 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

Houston, Texas

As shown in the attached BIA FCC Geographic Market Definition report for Houston, TX, there are 78 commercial and noncommercial radio stations that are home to the Houston, TX Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in four commercial FM radio stations, which is permitted under the Commission's Local Radio Ownership Rule.

Jacksonville, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Jacksonville, FL, there are 45 commercial and noncommercial radio stations that are home to the Jacksonville, FL Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in six commercial radio stations (1 AM station and 5 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

Miami, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Miami, FL, there are 61 commercial and noncommercial radio stations that are home to the Miami, FL Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in four commercial FM radio stations, which is permitted under the Commission's Local Radio Ownership Rule.

Nassau-Suffolk, New York

As shown in the attached BIA FCC Geographic Market Definition report for Nassau-Suffolk, NY, there are 46 commercial and noncommercial radio stations that are home to the Nassau-Suffolk, NY Nielsen Audio Metro. Therefore, common ownership of eight radio

stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in three commercial FM radio stations, which is permitted under the Commission's Local Radio Ownership Rule.

Orlando, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Orlando, FL, there are 40 commercial and noncommercial radio stations that are home to the Orlando, FL Nielsen Audio Metro. Therefore, common ownership of seven radio stations, no more than four in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in 5 commercial radio stations (1 AM station and 4 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

San Antonio, Texas

As shown in the attached BIA FCC Geographic Market Definition report for San Antonio, TX, there are 61 commercial and noncommercial radio stations that are home to the San Antonio, TX Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in seven commercial radio stations (2 AM stations and 5 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

Tampa, Florida

As shown in the attached BIA FCC Geographic Market Definition report for Tampa, FL, there are 48 commercial and noncommercial radio stations that are home to the Tampa, FL Nielsen Audio Metro. Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in 5 commercial FM radio stations, which is permitted under the Commission's Local Radio Ownership Rule.

Tulsa, Oklahoma

As shown in the attached BIA FCC Geographic Market Definition report for Tulsa, OK, there are 41 commercial and noncommercial radio stations that are home to the Tulsa, OK Nielsen Audio Metro. Therefore, common ownership of seven radio stations, no more than four in the same service, is permitted. Upon consummation of the AGM Reorganization, New AGM, Inc. will have an attributable interest in five commercial radio stations (1 AM station and 4 FM stations), which is permitted under the Commission's Local Radio Ownership Rule.

VII. Pending Applications and Cut-Off Rules

One or more of the broadcast television and radio stations owned by CMG may have a renewal application pending before the Commission during the time that the instant transfer applications are pending. Consistent with the Commission's policy permitting consummation of a multi-station transfer of control overlapping with a renewal cycle, New AGM, Inc. hereby assents to succeeding to the place of AGM for any pending renewal application for those broadcast television and radio stations over which New AGM, Inc. will acquire control as a result of the AGM Reorganization.²⁸

AGM and New AGM, Inc. are filing applications requesting Commission consent to a transfer of certain Media Bureau, International Bureau and Wireless Bureau licenses. The licensees identified in those applications (the "CMG Licensees") may now have on file, and may hereafter file, requests for authorizations for new or modified facilities that may be granted before the Commission takes action on the transfer of control applications. Accordingly, AGM and New AGM, Inc. request that Commission approval of the instant applications include (A) any authorization issued to any of the CMG Licensees while the applications are pending before the Commission and during the period required for consummation of the transaction, and (B) any applications filed by any of the CMG Licensees that are pending at the time of consummation. Inclusion of authorizations issued while the transaction is pending and during the consummation period, and applications pending at the time of consummation, are consistent with prior Commission decisions.

Pursuant to Sections 1.927(h), 1.929(a)(2), and 1.933(b) of the Commission's Rules, to the extent necessary, New AGM, Inc. requests a blanket exemption from any applicable cut-off rules in cases where New AGM, Inc. files amendments to pending applications in order to reflect consummation of the proposed AGM Reorganization so that such amendments are not treated as disqualifying amendments. The proposed AGM Reorganization is not undertaken for the purpose of acquiring any particular pending application, but instead is part of a larger transaction undertaken for an independent and legitimate business purpose. Grant of this request would be consistent with prior Commission decisions that routinely have granted a blanket exemption in cases involving multiple-license transactions.²⁹

Governance Term Sheet

March 8, 2021

This term sheet summarizes the principal governance terms agreed to by Leon Black, Marc Rowan, Joshua Harris (collectively, the “**Principals**”) and Apollo Global Management, Inc. (together with its subsidiaries, “**Apollo**”), to be implemented as set forth below, subject to approval of such implementation by the Conflicts Committee of the Board of Directors of Apollo (the “**Board**”) and receipt of required regulatory approvals and stockholder votes.

Certain agreements described in this term sheet (e.g., the agreement by Apollo to nominate certain person to the Board) will be implemented, as appropriate, through a Stockholders Agreement, by and among the Principals and Apollo, while other agreements (e.g., voting agreements among the Principals) may, as appropriate, be set forth in a separate Voting Agreement, by and among the Principals.

**1. Principal
Directorships:**

Each Principal will be entitled to be nominated by Apollo to a seat on the Board as long as such Principal's family group beneficially owns at least \$400 million in value or 10 million in number of Apollo common shares (or their equivalent) (the "**Ownership Threshold**").

Subject to the Ownership Threshold, each Principal, or upon his death or disability, his estate or successor, may designate, in lieu of himself, an individual reasonably acceptable to the Nom/Gov Committee (as defined below), to be nominated to the Board (each, a "**Principal Nominee**"). Such right shall continue so long as the Principal's family group satisfies the Ownership Threshold.

Each Principal's right to be nominated for a Board seat or designate a Principal Nominee will be provided for in a Stockholders Agreement among the Principals and Apollo (see below).

2. Board:

Composition. The Board will initially consist of:

- 9 independent directors, nominated by the existing Apollo executive committee, who shall initially be:
 - Michael Ducey;
 - Pamela Joyner;
 - Robert Kraft;
 - A.B. Krongard;
 - Siddhartha Mukherjee;

- Pauline Richards; and
- Three additional independent directors previously identified by the Principals.¹
- Jay Clayton, who shall serve as the initial Lead Independent Director;
- 3 Principals, with Leon Black to serve as Chairman of the Board; and
- James Zelter and Scott Kleinman.

Each director shall serve a 1-year term and shall be subject to reelection at the annual meeting of Apollo. Directors other than Principals (or Principal Nominees) to be recommended by the Nom/Gov Committee and nominated by the Board. (Directors appointed to the Board after January 1, 2021 will be nominated for reelection at the 2021 annual meeting of stockholders.)

If the Board size is increased (or decreased), the Board will use reasonable best efforts to ensure at least 2/3 of the Board is independent.

In the event that Apollo (or one of its affiliates) consummates the merger transaction known as Project Tango (“**Project Tango**”), a number of additional directors from the counterparty to such transaction shall also serve on the Board (each such director, a “**Tango Director**”).

Nominating & Governance Committee. A Nominating & Governance Committee (“**Nom/Gov Committee**”), comprised of 3 or more independent directors, will determine re-nominations and fill vacancies. The initial size and membership of the Nom/Gov Committee will be proposed by the Current Executive Committee (as defined below).

Thereafter, the membership, size and chairperson of the Nom/Gov Committee shall be determined by the full Board.

All independent directors (including the initial independent directors) must qualify as “independent” pursuant to applicable stock exchange listing requirements and any applicable legal requirements.

The Nom/Gov Committee will meet with the Principals from time to time to consider Board nominees they may suggest, and to discuss other potential candidates and obtain feedback.

Other Board Committees/Committee Charters. The Board will form other committees, in compliance with stock exchange listing requirements and any other applicable legal requirements, and including, initially, an Audit Committee, a Compensation Committee, and, as noted above, a Nom/Gov Committee, as well as the Board EC (as defined below) and such other committees as the Board determines to be necessary and advisable from time to time.

Committee membership shall be limited to independent directors, except in the case of the Board EC and any other committees to which stock exchange or other independence requirements do not apply. The Nom/Gov Committee may recommend to the Board additional committees.

All committee charters shall be consistent with best practices.

Lead Independent Director. The Board will designate, subject to consultation with and approval by the remaining independent directors, a Lead Independent Director at the start of each annual term, whose responsibilities shall include, among others, maintaining dialogue with the Principals, chairing executive sessions of the Board and engaging with Apollo's stockholders and other stakeholders, as appropriate.

The initial Lead Independent Director shall be Jay Clayton.

**3. Board
Executive
Committee
(the "Board
EC"):**

Purpose. The Board EC shall be a committee of the Board, with such duties as delegated to it by the Board, and responsible generally for managing the affairs of the Board between its meetings, and providing guidance to senior management and recommendations to the Board of Apollo regarding its strategic, financial and operating plans and performance, and key employment decisions, in each case, consistent with and subject to applicable law and securities regulations and the fiduciary duties of the Board.

Decisions of the Board EC shall be determined by a simple majority vote. In the event the Board EC is deadlocked, the full Board may consider and decide such matter. At each meeting of the Board, the Board EC shall deliver a report as to any actions or decisions taken by the Board EC in the period since the last such report was delivered to the Board.

Composition. The voting members of the Board EC for the first year of its existence shall be:

- 3 Principals; and
- Jay Clayton (Chair).

In addition, James Zelter, Scott Kleinman and Gary Parr will be non- voting observers on the Board EC for the first year of its existence.

In the event that Apollo (or one of its affiliates) consummates Project Tango, one Tango Director (as designated by the counterparty to Project Tango) shall also be a non-voting observer on the Board EC until the end of the first year of its existence.

Each Principal shall use commercially reasonable efforts, consistent with his fiduciary duties, to ensure that each of the Principals is re- elected to the Board EC.

Thereafter, the Board EC shall have no more than 7 voting members (including the Principals so long as they satisfy the Ownership Threshold), with the specific size determined by the Board.

Timing. The Board EC shall be implemented (and the AAP Executive Committee and the Current Executive Committee (as defined below) terminated) upon the consummation of Project Tango or, if earlier, March 31, 2022.

**4. One Share,
One Vote
(and Class
C Share):**

The Principals hereby agree to convert the Class B share into shares of preferred stock (the “**Preferred Stock**”) equal in number and votes to the number of AOG units outstanding from time to time, and which shall then become exchangeable with the related AOG unit for shares of Class A common stock. This conversion will occur as promptly as reasonably practicable following receipt of required approvals.

Each holder of AOG units (each, an “**AOG Unit Owner**”) will have the option, at any time, to exchange its beneficially owned AOG units for Apollo common stock and sell such Apollo common stock in accordance with the agreed terms of the conversion and exchange and Apollo’s trading policy.

On or immediately prior to a date prior to June 30, 2022 to be designated by the Company, which date shall be coincident with the consummation of Project Tango (such date, the “**Mandatory Exchange Date**”), a wholly-owned subsidiary of a newly formed holding company (“**NewCo**”) will merge with and into Apollo, with Apollo surviving.

All holders of Apollo Class A common stock will receive on a tax-free basis an equal number of shares of NewCo Class A common stock and such holders will cease to own interests in Apollo. If Project Tango shall not have been consummated by June 30, 2022, then the Mandatory Exchange Date shall be June 30, 2022; provided, however, that in the event that, as of June 30, 2022, (i) a transaction agreement with respect to Project Tango has been executed and delivered and has not been terminated and (ii) Project Tango has not been consummated, then the

Mandatory Exchange Date shall be the earlier of (x) the date on which Project Tango is consummated and (y) the date on which such transaction agreement is terminated.

On the Mandatory Exchange Date, all AOG units beneficially owned by each of the AOG Unit Owners (other than Athene Holdings Ltd. (“**Athene**”)) shall be transferred to NewCo and one or more of its affiliates in a series of transactions in exchange for (i) such number of shares of NewCo Class A common stock equal to the aggregate number of AOG units beneficially owned by the AOG Unit Owners (other than Athene) as of immediately prior to the Mandatory Exchange (such units, the “**Outstanding AOG Units**”) and (ii) an aggregate amount in cash equal to the *product of* (a) the number of Outstanding AOG Units *multiplied by* (b) \$3.66, payable over a period of four years in equal quarterly installments (the “**AOG Unit Payment**”); provided, however, that in the event that the Company consummates Project Tango simultaneously with the Mandatory Exchange, the AOG Unit Payment shall be payable over the period between the date on which Project Tango is consummated and the third anniversary of the Mandatory Exchange Date in equal quarterly installments (such transactions collectively, the “**Mandatory Exchange**”). The obligation to make the AOG Unit Payment will be an unsecured obligation of APO, subordinated in right of payment to indebtedness and any preferred stock of NewCo and its subsidiaries, and will not bear interest. The foregoing transactions are intended to be generally tax-free with respect to the NewCo Class A common stock received.

The parties hereto agree to work in good faith to modify any of the steps set forth in the foregoing paragraph necessary to (x) achieve efficiencies (including with respect to the taxes of the parties) or (y) consummate Project Tango; provided, however, that in no event will the amount of cash to be paid or the number of shares of Newco stock to be issued to AOG Unit Holders be increased beyond the amount or number set forth in the foregoing paragraph; and provided, further, that (i) no Principal shall incur any additional tax or other costs in connection with any such modifications and (ii) any changes would be *pro rata* as to each Principal.

The Tax Receivables Agreement currently in effect shall be not be applicable to the Mandatory Exchange, but shall remain in effect for any exchanges occurring prior to the Mandatory Exchange Date.

At the time the Preferred Stock is issued, the Principals will cause the surrender of the Class C share to Apollo.

No change in the voting structure (including relinquishment of the Class C share) will occur prior to the time the parties agree and enter into the Stockholders Agreement (as defined below).

5. Stockholders Agreement:

The Principals, their relevant respective holding entities and Apollo shall enter into a stockholders agreement (the “**Stockholders Agreement**”) and/or a voting agreement (the “**Voting Agreement**”), providing that, consistent with and subject to applicable law and securities regulations and the fiduciary duties of the Board:

- Apollo shall nominate each of the Principals (or Principal Nominees, as applicable) as part of the Board’s director slate for so long as such Principal meets the Ownership Threshold;
- A Principal or Principal Nominee, as applicable, shall resign from the Board in the event that such Principal no longer meets the Ownership Threshold;
- Each Principal, on behalf of his family group, agrees to vote all of his respective Apollo shares in favor of the election of the other Principals (or Principal Nominees, as applicable);
- Apollo shall recommend that stockholders vote in favor of the Principals (or Principal Nominees, as applicable) and Apollo shall otherwise take reasonable action to support their nomination and election (including by filling vacancies on the Board, if necessary);
- As described above, each Principal shall be entitled to a seat on the Board EC until he no longer serves on the Board (and shall be entitled to continue to serve on the Current Executive Committee until such time as he is appointed to the Board EC);
- The Company shall not make any *non-pro rata* distributions or payments to any Principals without the consent of the other Principals;
- Each Principal and Apollo shall agree not to take actions inconsistent with the terms of the Stockholders Agreement or in a manner that is discriminatory as to one or more of the Principals, and to oppose any such actions if proposed by others; and
- Customary confidentiality provisions consistent with the confidentiality provisions contained in the Agreement Among Principals.

Each Principal will have information rights regarding Apollo’s business, so long as such Principal meets an ownership threshold to be agreed

upon by the parties hereto (which threshold shall be approximately 50% of the Ownership Threshold).

The Principals will be entitled to office/administrative and logistics support, so long as the Principal continues to provide services (as a co-founder or otherwise) to Apollo or serves on the Board EC or serves as a chair on any Board committee.

The Company will reimburse each Principal for such Principal's reasonable third-party fees and expenses incurred in connection with negotiating and implementing this term sheet and the related agreements.

The Stockholders Agreement will be entered into and will become effective when the recapitalization (as described below) is implemented and the Class C share surrendered.

Notwithstanding anything to the contrary herein, if necessary to support compliance with Section 13 and Section 16 of the Securities Exchange Act of 1934, as amended, and related rules and regulations, the agreements that would otherwise be set forth in the Stockholders Agreement and/or the Voting Agreement, may, in lieu of the Stockholders Agreement or Voting Agreement, be set forth in a separate stockholder agreement for each Principal, to be entered into by such Principal and Apollo.

**6. Transition to
New
Governance
Structure:**

Certain of the agreements set forth in this term sheet, including implementation of the new Board governance structure, elimination of the Class C share, implementation of the One Share, One Vote structure, creation and issuance of the Preferred Stock, elimination of the Executive Committee as currently constituted by Apollo's certificate of incorporation (the "**Current Executive Committee**") and the amendment of the certificate of incorporation, bylaws and other governing documents of the Company (if any) as required to implement the foregoing, will require the approval of the Current Executive Committee. The Principals, as the only voting members of the Current Executive Committee, will vote to approve such agreements.

The implementation of the agreements set forth in this term sheet will be subject to receipt of required regulatory approvals and stockholder votes, which may take up to nine months to obtain. The Principals and Apollo will endeavor to implement such agreements in an expeditious manner, but in no event later than the Mandatory Exchange Date.

The Current Executive Committee will continue to operate as it does at the time of this term sheet until the earlier of (x) the Mandatory Exchange Date and (y) March 31, 2022; provided, however, that the

Current Executive Committee shall not take any major decisions (i) that are inconsistent with this term sheet and (ii) without first consulting with and seeking the advice of the Board. Subject to the foregoing, the Principals agree that the Current Executive Committee will continue to operate in a manner consistent with past practice until terminated.

7. Employment Matters:

Employment agreement to be entered into with one of the Principals in the form agreed on the date hereof.

8. Miscellaneous:

Principals and Apollo, as applicable, will enter into other documentation necessary to preserve exchange rights (prior to Mandatory Exchange Date) and registration rights including on a pass-through basis and to provide for the orderly maintenance of AP Professional, BRH Holdings GP, Ltd. and BRH Holdings, L.P. until the Mandatory Exchange Date.

Each of the Principals agrees that such Principal shall use reasonable best efforts to take, or cause to be taken, all actions necessary, proper or advisable to give effect to the agreements of the parties hereunder, including by executing and delivering such additional documents as may be reasonably necessary or appropriate to effectuate the agreements set forth in this term sheet.

The principal community contours of all of these stations are depicted on a map included herein as Figure 1. The radio multiple ownership analysis considers only those stations with overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations). An ownership study was prepared in accordance with the Federal Communications Commission multiple ownership rules as outlined in Section 73.3555.

Radio Markets

The “radio market” applicable to common ownership of the subject stations is defined as the area encompassed by the mutually overlapping principal community contours of the stations proposed to be commonly owned. Count of Stations in Defined Markets

The number of radio stations in a “radio market” is determined by counting the operating stations that have principal community contours that intersect the principal community contours that define the radio market. Only those stations located within 92 km of the perimeter of the mutual overlap area of the defined market area were employed in the count of stations. Commonly owned stations, other than those that form the market in question were not considered in the count of stations in the defined market. The results of the analysis are tabulated below:

Tabulations and maps of the radio stations identified in the defined radio market are included with this statement. Only known licensed, operating stations were employed for the study. Distances to the AM coverage contours were predicted using the antenna patterns as identified in the Commission's AM database and the appropriate Ground Wave Field Strength versus Distance Graph described in Section 73.184 of the FCC Rules. Ground conductivity data were obtained from FCC Figure M3. Distances to the FM contours were determined based on the method outlined in Section 73.313 of the FCC Rules. Terrain data were derived from the U.S.G.S. 1-second terrain database for each of the FM stations using radials evenly-spaced every 5 degrees of azimuth.

Based on the above, it is concluded that the proposed combination of the stations to be owned complies with Section 73.3555(a) of the FCC Rules.

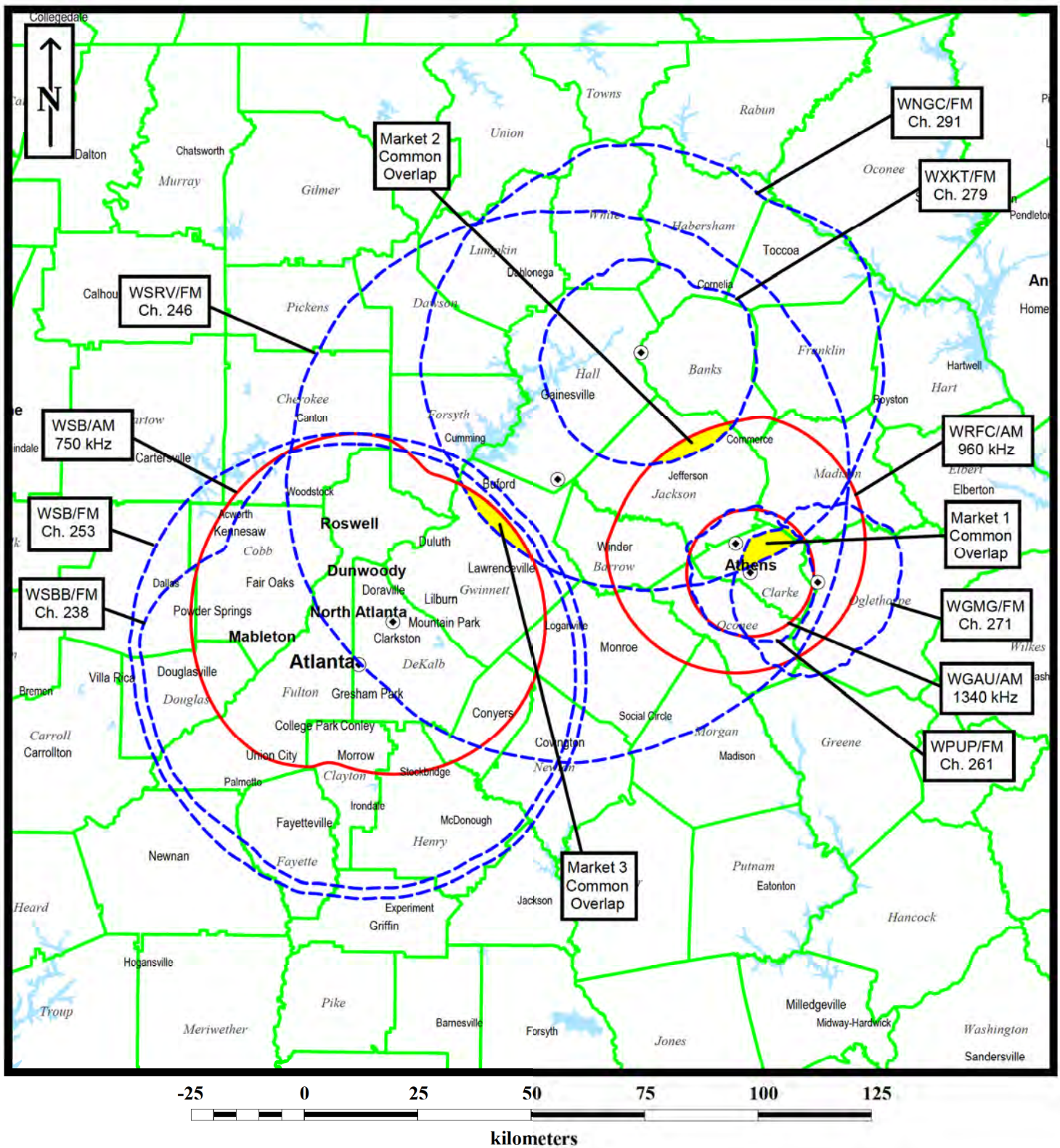

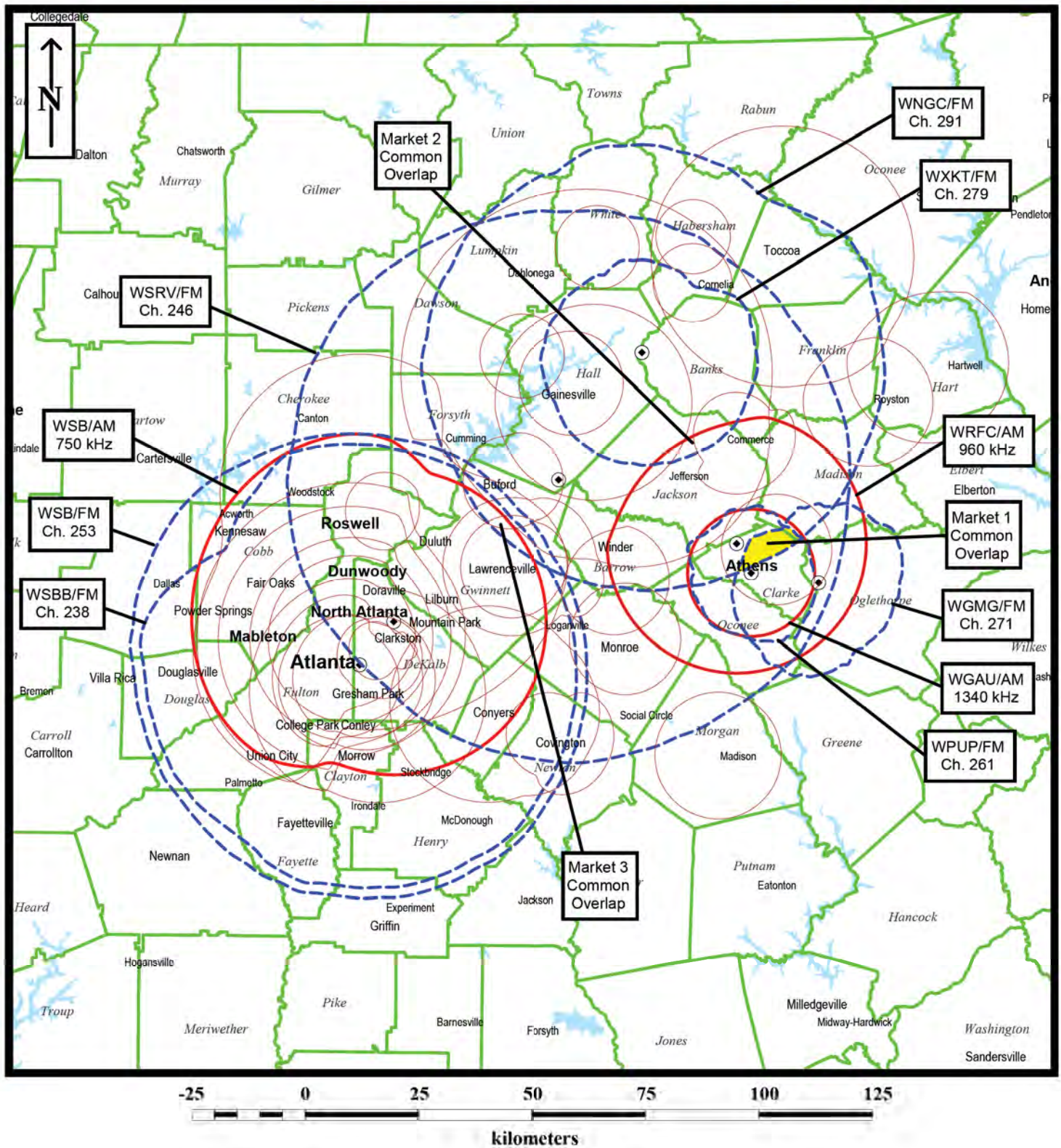
PREDICTED PRINCIPAL COMMUNITY CONTOURS OF SUBJECT STATIONS

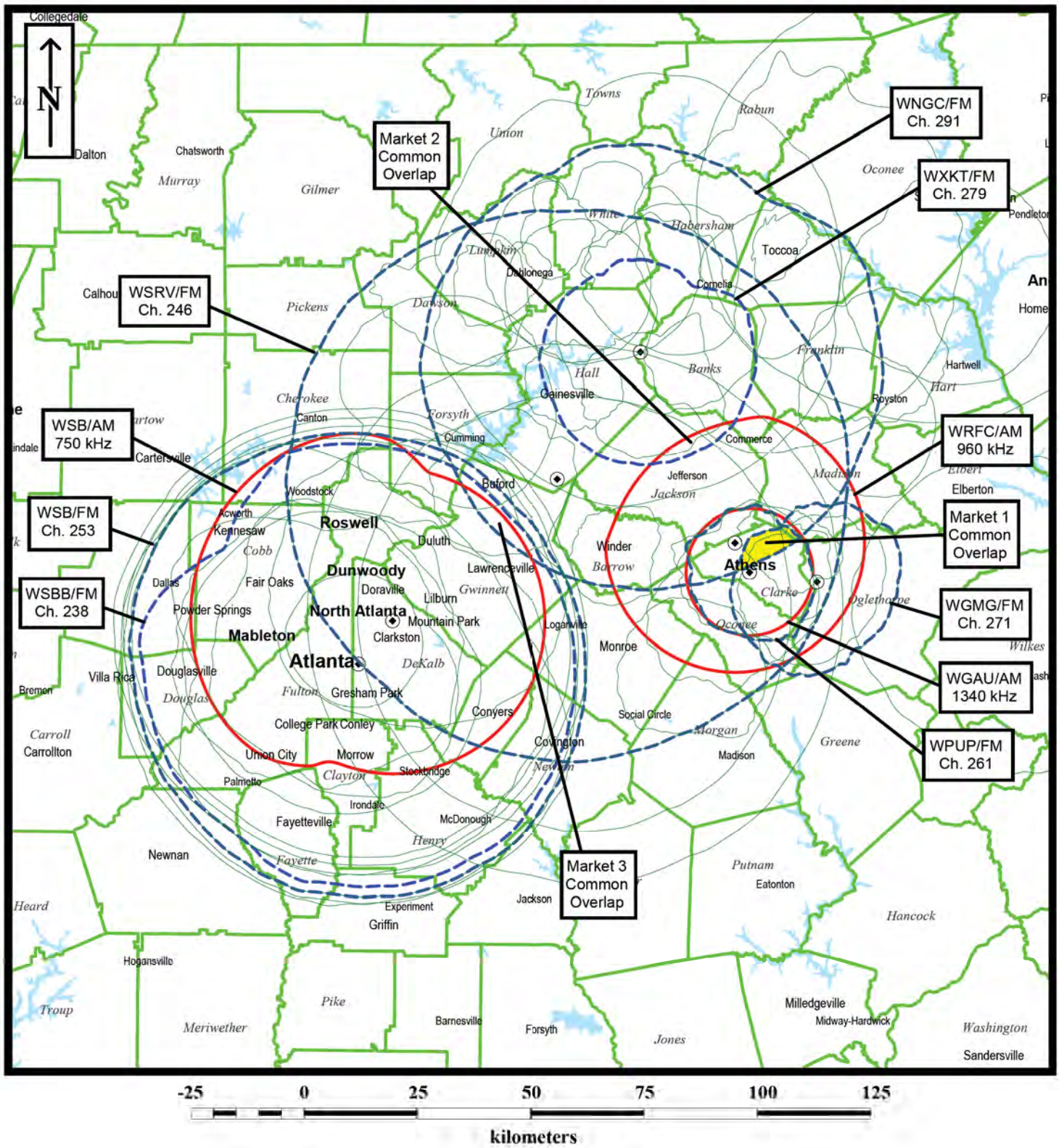

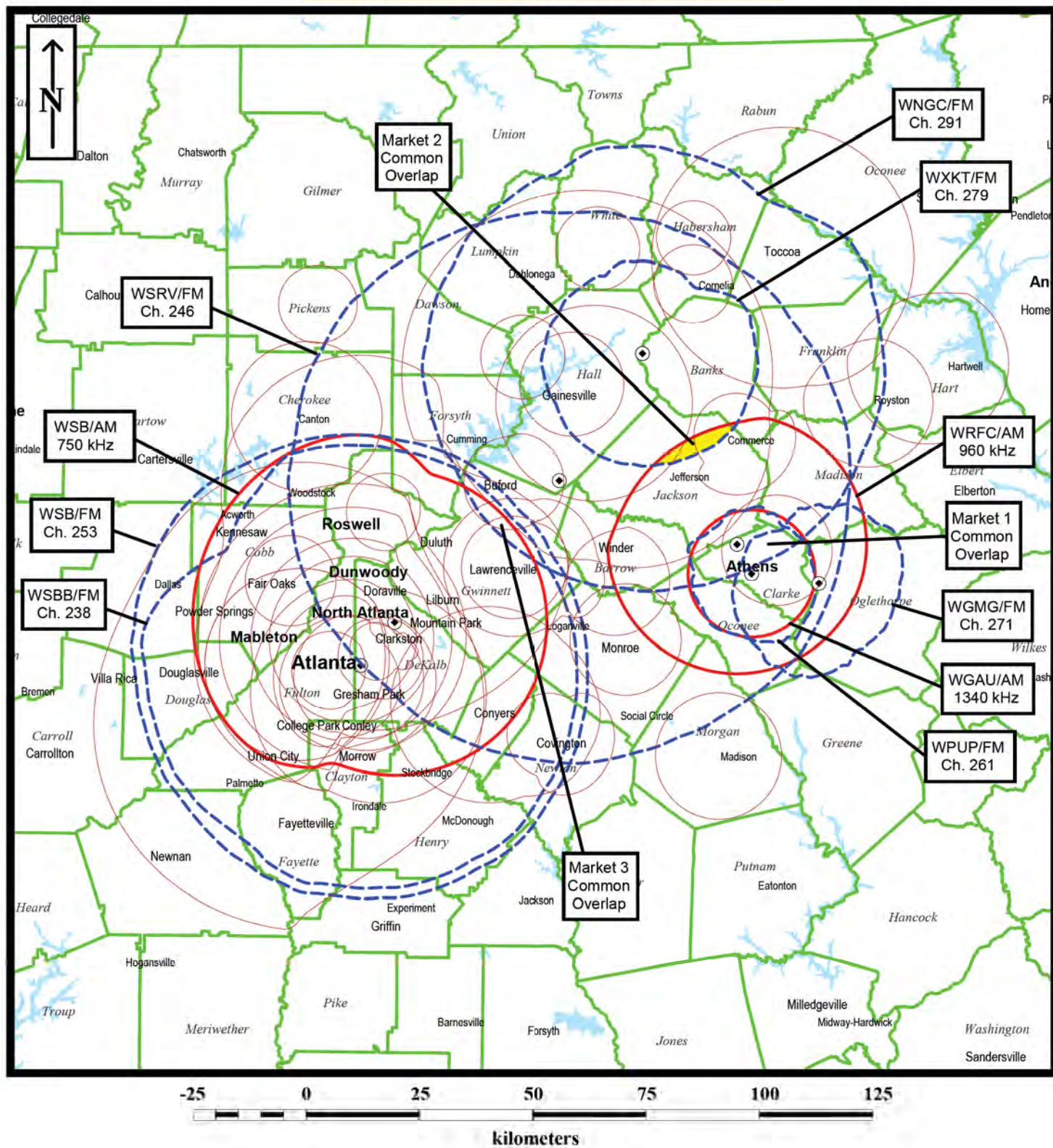

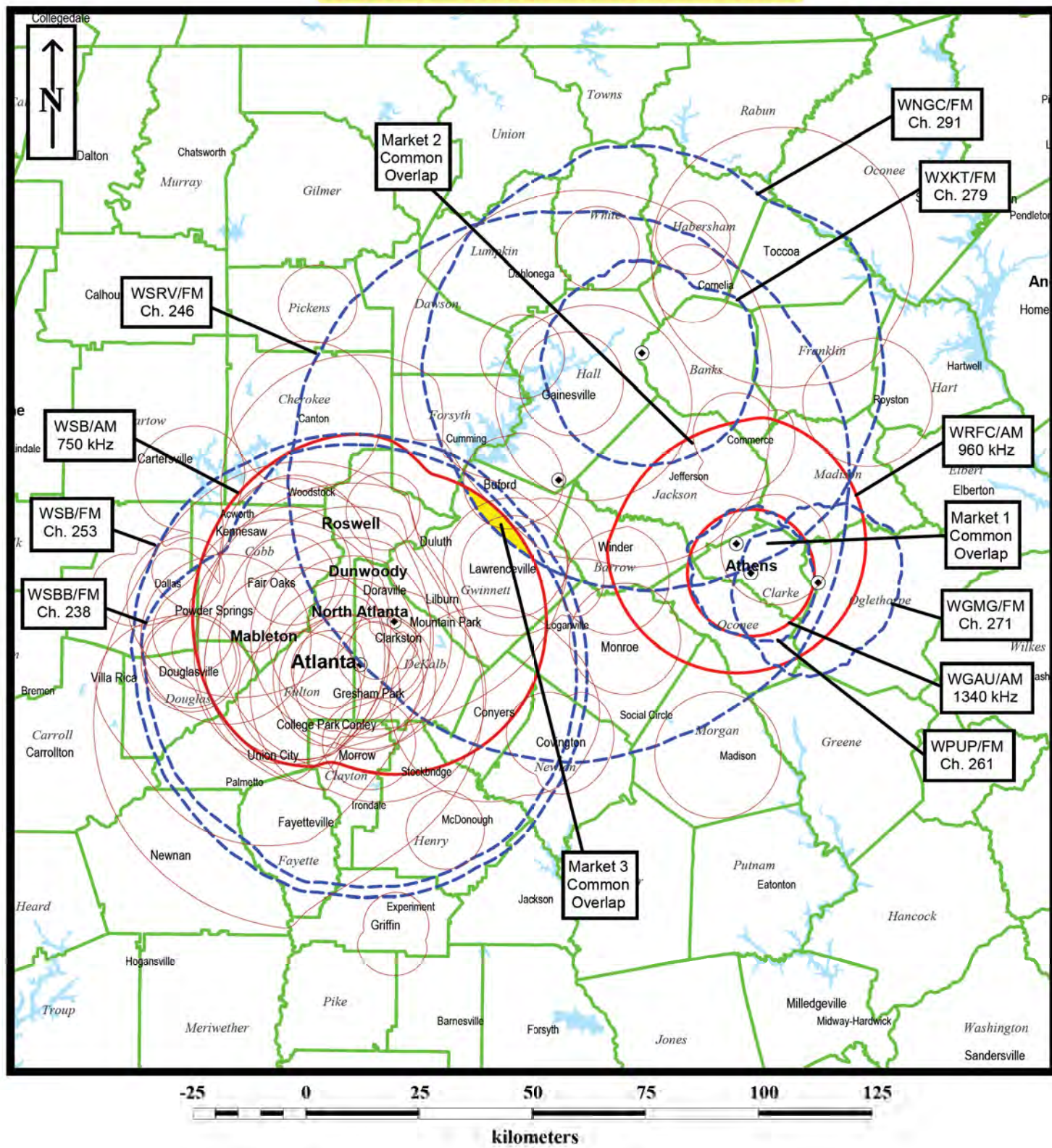

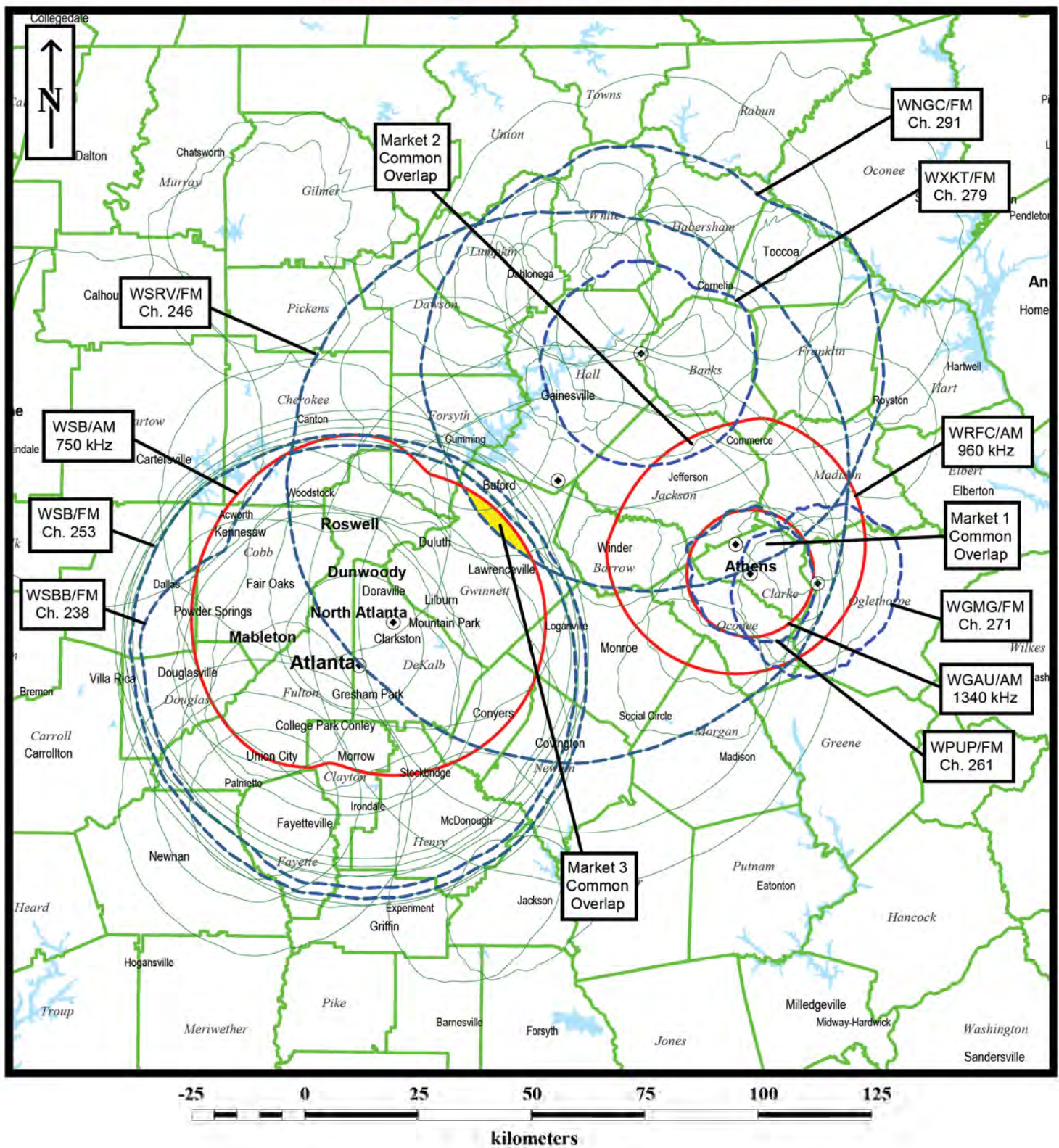
PREDICTED PRINCIPAL COMMUNITY CONTOURS OF SUBJECT STATIONS
