Effective 01/02/07, upcoming programming promos, with certain exceptions, count as commercial matter.

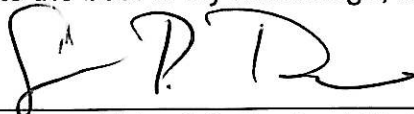
