Andrew,

Thank you for your willingness to record this for our mock crash event which is going to be held on Friday, May 19th. I have included the announcement below. Since this is in your wheelhouse, please feel free to make changes to the way it is presented. I wrote it how I thought it would sound. All of the students mentioned will be in the cars in the "accident" and the student audience will listen to this once they return from viewing the "crash scene." Please let me know if you have any questions.

A tragedy occurred in the town of Ashville early Sunday morning. At approximately 2:30 am, two cars full of teenagers collided at the intersection of Blockville Watts Flats road and County Route 474. The driver of one vehicle, 18-year-old Donovan Schnars, was driving at a high rate of speed and failed to stop for a stop sign. After a field sobriety test, it was determined that Schnars was under the influence of alcohol. He was taken into custody by the Chautauqua County Sherrif's Department. Schnars sustained few injuries. 18-year-old Josephine Bailey, a passenger in Schnars's vehicle, was flown to Hamot and is listed in critical condition with life-threatening injuries. Mackenzie Greene of Panama, also a passenger in Schnar's vehicle, escaped the vehicle with few injuries and managed to flag down help. The other vehicle was driven by 17-year-old Peyton Range of Panama. She was taken to UPMC and is reported to be in stable condition. Her passengers, Lilly Odell, Hannah Schauman, and Evelyn Montagna, all 17 years of age and all of Panama, were also transported to UPMC by the Ashville and Panama fire departments. All girls are listed in stable condition. The lone fatality, Mandy Brink of Ashville, was a passenger in Schnar's vehicle and was not wearing a seatbelt. She was pronounced dead at the scene by Chautauqua County Coroner Ken Haley. All students involved were high school seniors at Panama Central School. The accident remains under investigation.

A two car crash blamed on drunk driving has killed one Maple Grove High School teenager and seriously injured two others. 18 Year old Jake Wozniak died last night when the car he was riding in struck another vehicle at Ellery Center. According to the Chautauqua County Sheriff's Office. The vehicle driven by 18 year old Connor Reagle was traveling north when it went through a stop sign and struck a north bound vehicle driven by 18 year old Elizabeth Quadt. A Passenger in the Connor Reagle vehicle, Maddie Wadsworth was taken by ambulance to UPMC Chautauqua Hospital in Jamestown where she is listed in serious condition. Elizabeth Quadt was extricated by the Fire Department) using the jaws of life and Flown by Stat Medivac to Hamot Medical Center in Erie, PA where she is listed in critical condition in the trauma intensive care unit. Jake Wozniak was pronounced dead at the scene by the Chautauqua County Coroner. After investigation Connor Reagle was charged with speed not reasonable and prudent, Failure to stop at a stop sign, Driving While Intoxicated, and Vehicular Manslaughter. After Arraignment in the Town of Ellery Court before Justice John Ferrara he was remanded to the Chautauqua County Jail in lieu of \$1,000,000 bail. The family of Jake Wozniak will receive friends from 2:00 to 4:00 and 7:00 to 9:00 on Monday at the Lind Home in Jamestown.

Tragedy Overnight in the Town of Gerry. A two car crash blamed on drunk driving has killed one Cassadaga Valley High School teenager and seriously injured two others. 18 Year old Kristen Wise died last night when the car she was riding in struck another vehicle at the intersection of Route 60 and Moon Station Road. According to the Chautauqua County Sheriff's Office. The vehicle driven by 16 year old Isabella Dutton had recently left an after Prom underage party and was traveling Northbound on Moon Station Road when it went through a stop sign and struck a Southbound vehicle on Route 60 driven by 17 year old Eliza Anderson who was heading home to watch a movie with friends. Ariana Main, a passenger in the Eliza Anderson vehicle, was taken by Sinclairville Volunteer Fire Department Ambulance to UPMC Chautauqua Hospital in Jamestown where she is listed in serious condition. Eliza Anderson was extricated by the Sinclairville Volunteer Fire Department using the jaws of life and Flown by Stat MedEvac to Hamot Medical Center in Erie, PA where she is listed in critical condition in the trauma intensive care unit. Kristen Wise was pronounced dead at the scene by the Chautauqua County Coroner. After investigation Isabella Dutton was charged with Unlicensed Operation of a Motor Vehicle, Speed Not Reasonable and Prudent, Failure to Stop at a Stop Sign, Driving While Intoxicated, Vehicular Manslaughter and Assault 1st Degree. At Arraignment in the Town of Gerry Court, Justice Kevin Sirwatka, remanded Isabella Dutton to the Chautauqua County Jail in lieu of \$250,000 cash, \$500,000 property and \$1,000,000 unsecured bail. The family of Kristen Wise will receive friends from 2:00 to 4:00 and 7:00 to 9:00 on Monday at the Jordan Funeral Home.

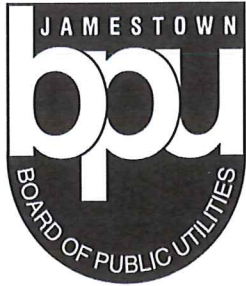

A two car crash blamed on drunk driving has killed one Frewsburg High School teenager and seriously injured two others. 18 Year old Madigan Collver died last night when the car she was riding in was struck by another vehicle, on Route 62 near 5 W Main St in Frewsburg. According to the Chautauqua County Sheriff's Office. The vehicle driven by 18 year old Jacob Sears was traveling North when the vehicle exited its lane into oncoming traffic and struck a south bound vehicle driven by 18 year old Teresa Mole. A Passenger in the Jacob Sears vehicle Jacey Cappa was taken by Frewsburg Fire Department Ambulance to UPMC Chautauqua Hospital in Jamestown where she is listed in serious condition. Teresa Mole was extricated by the Frewsburg Fire Department using the jaws of life and Flown by STAT MedEvac to Hamot Medical Center in Erie, PA where she is listed in critical condition in the trauma intensive care unit. Madigan Collver was pronounced dead at the scene by the Chautauqua County Coroner. After investigation Jacob Sears was charged speed not reasonable and prudent, Failure to keep right, Driving While Intoxicated, and Vehicular Manslaughter. After Arraignment in the Town of Carroll Court before Judge Gray. Jacob Sears was remanded to the Chautauqua County Jail in lieu of \$50,000 bail. The family of Madigan Collver will receive friends from 2:00 to 4:00 and 7:00 to 9:00 on Monday at the Frewsburg Funeral Home.
