



Children who have packed their few personal belongings, not knowing where they are going next...only to do the same thing in a few months. In 2022, 35 CASA volunteers advocated for the needs of 47 abused and neglected children and there are still more children that need our help.

All proceeds from A Voice Fore A Child Beer & Wine Tasting Charity Golf Tournament will help offset the costs associated with recruitment, training and support of our volunteers. 



Frequently Asked Questions

Is there a fee for the vendors?

 No, this event is free to the vendors but the tastings will be supplied by the vendor. Vendors are encouraged to do creative marketing at their booth which includes displaying marketing materials and give-aways.

Do you need a copy of our brewing license?

 Yes, breweries and wineries will need to send a copy to kfiorellacasa@gmail.com prior to the event.

When should we arrive?

Vendor set up is from 10:00 a.m. - 11:45 a.m. Please be set up no later than 11:45 a.m. The tournament and beer/wine/coffee tastings is from 12- 5:30 p.m. Assistance by golf cart will be provided to get product to your assigned tee box.

Where is Chautauqua Golf Club?

 Chautauqua Golf Club is located at 4731 W. Lake Road, Chautauqua, NY 14722

Will vendors be provided a table?

Yes, an 8' long table and 2 chairs will be provided along with a table covering.
We will also provide you with ice for your booth. We recommend bringing an
easy up sun shade as those will not be provided. Electric will not be available on
the course. Coffee roasters who need accommodations to provide hot coffee will
be placed closest to the clubhouse.

Does CASA supply the tasting glasses?

 Yes, we will supply the tasting glasses. They are 5 ounces however tastings should be around 3 ounces. Each golfer can get one 3-ounce tasting per vendor.

How will we know which golfers can taste?

Golfers who are under 21 will have a neon orange wristband.

Is insurance covered by the event sponsor?

 Yes, we obtain a commercial general liability insurance rider for the event. Only beer, wine, cider and coffee can be served. No hard liquor.

Can we bring product to sell?

Yes, feel free to bring sealed product to sell which will be held until the end of the
tournament and can be consumed off-site. Once purchased, put the buyer's
name on it. An event volunteer will collect these items and bring them to the
registration table for pick up. Swag and merchandise can be sold or given away.

Will there be advertising?

Yes, advertising avenues include Facebook, Instagram, Twitter, posters, radio ads, email blasts, press releases, direct mail, etc. This tournament will be highly advertised and much anticipated. We expect 36 teams for a total of 144 golfers/tasters. Vendors will be featured on the event social media pages as well as in email blasts and press releases. 
