

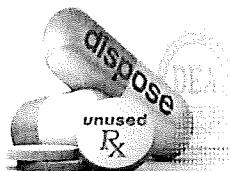
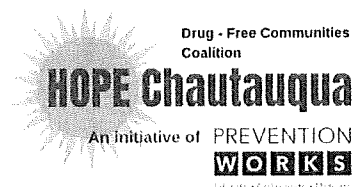

## Safe Use

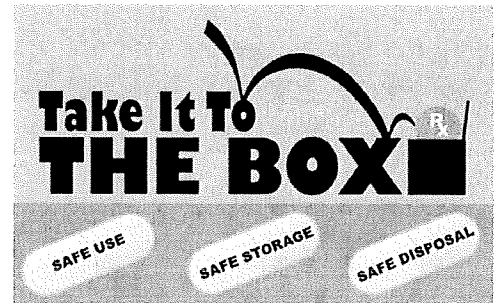
- Read and follow all directions on medications
