Pecos County is one of the sites considered for a project to test the feasibility of drilling holes 16-thousand feet deep to store canisters of nuclear waste. Medical Center Hospital cuts the ribbon on a new high tech pediatric care center. The 2.9-million dollar Samantha Canady Center for Pediatric Care was built after a local family lost a daughter who contracted a sudden illness and was unable to be airlifted to a specialized hospital in time to save her life. The new facility has telemedicine capability and more advanced care than was available before in the Permian Basin. (9:00)

#### Issue: economic development

The Midland City Council marks the beginning of demolition of the old Midland Center to make way for a new 42 million dollar convention center. Midland Mayor Jerry Morales says the project will be one of several major construction projects in the downtown area. VisitMidland president Brad Barnett says they lost out on about 300 meetings because the Midland Center was too small to handle them. He estimated at about 70% of those meetings could be accommodated by the new center. (10:00)

#### Issue: racial profiling

The Midland Police Department's annual racial profiling report is announced, showing there were no traffic stop arrests or citations issued on the basis of race. Midland City Council member John Love says the report shows the police department followed the letter of the law, but many minority motorists say they are not being treated with respect when they are stopped in traffic. #### Issue: Education

UTPB holds a groundbreaking for a new 52-million dollar academic building for its school of engineering. There is a growing demand for engineers as the oil industry becomes more active following a recent downturn. The three story academic building will house facilities for instruction in mechanical, petroleum, aerospace and later chemical engineering. 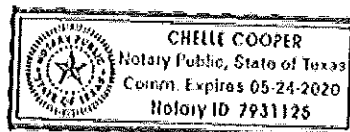

#### Issue: Education

Odessa College wins a "Rising Star" Award along with \$100,000 from the Aspen Institute, recognizing them as being within the top 5 community colleges in the nation. Institute officials honor Odessa College for dramatically improving its graduation rate and producing graduates that make twice the wages of other workers in the region.

Spokesperson Cheri Dalton says the college has put in place several initiatives to improve student performance. (9:00)

#### Issue: Environmental protection

Two Midland residents express their opposition to Waste Control Specialists' application to store high level radioactive waste at their facility in Andrews County that already store low level waste. Bridget Houston Hyde and David Rosen talk about their concerns that dangerous cargo will travel on rail and highways through Midland County on its way to Andrews County. They ask the Midland County Commissioners to pass a resolution banning the transport of the waste through the county. They also ask the commissioners to seek intervener status in the licensing case. Midland County Judge Mike Bradford says the county has no jurisdiction over the railroad or federal projects. He says the county commissioners will study the matter to see if there is any action that would be appropriate for them to pursue. (11:00)

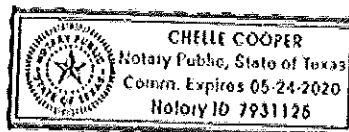

#### Issue: Economic Development

The Midland Development Corporation board voted more than three million dollars toward highway projects in the area. Normally, the corporation gives financial incentives for new businesses to move to the area, but the board felt that improving highway infrastructure is another way at attracting new business. Texas Department of Transportation district engineer John Speed talked about highway funding participation by both the Midland and Odessa Development Corporations. Midland Development Corporation Brent Hilliard says they hope it will speed up the process to build the needed highway infrastructure. (12:00)

#### Issue: Jury duty improvements

Midland County District Clerk Ross Bush says a new software program has dramatically improved the response of potential jurors to show up for jury duty. Instead of just relying on post card notices, jurors register on a website that then notifies them by e-mail or texts when they need to report for jury selection. Bush says the new system has nearly doubled the response rate. (5:00)

#### Issue: Medical care

Medical Center Hospital held a ribbon cutting for a new women's health clinic, consolidating several obstetrics and gynecology practices. Medical Center Hospital CEO Bill Webster says a needs assessment survey showed that 40 percent of women in Ector County had no previous access to pre-natal care. Dr. Avelino Garcia said the new clinic put several existing medical services under one roof. (5:30)

HealthSouth Rehabilitation Hospital held a groundbreaking for an expansion of 24 patient rooms to their present facility in Midland. HealthSouth regional president Frank Brown said the Midland hospital was operating at capacity and needed more space. Midland Memorial Hospital CEO Russell Meyers said they had entered into a partnership with HealthSouth to coordinate rehabilitation care for patients recovering from stroke, heart attacks, and serious physical disabilities. #### Issue: Traffic safety





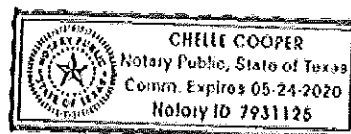

Issue: Domestic violence

Odessa State Representative Brooks Landgraf discusses his proposed bill that would create a list of protective orders issued by Texas courts. The list would be a record of persons who have been convicted of offenses involved with domestic or family violence. The bill was inspired by a person Landgraf met during a door to door campaign visit. A retired police officer lost his daughter when her abusive boyfriend shot her to death. The boyfriend had a record of domestic violence, but the daughter had no way of knowing that. (18:00)

Issue: Parks development

Former Midland City Councilman Buddy Sipes speaks at a public hearing in opposition to a proposal to extend a sales tax that would fund parks improvements. The tax is set to expire when the construction debt on the Scharbauer Sports Complex is retired. City leaders want to continue to collect the tax to finance civic improvements. Current City Councilman J. Ross Lacy defends the extension and repurpose of the tax, adding that he would like to see an emphasis on city street maintenance. (9:00)

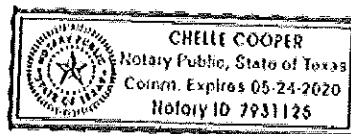
