## Conaway to Lead Russia Investigation

A follow up to an alert that I brought you on Friday: The Amber Alert for missing Grandfalls 15 year-old Stormie Clemmer has been discontinued although teen \*is still missing\*.

According to dispatch the reason why the Amber Alert has been discontinued is because there is a time limit on Amber Alerts.

No other details have been released regarding this case.

According to the Brewster County Sheriff's Office, Clemmer is described as a white female who is 5'7 and weighs around 100 pounds.

She has brown hair, green eyes and was last seen wearing a black shirt, blue jean shorts and hiking shoes.

Authorities are also looking for Andrew Brian Akers, 20, in connection with Clemmer's abduction.

Akers is described as a white male who is 5'11 and weighs around 210 pounds. He has brown hair and brown eyes.

Akers is believed to be driving a black 2000 Ford Ranger Extended Cab with fender flares, 5-spoke chrome rims and a temporary Ohio license plate.

**MIDLAND** -- This past month all of West Texas has been slammed with storms. We know of two apartment complexes in Midland that had roofs cave in from the wind and rain.

If this happens to you, do you know just how much of your insurance covers the damage?

Not all of us enjoy paying bills, but Roy Nelson with State Farm tells us that paying just a small amount of renters insurance (typically under \$20) can save lots of heartache and money when disaster strikes.

"We've had a lot of people with claims and especially with the wind," Nelson said.

Nelson also stated that "If you have insurance, they are able to react very quickly, in fact if someone calls him with a claim and their place is unlivable he can get them into an apartment or a hotel, adding that renters insurance is there to protect your personal property, like electronics and furniture.

And why should you have it? If your home is totaled, your provider can immediately get you a place to stay for the time being, according to Nelson.

Most renters insurance packages cover fire, theft, vandalism, and storm damage. However it's important to note that renters insurance doesn't typically cover street flooding.

Nelson adds that as for the apartment complex you're staying in, they're also focused on liability insurance, meaning your ability to cover any damages you may inflict on another resident.

**MIDLAND** -- Good news at Midland College: the nursing program reports a 100 percent pass rate on its nurse license exam for its December graduates.

It's been roughly 20 years since all students passed, according to Midland College spokesperson Rebecca Bell.

Aside from a growing need for more nurses in Midland, Bell says it's all thanks to the 17 students' success that brought the program above state average, which, according to the Texas Board of Nursing, is just over an 80 percent success rate.

From day one, students are thrown into almost real-life medical situations where their life-saving skills are put to the test.

An average of 15 to 30 students spend two years training at the F. Marie Hall Simlife Center on Midland College's campus.

"Recently we've changed our curriculum in our Associate Nurse Degree Program. I think that's helped students pass; we've had our standards much more rigorous," she added.

Bell believes a tough set of prerequisite courses and dedicated students is what led to their success.

The students' next step is to find employment. Bell adds that many of them already have jobs at Midland Memorial Hospital.

## ENERGY REPORT 6/28/17

U.S. exports of oil and natural gas are surging.

President Donald Trump says the U.S. is on the brink of becoming a net exporter of oil, gas and other resources.

The White House is launching its "energy week" with a series of events focused on jobs and boosting U.S. global influence. The events follow similar policy-themed weeks on infrastructure and jobs.

Energy Secretary Rick Perry says the Trump administration is confident officials can "pave the path toward U.S. energy dominance" by exporting oil, gas and coal to markets around the world. He also says the U.S. will promote nuclear energy and even renewables such as wind and solar power.

In recent weeks, a new energy buzzword has taken flight from Washington, D.C., making stops in Alaska, North Dakota, Texas, Utah and more: "American energy dominance." Taking a cue from a 2016 speech by then-candidate Donald Trump, top federal officials including Energy Secretary Rick Perry and Interior Secretary Ryan Zinke have begun to trumpet the notion of energy "dominance."

Although no Cabinet official has offered a precise definition, it's a recurring theme in a set of administration events organized around energy policy, including a planned speech by Trump emphasizing exports of coal, natural gas and oil.

So what does this new energy catchphrase mean, and how should we think about it?

Two words- Domestic boom

For decades, U.S. politicians have trumpeted the notion of energy "independence," focused primarily on the need to eliminate oil imports from OPEC nations and other countries that may not share U.S. interests. But as other energy policy experts have observed, "independence" was never a smart energy goal. Isolating the U.S. from global energy markets is neither in the interest of domestic consumers nor newly resurgent oil and gas producers in the U.S.

For consumers, access to international markets ensures energy supplies at more stable prices. For instance, consider what would happen if a hurricane shut down production and refining along the Gulf Coast, the hub of the U.S. oil and gas industry. Without access to global markets, prices for motor fuels, home heating fuels and other products would be far more volatile.

As for producers, they have argued strongly for opening up, rather than sealing off, access to international energy markets. They've lobbied to lift restrictions on crude oil exports and encouraged exports of natural gas via new pipelines and liquefied natural gas (LNG) terminal.

#### Issue: Eliminating hunger

#### Issue: traffic safety



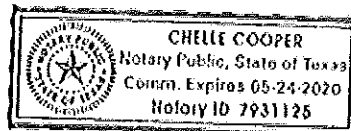

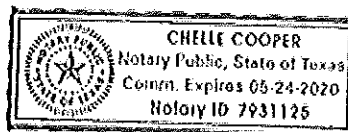

The loads would pass through Midland County on the way to a storage facility in Andrews County if Waste Control Specialists is successful in getting a license from the Nuclear Regulatory Commission.
