Marfa Public Radio Licensee of KXWT(FM) (Facility I.D. # 50038) Response to EEO Audit Letter of June 26, 2013:

Noncommercial educational radio broadcast station KXWT(FM) (Facility 1.D. # 50038), which serves the community of Odessa, Texas, is licensed to Marfa Public Radio ("MPR"). KXWT is included within the Marfa Public Radio Station Employment Unit ("SEU" or "Unit"), which consists of the following three full-service NCE FM radio stations licensed to MPR:

KRTS(FM) (Facility I.D. # 164217) Marfa, Texas KXWT(FM) (Facility I.D. # 50038) Odessa, Texas KRTP(FM) (Facility I.D. #173345) Alpine, Texas (license to cover applied for)

and one station that is managed by MPR pursuant to a Local Management Agreement: KDKY(FM) (Facility I.D. # 171963) Marathon. Texas

Response to Question 2: KRTS, KXWT, KRTP, and the LMA station in Marathon, KDKY, are operated as a single SEU, with the same group of employees, by Marfa Public Radio. The MPR Unit has fewer than five (5) full-time employees, defined as employees regularly assigned to work 30 hours per week or more, and has continuously had fewer than five (5) full-time employees throughout the present license term of these stations. At the present time, the MPR SEU has the following full-time employees:

Tom Michael, General Manager, 40 hours per week Rachel Osier Lindley, News Director, 40 hrs per week Anne Adkins, Business Manager & Volunteer Coordinator, 40 hrs per week Michael Camacho, Operations Engineer & Traffic Manager, 40 hrs per week

Response to Question 3(e): No. There have been no pending or resolved complaints against NCE radio Station KXWT or against any station within the MPR SEU, during the Station's current license term before any body having competent jurisdiction under federal, state, territorial, or local law alleging unlawful discrimination in the employment practices of the Unit on the basis of race, color, religion, national origin, or sex.

Response to Question 4: KXWT is not subject to a Time Brokerage Agreement or Local Management Agreement; rather, it is programmed and operated by employees of licensee in the MPR SEU. One station in the MPR SEU – KDKY, Marathon, Texas – is licensed to the Marathon Volunteer Fire Department and operated by MPR pursuant to a Local Management Agreement. The Marathon Volunteer Fire Department has no full-time employees.
