POLITICAL DISCLOSURE 2018

GENERAL POLICIES

Rate quotations for the purpose of the purchasing spot air time by or for legally qualified candidates for federal, state, county or city offices must come from either the general sales manager or someone appointed by them to do so. All rates for advocacy campaigns or special interest groups must come from one of the above mentioned.

Qualified political candidates expressing an interest in the purchase of commercial time on KTTW should understand that most rates for advertising time are arrived at on a negotiated basis. Pursuant to federal law, during the 45 days prior to the primary election (4/21/18 - 6/5/18) and the 60 days prior to the general election (9/7/18 - 11/6/18), legally qualified candidates sponsoring announcements containing the candidates voice and/or picture will be afforded the lowest unit rate based on the amount and class of time purchased in the time period selected; other than during the pre-primary and pre-election periods, candidates are entitled to purchase time at rates comparable to those charged regular commercial advertisers.

LOWEST PRICED PRE-EMPTIBLE RATES

Candidates will be provided with our two grid rate card and disclaimer on each grid. Candidates will be provided with the rates for the lowest priced Highly Pre-emptible without notice advertising time thus far scheduled or expected to be scheduled for any advertiser in a particular program, time period or rotation in which the candidate is interested, during the week or weeks for which availabilities have been quoted. The possibility of pre-emption is outlined on the grid rate disclosure.

Candidates should be aware that the ultimate charge for purchasing immediately pre-emptible time will in no way exceed the lowest unit rate charge to any other advertiser for the same immediately pre-emptible air time of the same length and for the same program, day part or rotation which actually runs during the same "Rate Period" as the political air time. Any price differential due a candidate will be refunded, or applied as a credit against subsequent purchases, at the option of the candidate.

MAKE GOOD POLICY

KTTW does not guarantee to any advertiser- Commercial or Political- that make goods can be provided in the same time period or rotation originally ordered. If that is not possible due to inventory restraints, the station shall offer make-goods only in day parts with available time. If these are not acceptable to an advertiser, the station shall provide credits or refunds for the pre-empted commercials. Make good commercials are offered based on the class of time purchased.

POSTING

Upon request KTTW will negotiate rating points at the time order placement and will guarantee delivery of at least 90% of total rating points negotiated for the order. The posting will be based on the book for the quarter in which the spots ran. All ratings must be negotiated in advance of the order placement. All posts must be completed within 60 days of invoicing.

PROGRAM LENGTH ADVERTISEMENTS

This will outline the traffic and sales procedures for the purchase of program length (5 minutes or longer) political announcements on KTTW for the 45 day window before the primary election which is April 19th, 2014 through June 3th, 2014 and the general election which is September 5th, 2014 through November 4th, 2014. KTTW will accept political advertising the day of the election up till 7PM.

Standard half hour avails will be subject to availability and will be offered the lowest unit rate available pre-emptible rate. Time request in length other than our normal half hour avails will be as follows.

Any other time periods would have to be on a negotiated rate.

MEDIA POLICY

Commercial media for all clients including political must be in our hands and viewed before telecast. The tape must meet the requirements of the FCC as to proper sponsorship identification. All letters in the sponsorship ID must consist of 4% of the vertical picture height (20 scan lines) and must be visible for at least 4 seconds. The words "Paid For", "Sponsored" and "Furnished" may not be abbreviated. Political ads of the five minute duration or less require proper sponsorship identification during the broadcast.

Ads in excess of five minutes must have sponsorship identification at both the beginning and conclusion of the broadcast.

The weekend prior to the election, late changes of media will be handled around the clock. On Saturday and Sunday before the election, political candidates can call Ed Hoffman at 605-351-1572 or 605-368-5442 to change media. He can coordinate deliver of the tape and written traffic changes, make sure the ad meets the guidelines listed above and get it on the air.

KTTW Fox 7 SALES PRACTICES

The following is an outline of the basic sale practices and policies followed by KTTW FOX 17.

1. All commercial advertising is subject to a (2) grid system that outlines our rates and the risk of each being pre-empted. See attached disclaimer.
2. All orders must be in to our traffic department by 2pm if to start the following day.
3. All traffic and commercials must be in house by 3pm if they are to start the next day.
