Ector County Attorney Dusty Gallivan has led an effort to speed up the process for getting search warrants to draw blood samples from DWI suspects. He and law enforcement officials have developed computer programs to allow officers to draw up "probable cause" applications for search warrants. Those applications can be e-mailed to district judges for their consideration. If they approve the search warrant request, they can e-mail that back to the officer. A process that used to take three or four hours has been reduced to about 45 minutes.

This allows blood samples to be taken while blood-alcohol level evidence is still valid.
