Hi Nick,

Thank you for the information. I'm not entirely sure I understand all of it, so I may have filled out all of these forms incorrectly. If so, just let me know and maybe we can discuss further by email or by telephone.

Another candidate who told me he was doing radio ads with Hall Communications, said he was having one 30 sec ad aired an hour for a set number of hours and a set number of days. The info you sent about rates didn't really seem like they were meant for hourly advertisements (i.e. the language about "dayparts") but since he told me that's what he paid for, I made an assumption that I could do the same.

If it's unclear in the documents attached, I'm looking to do the following, if approved:

On WONN, one 30-sec ad an hour from 6-10 AM and 3-7 PM, Monday through Friday, and from 10 AM - 3 PM on Saturdays, just for the period of August 12-23 (M-F (8 hrs a day \times 8 days \times 5 = \$320) + Sat (5 hrs a day \times 2 days \times 5 = \$50) = \$370).

On WWRZ (98.3), one 30-sec ad an hour from 7-9 PM, Monday through Sunday, just for the period of August 12-22 (Mon-Sun 2 hrs a day x 11 days x \$12 = \$264).

On WPCV (97.5), one 30-sec ad an hour from 7-9 PM, Monday through Sunday, just for the period of August 13-22 (Mon-Sun 2 hrs a day x 10 days x \$30 = \$600).

I was also told I could come in and record my ad, so I was hoping to find out some information and parameters on what needs to be in the ad (i.e. does the disclaimer need to be included within the 30 sec time period?).

Please let me know if I need to send more information, or if I need to redo any of these forms, or anything else that may be necessary, including how to pay. Thank you!
