WA Health Centers Push Congress for Stable Funding

Yakima, WA Advocates for Community Health Centers are in Washington, D.C., to pushing for stable, long-term funding. Their facilities provide affordable care to one in 12 Americans across the country, many in under-served areas. Comments from Anita Monoian (muh-NOY-en), president and CEO, Yakima Neighborhood Health Services; and James Luisi (loo-EE-see), board chairman, National Association of Community Health Centers.

Intro: Thousands of medical professionals and health-care advocates from across the country are in Washington, D-C, this week, urging Congress to ensure stable funding for Community Health Centers. These clinics provide affordable care to about one in twelve Americans, work in under-served areas and often are the only places available for preventive and primary care. Anita Monoian heads Yakima Neighborhood Health Services, which serves more than 23-thousand patients a year in rural central Washington. She says many people would go to emergency rooms or without care at all if their clinics didn't exist and without reliable funding, it's hard to operate.
