

I am President of Radio Georgia, Inc., licensee of WTGA-FM, Thomaston, Georgia (FCC Facility ID No. 54590).


WTGA-FM has three full-time (30 hours or more per week) employees. Their positions and the number of hours they are assigned to work weekly are set forth below:
