K21DO-D Children's Programming Comprehensive Amendment, Fourth Quarter 2017 through Third Quarter 2019

K21DO-D ("K21DO" or the "station") was acquired by HC2 Station Group, Inc. ("HC2") on December 18, 2017. HC2 hereby amends the K21DO children's programming reports for the Fourth Quarter 2017 through Third Quarter 2019.

Fourth Quarter of 2017 - COMPLIANT

K21DO timely filed its fourth quarter 2017 children's programming report on January 2, 2018, as amended on May 4, 2018 (FCC File Number: 0000037080). The report correctly noted that the station broadcast an average of 7.3 hours per week of core programming on the primary channel, which was more than the required average of 3.0 hours.

However, the report inadvertently indicates that average number of hours per week of free over-the-air digital video programming broadcast by the station on other than its main program stream was 336 hours. This is incorrect, as only 168 hours aired during this quarter because there was only one multicast channel on the station. The report correctly indicates that the average number of hours per week of core programming broadcast by the station on other than its main program stream was 2.65 hours, which is 0.35 hours short of the required 3.0 hours. However, this minor deficiency is more than made up by the 4.3 hours per week of extra core programming that aired on the station's primary channel during this quarter.

First Quarter of 2018 - COMPLIANT

K21DO timely filed its first quarter 2018 children's programming report on April 3, 2018, as amended on April 30, 2018 (FCC File Number: 0000049675). The report indicates that the station broadcast an average of 7.0 hours per week of core programming on the primary channel (which appears to have been rounded up from the actual calculation of 6.8 hours). In either case, the station clearly aired more than the required average of 3.0 hours for the quarter.

However, the report inadvertently indicates that average number of hours per week of free over-the-air digital video programming broadcast by the station on other than its main program stream was 336 hours. This is incorrect, as only 168 hours aired during this quarter because there was only one multicast channel on the station.² The report indicates that the average number of hours per week of core programming broadcast by the station on other than its main program stream was 4.5 hours (which appears to have been rounded down from the actual calculation of 4.61 hours). In either case, the station clearly aired more than the required average of 3.0 hours per week on the multicast channel during this quarter.

Second Quarter of 2018 - COMPLIANT

K21DO timely filed its second quarter 2018 children's programming report on July 9, 2018 (FCC File Number: 0000056848). The report indicates that the station broadcast an average of 7.5 hours per week of core programming on the primary channel (which appears to have been rounded up from the actual calculation of 7.46 hours). In either case, the station clearly aired more than the required average of 3.0 hours for the quarter.

However, the report inadvertently indicates that the average number of hours per week of free over-the-air digital video programming broadcast by the station on other than its main program stream was 336 hours. This is incorrect, as only 168 hours aired during this quarter because there was only one multicast channel on the station.³ The report correctly indicates that the average number of hours per week of core programming broadcast by the station on other than its main program stream was 5.5 hours, which was more than the required average of 3.0 hours per week on the multicast channel during this quarter.

Third Quarter 2018 - COMPLIANT

K21DO timely filed its third quarter 2018 children's programming report on October 5, 2018 (FCC File Number: 0000060841). The report correctly indicates that the station broadcast an average of 9.6 hours per week of core programming on the primary channel. Thus, the station aired far more than the required average of 3.0 hours for the quarter.

The report also correctly indicates that the average number of hours per week of free over-the-air digital video programming broadcast by the station on other than its main program stream was 168 hours. The report correctly indicates that the average number of hours per week of core programming broadcast by the station on other than its main program stream was 5.0 hours, which was more than the required average of 3.0 hours per week on the multicast channel during this quarter.

Fourth Quarter 2018 - COMPLIANT

K21DO timely filed its fourth quarter 2018 children's programming report on January 10, 2019 (FCC File Number: 0000066318). The report indicates that the station broadcast an average of 28 hours per week of core programming on the primary channel. However, after further review of the station's records, the station actually aired the following core programming on its primary channel during the quarter:⁴

1. Kids Time aired 90 times (not 247) during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 45 hours of core

programming.

- 2. Kids Time Praise aired 63 times (not 247) during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 31.5 hours of core programming.
- 3. Tiny Tots for Jesus aired 89 times (not 221) during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 44.5 hours of core programming.

Accordingly, the station aired an average of more than 9.3 hours of core programming per week on its primary channel, which is still far more than the required average of 3.0 hours for the quarter.

The report correctly indicates that the average number of hours per week of free over-the-air digital video programming broadcast by the station on other than its main program stream was 168 hours. The report indicates that the average number of hours per week of core programming broadcast by the station on other than its main program stream was 5.5 hours. However, it appears that the station actually aired the following qualified core programming on its .2 multicast channel:

- 1. Amiguitos de Jesus aired 90 times (not 52) during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 45.0 hours of core programming.
- 2. Estrelitas de Jesus aired 92 times (not 52) during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 46.0 hours of core programming.

Thus, the station aired an average of 7.0 hours of core programming on its one multicast channel during this quarter (not 5.5 hours as reported), which was more than the required average of 3.0 hours per week on the multicast channel during this quarter.

First Quarter 2019 - COMPLIANT

K21DO timely filed its first quarter 2019 children's programming report on April 1, 2019 (FCC File Number: 0000068994). The report indicates that the station broadcast an average of 7.5 hours per week of core programming on the primary channel. However, after further review of the station's records, the station inadvertently omitted from the quarterly report one additional qualified core program on its primary channel during the quarter:⁵

1. Tiny Tots for Jesus aired 52 times during the quarter at its regularly scheduled time and each program was 30 minutes in length, for a total of 26 hours of core programming.

Accordingly, the station aired an average of more than 9.4 hours of core programming per week on its primary channel (not 7.5 hours as previously reported), which is still far more than the required average of 3.0 hours for the quarter.

The report correctly indicates that the station had no multicast channels during this quarter, and thus no core programming aired on any multicast channel during this quarter.

Second Quarter 2019 - COMPLIANT

K21DO timely filed its second quarter 2019 children's programming report on July 8, 2019 (FCC File Number: 0000076381). The report indicates that the station broadcast an average of 3.5 hours per week of core programming on the primary channel, which is more than the required average of 3.0 hours for the quarter.

The report correctly indicates that the station had no multicast channels during this quarter, and thus no core programming aired on any multicast channel during this quarter.

Third Quarter 2019- COMPLIANT

For the third quarter of 2019 (through September 15, 2019, when the FCC's core processing guidelines changed to an annual reporting requirement), K21DO timely filed its children's programming report on October 7, 2019 (FCC File Number: 0000084493). The report indicates that the station broadcast an average of 3.5 hours per week of core programming on the primary channel, which is more than the required average of 3.0 hours for the quarter.

The report correctly indicates that the station had no multicast channels during this quarter, and thus no core programming aired on any multicast channel during this quarter.

Subsequent Reports - COMPLIANT

K21DO also has been compliant with the core programming requirements as reported in its 2019 annual report and continuing through to the recently filed 2023 annual report.
