Fox Television Stations, Inc., the licensee of WTTG, Washington, DC ("WTTG"), hereby responds to the Notice of Informal Complaint, as identified above, dated December 19, 2011 ("NOIC"), which was generated by a Disability Access Complaint filed by Howard Rosenblum. An acknowledgement of Mr. Rosenblum's complaint was emailed to him on December 20, 2011, and is attached hereto.

Mr. Rosenblum states in his Disability Access Complaint ("Complaint") that he is a DIRECTV subscriber and that the "broadcast of *Fringe* on 11/18 was not captioned at all. The Internet version is also not captioned."

WTTG reviewed the air-check recording of the broadcast *Fringe* on November 18, 2011, and the captioning was functioning properly. From time to time, cable and satellite providers have technical issues passing through the captions as broadcast. WTTG can only state that the captions on *Fringe* were functioning properly as broadcast. As to the captioning of the Internet version of *Fringe*, closed captioning is not currently required for programs made available on the Internet.
