Measure R	<ul style="list-style-type: none"> <li>Del Norte County supervisors Tuesday unanimously voted to include a proposed repeal of Measure R on the Nov. 8 ballot. But because of the way the initiative is written, even if it passes, the 1 percent sales tax won't be eliminated since the repeal addresses the resolution that placed Measure R on the 2020 ballot, according to County Counsel Joel Campbell-Blair. Measure R narrowly passed with 50.24 percent voting yes and 49.76 percent voting against it.
