Description: NJ Restaurants were closed down for months, due to Covid-19. One advocacy group, the NJ Restaurant and Hospitality Association, is here to help them recoup their losses. Rep. Mikie Sherill believes it is time to return to work. She and Larry discuss the re-opening of New Jersey and how it can be done safely. In the same episode, Larry talks to an assemblyman who left NJ each time he wanted to go to the gym. The next week, Phil Andrews spoke with Joe Piscopo, who owns a Retro Fitness in NJ, upon re-opening its doors. Then, Kimberly Kravitz hits the Jersey Shore upon restaurants reopening indoors at 25% capacity.

Then, she returned to the show after coming under fire for the backlog of registration at the DMV, long lines and disasters since re-opening.
