Topic: Gas Tax

Description: New Jersey implemented a \$.23 per gallon gas tax increase. The Executive Director of the New Jersey Gasoline Association Sal Risalvato sits with Host Larry Mendte to talk about the implications that this will have on small gasoline retailers as well as consumers. Although the increase comes with some sticker shock, Sal says that things could have been much worse. They could have been no tax relief or the tax could be much higher.

Assemblywoman Muoio is very concerned about cost going over budget now because of stopping and then re-starting a project and many projects will not be done in time.

Topic: Local Terrorism

Description: After a string of local terror attacks in New York City; Elizabeth, New Jersey; and Seaside, New Jersey Larry talks to the former Director of Homeland Security for New Jersey Ed Dickson. Ed currently is the President for MSA Investigations goes into detail about the dangers of “lone wolf” attacks. Ed talks about how ISIS and Al Qaeda are influencing American citizens and how we have to be more mindful of social media.

Description: Host Larry Mendte visits the home of Bill Cheswick whom has earned the nickname The “Godfather of the Firewall”. Bill has worked in cyber security for decades and is the co-author of *Firewalls & Internet Security*. Bill talks about denial of service attacks, which are when people take down or overwhelm popular sites like Netflix, Amazon, and Google. Bill also talks about how the lack of regulation can lead to more attacks. Poorly made devices that require internet access are being hacked and give intruders access to your data or computers. Finally Bill address data breaches in which hackers steal user data from yahoo and target.

Topics: Emergency Services

Description: New Jersey is one of the first three states to implement technology in which residents in all 21 counties can text 911 emergency responders. New Jersey Chief Technology Officer Dave Weinstein explains how the program works. The purpose of these system is for when citizens are in a situation in which they can’t call such as an intruder or a domestic situation. Responders can respond to text, and have a dialogue. Nevertheless, calling is still the preferred method of emergency communication.

Topic: Police Transparency – Body Cameras

Description: Correspondent Ellen Kolodziej sits down with the Sharon Hills Police Department Chief Rick Herron. They are the first department in Delaware County, PA to use body camera’s full time. And the chief praises how the cameras have helped with prosecution and citizen complaints. Larry continues the conversation with the Acting Police Chief of the Asbury Park Police in Monmouth County New Jersey. Chief Anthony Salerno is a firm believer of transparency and he thinks cameras are a tool that helps significantly with prosecution and citizen complaints.

Topic: Healthcare – Out of Network Medical Bills

Description: New Jersey State Assemblyman Joe Vitale joins host Larry Mendte to discuss legislation that would help prevent consumers from being billed for emergency services that fall outside of their health coverage. Senator Vitale gives the example of a patient going to their in-network hospital, but then a procedure or a test is administered by a specialist who is out of network. The patient then gets a large bill for whatever their insurance doesn’t cover. Senator Vitale’s bill would require the insurance provider and the healthcare provider to attend mediation to reach a settlement. Senator Vitale has bipartisan support and believes it is very close to becoming a reality in New Jersey.

Description: Jeff Gural sits down with host Larry Mendte just before New Jersey residents vote to allow casinos to be built in Northern New Jersey. Jeff is the owner & president of New Meadowlands Racing. Jeff argues that this bill was designed to save Atlantic City, horse racing, and senior citizens. The Northern Jersey Casinos offered 400-500 million dollars in taxes to the state, which is double what the state gets from all of Atlantic City. Jeff believes the measure will get voted down, however he will continue trying to get casinos built in Northern New Jersey. Jeff believes a casino in Northern New Jersey is inevitable.
